8. Test Results

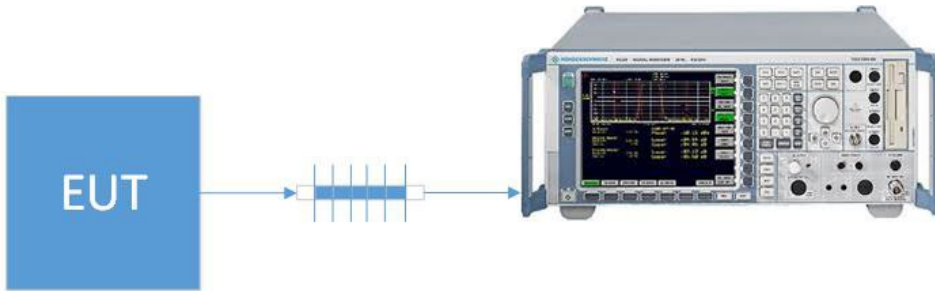

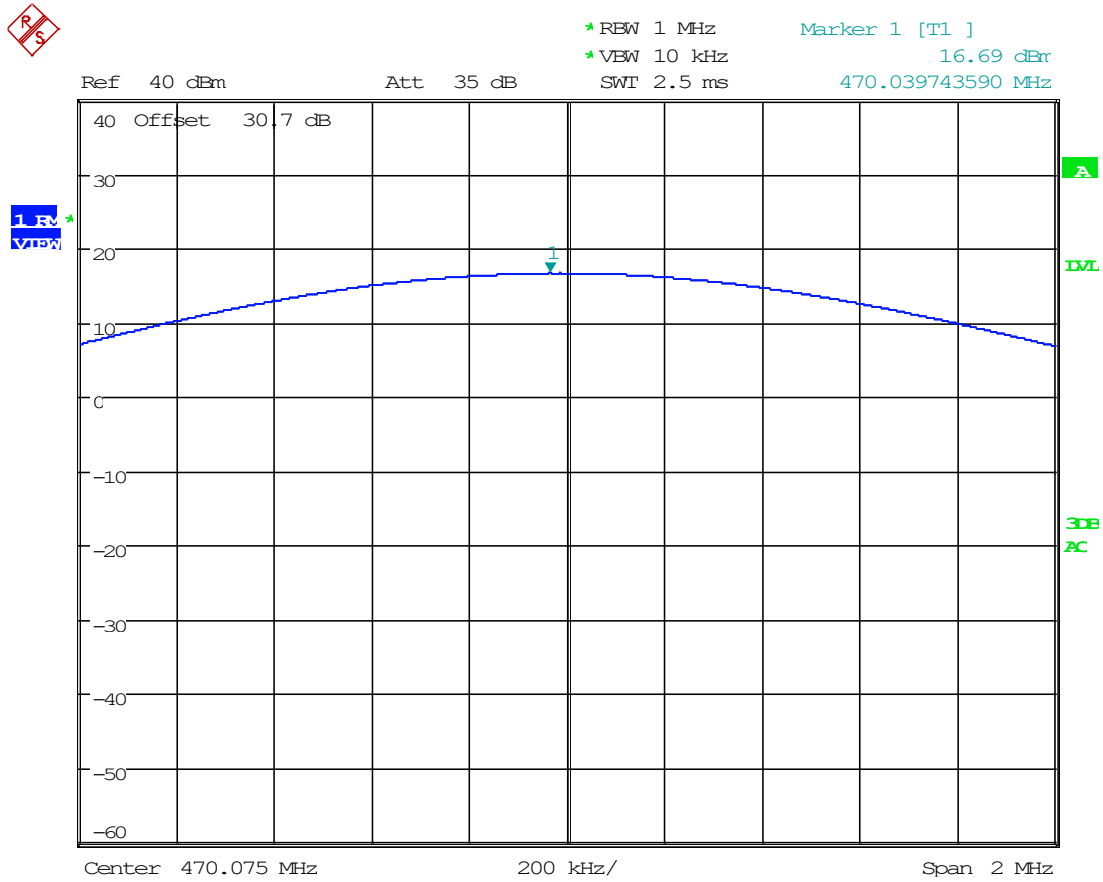

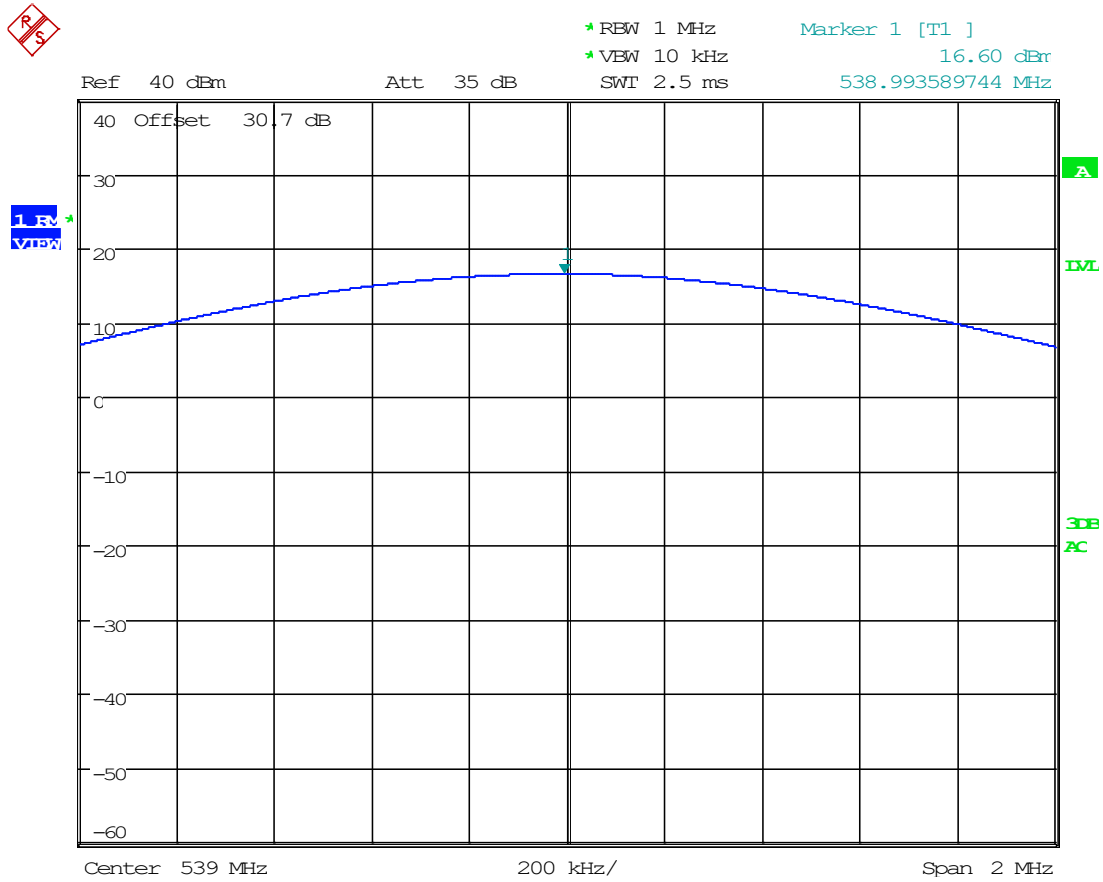


8.1.1 Power Output Plot, 470.075 MHz



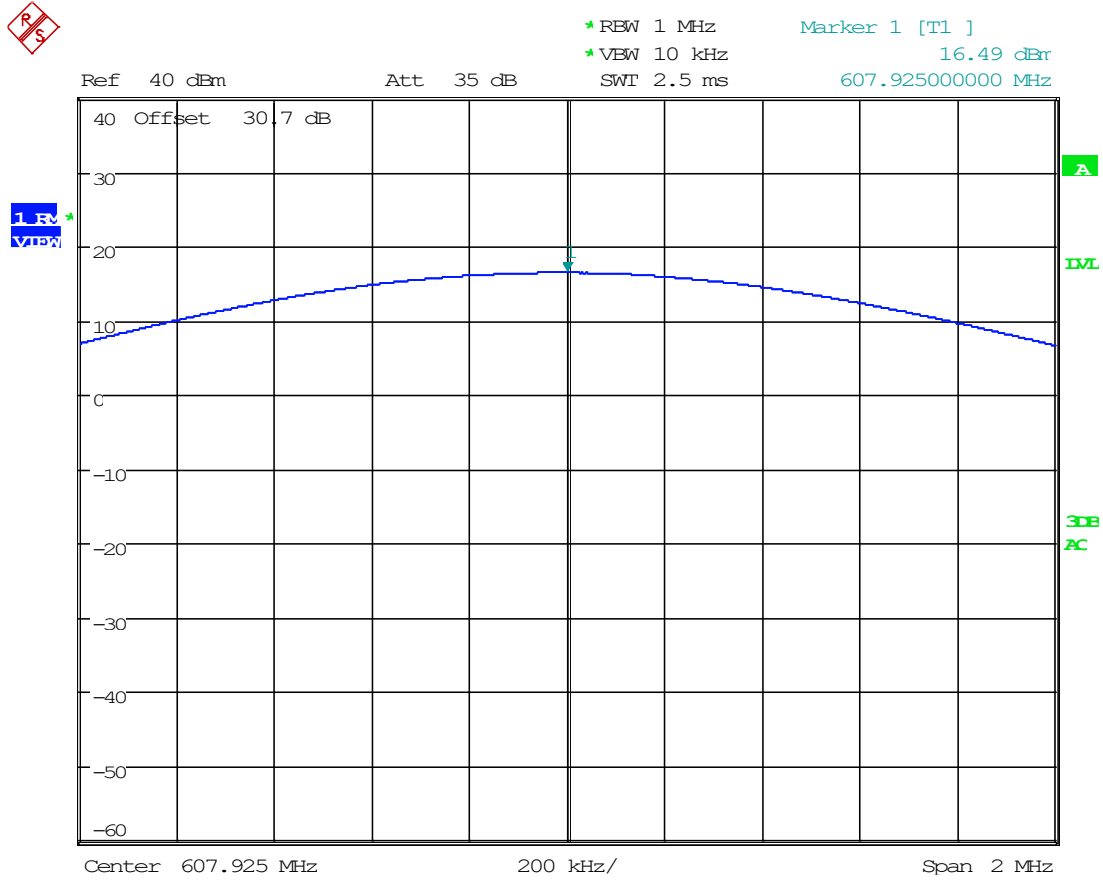

8.1.2 Power Output Plot, 539 MHz



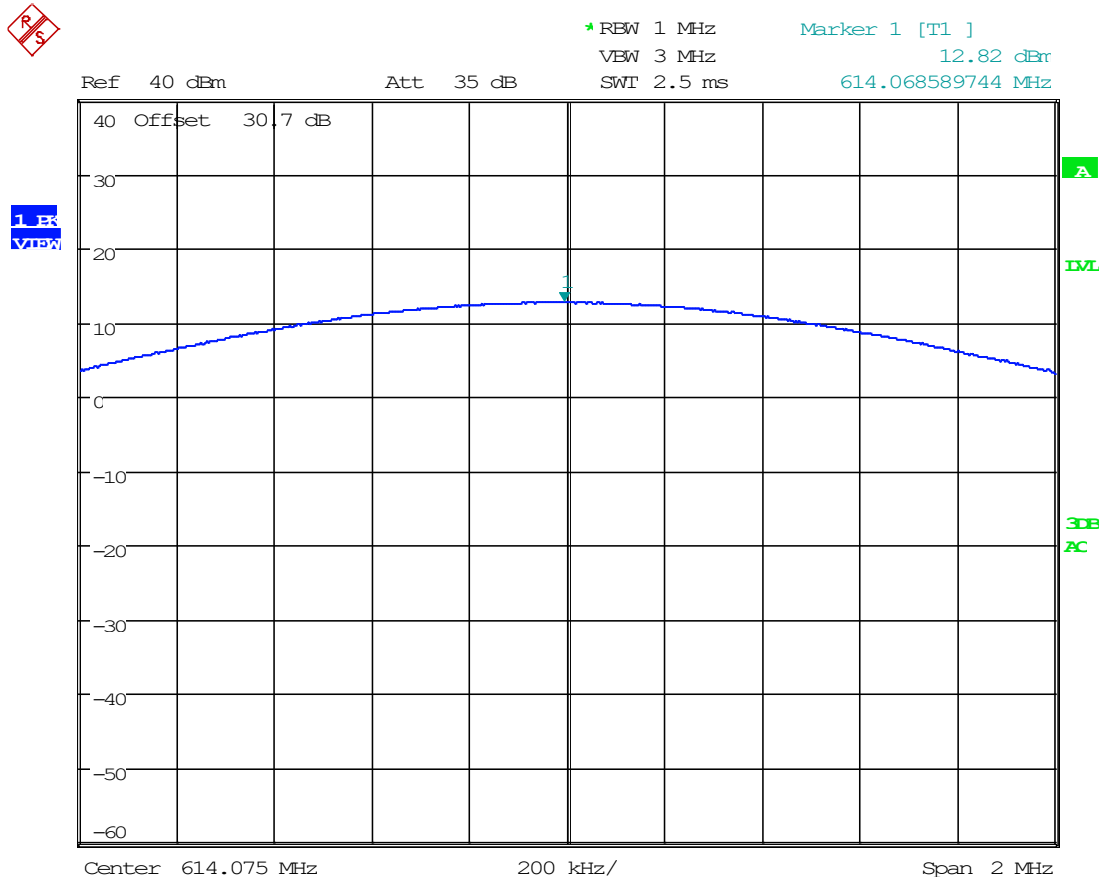

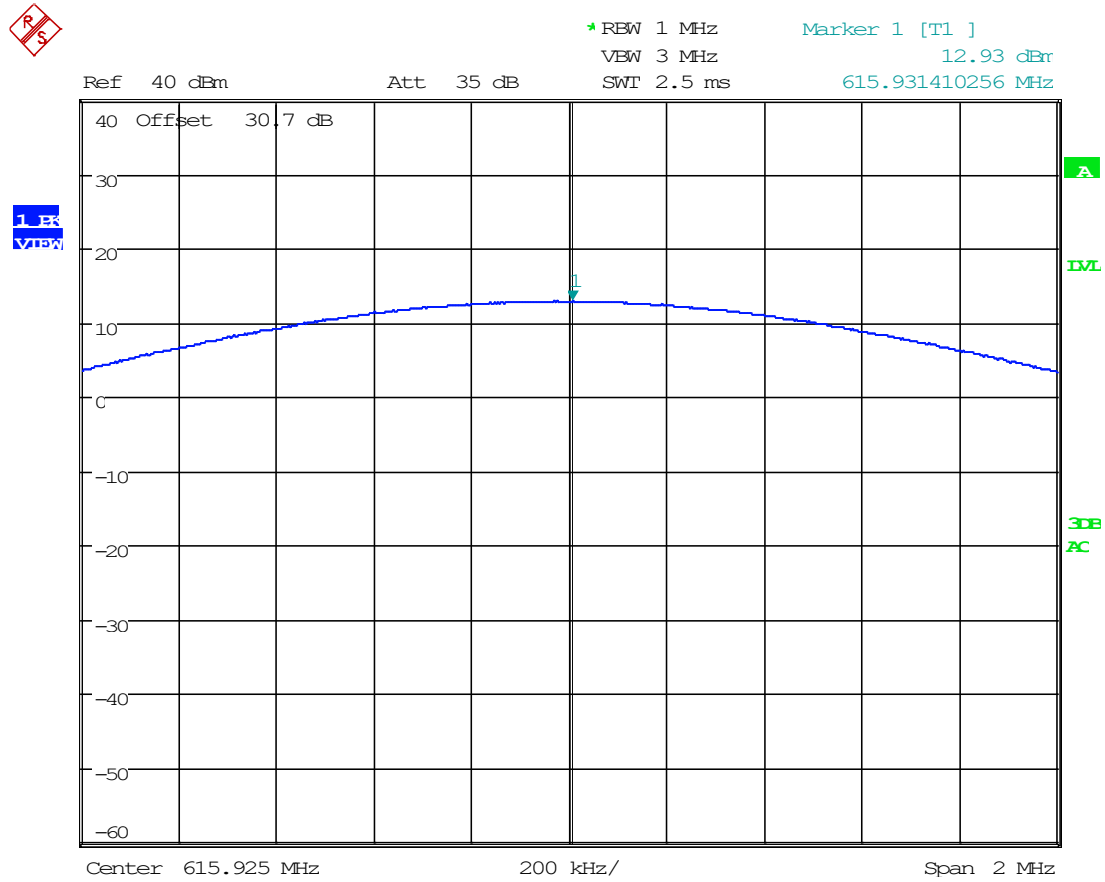
8.1.4 Power Output Plot, 614.075 MHz

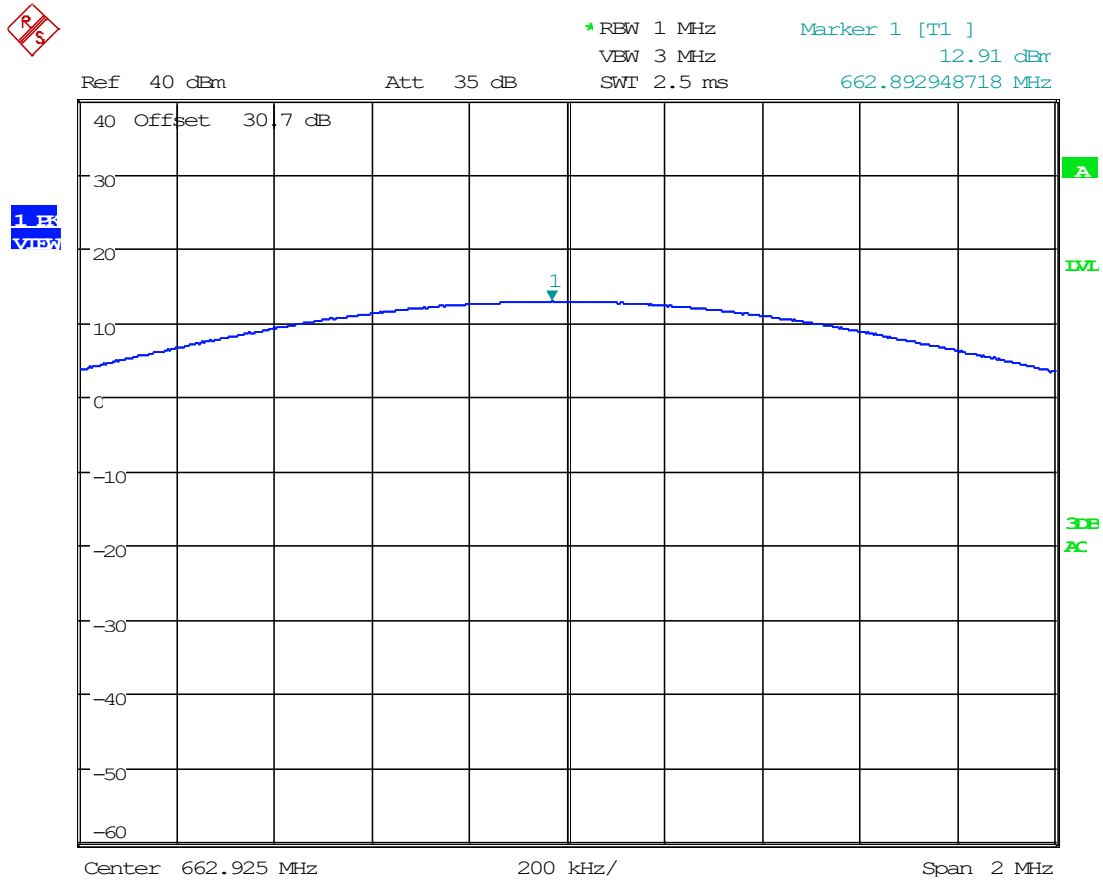


8.1.5 Power Output Plot, 615.925 MHz

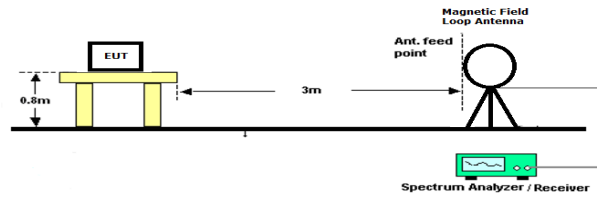

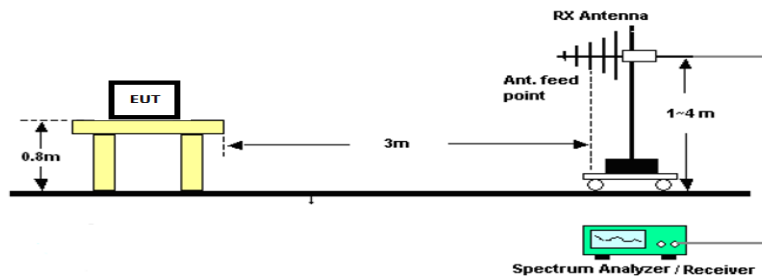

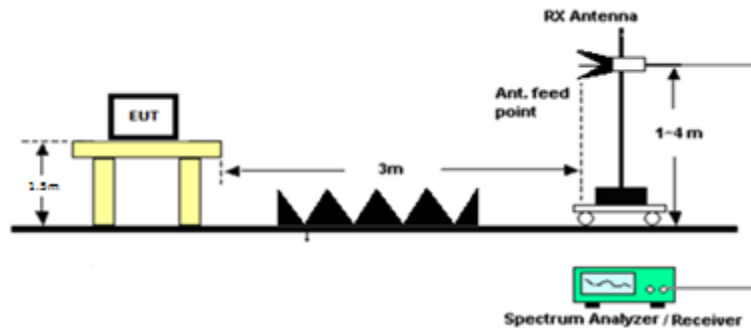
Radiated Test Setup, Below 30 MHz
