8. Test Results

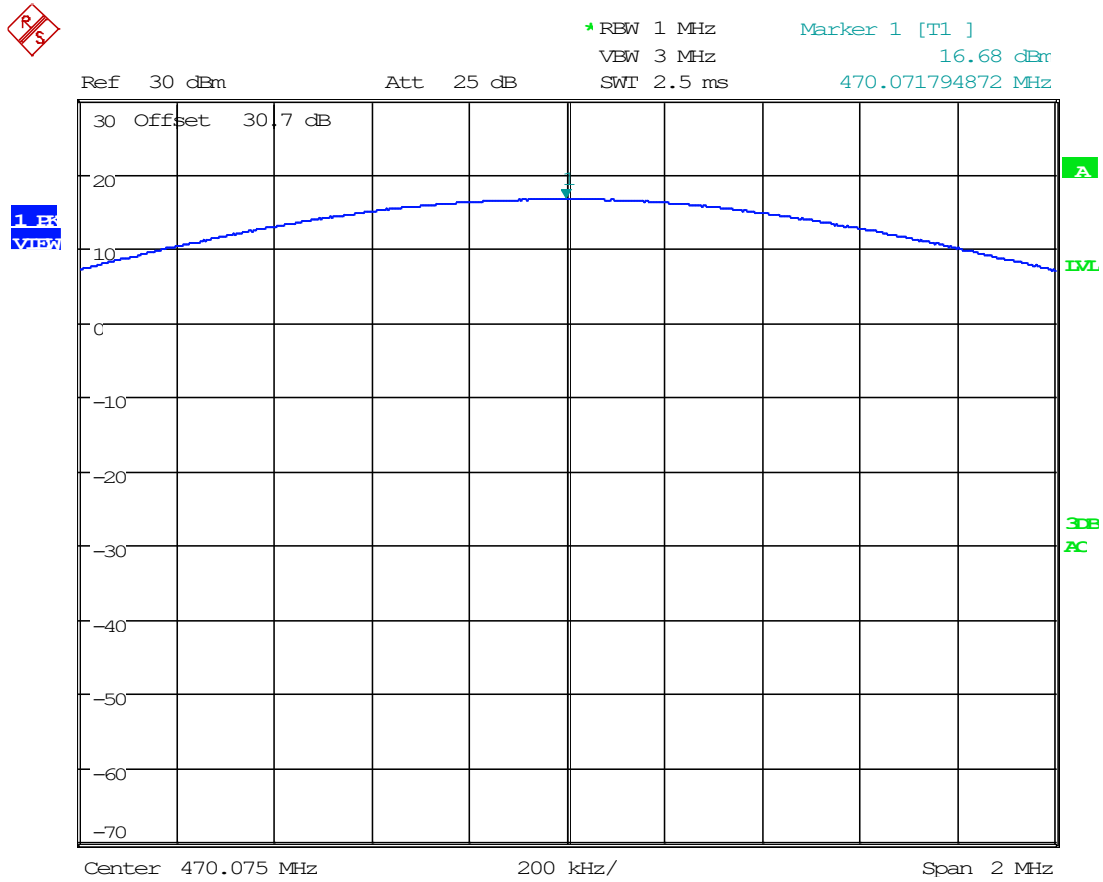

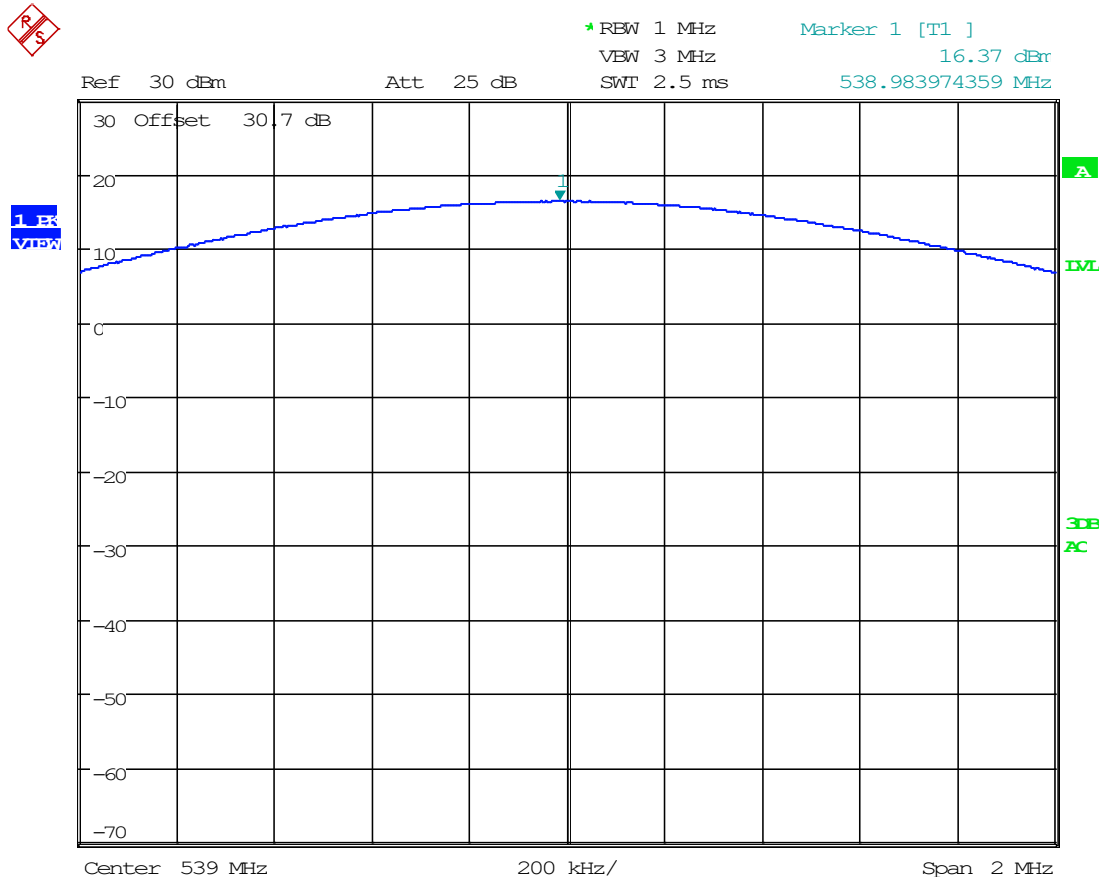

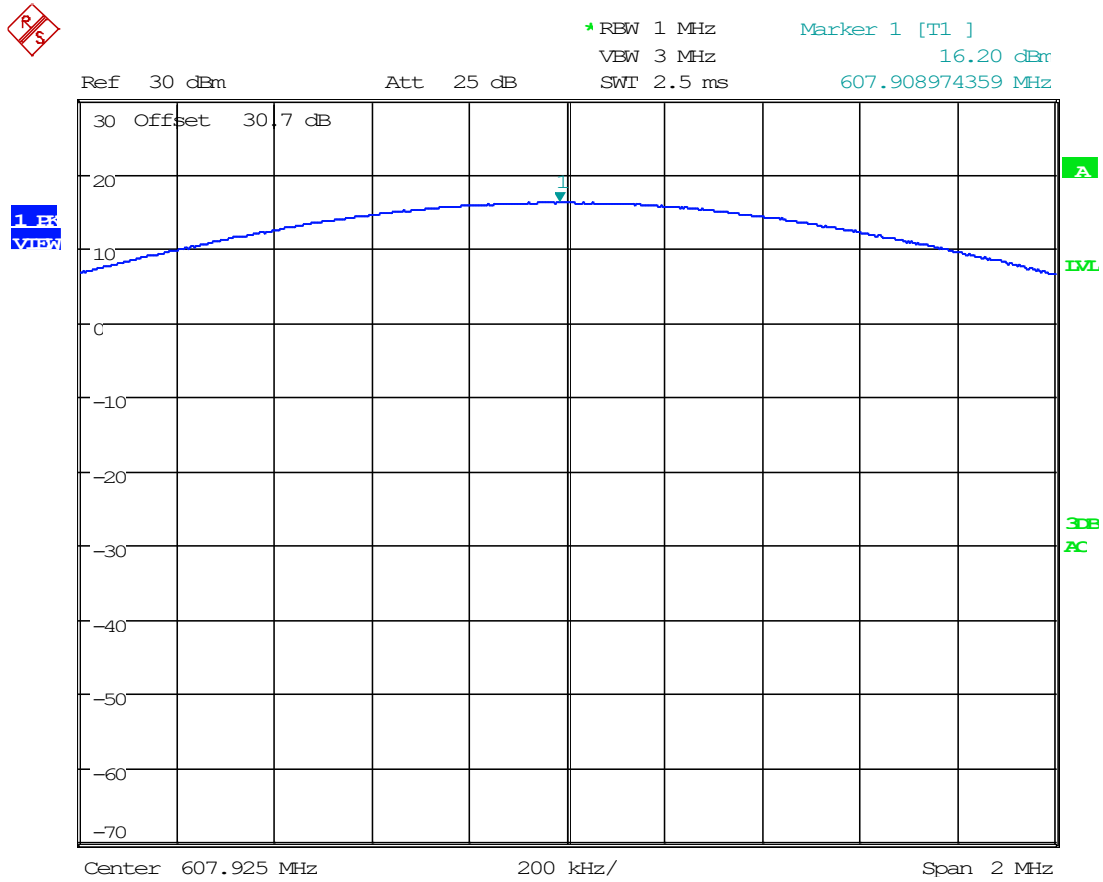

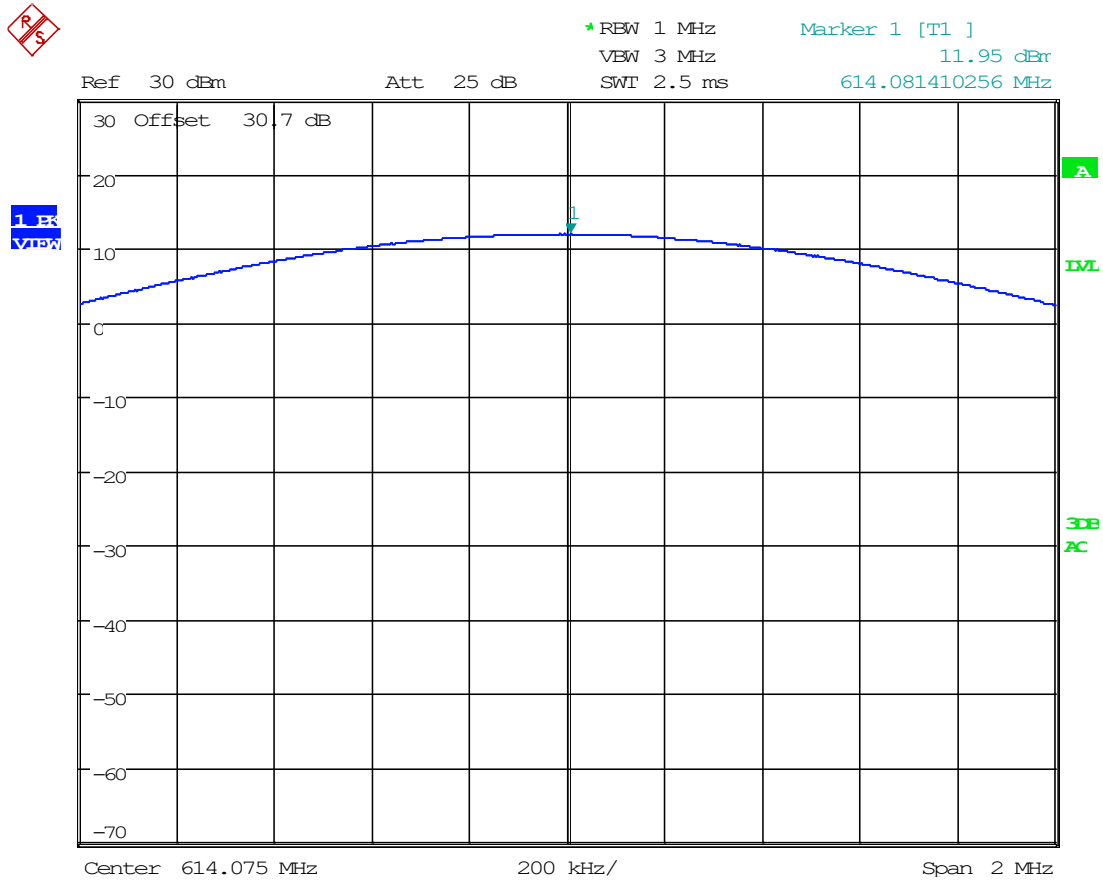

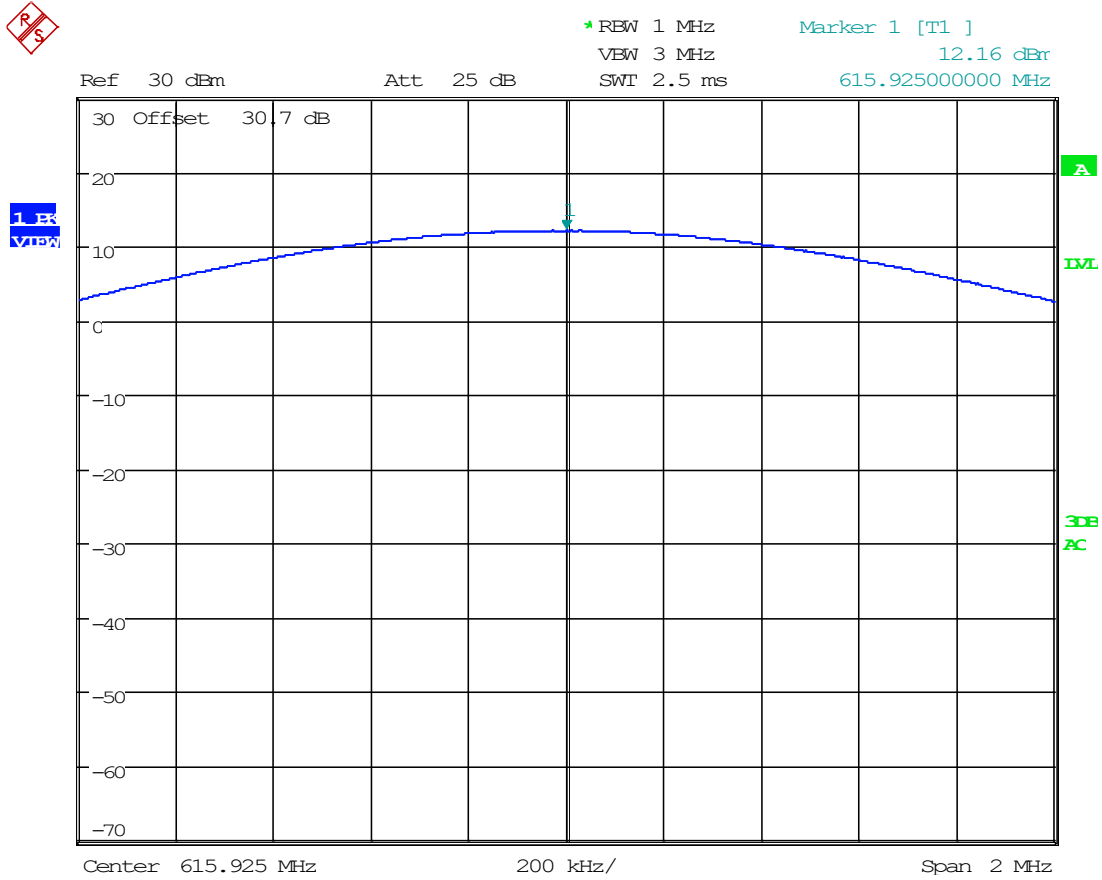
8.1.4 Power Output Plot, 614.075 MHz

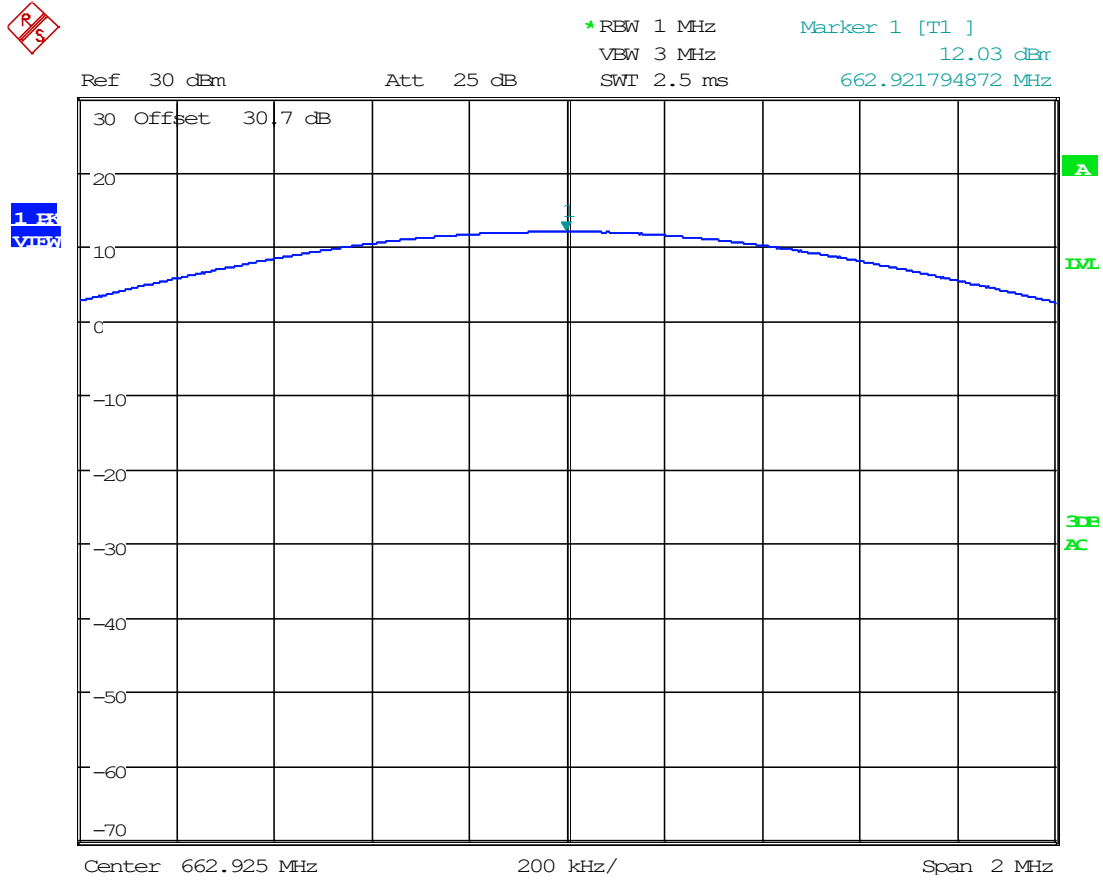
8.1.5 Power Output Plot, 615.925 MHz

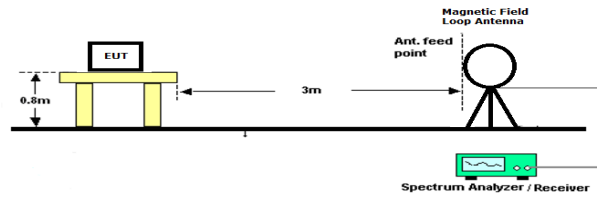

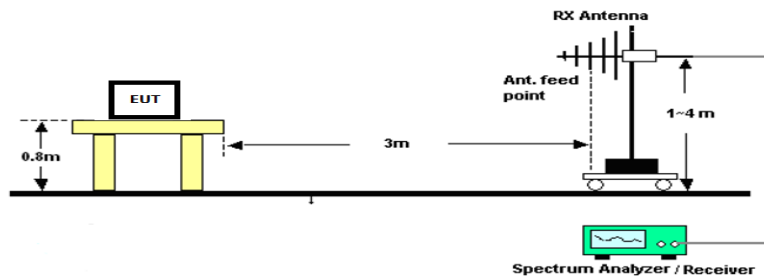

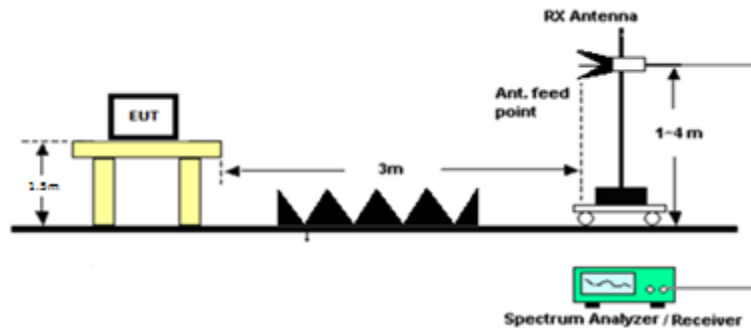
Radiated Test Setup, Below 30 MHz
