#### **GENERAL INFORMATION**

#### **Product Description for Equipment under Test (EUT)**

The Shenzhen Rapoo Technology Co., Ltd. 's product, model number: 7200P (FCC ID: PP27200P) (the "EUT") in this report was a Wireless Optical Mouse, which was measured approximately: 11.0 cm (L) x 6.5 cm (W) x 4.0 cm (H), rated input voltage: DC 1.5V from battery.

#### **Objective**

This type approval report was prepared on behalf of *Shenzhen Rapoo Technology Co., Ltd.* in accordance with Part 2-Subpart J, and Part 15-Subparts A, B and C of the Federal Communications Commission's rules

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, and section 15.203, 15.205, 15.207, 15.209 and 15.249 rules.

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2003, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All radiated and conducted emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Dongguan).

#### **Test Facility**

The Test site used by Bay Area Compliance Laboratories Corp. (Dongguan) to collect test data is located on the No.69 Pulongcun, Puxinhu Industrial Zone, Tangxia, Dongguan, Guangdong, China

Test site at Bay Area Compliance Laboratories Corp. (Dongguan) has been fully described in reports submitted to the Federal Communications Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on February 02, 2012. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2003.



As per FCC§15.249 (c), Field strength limits are specified at a distance of 3 meters.

(d) Emissions radiated outside of the specified frequency bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits in §15.209, whichever is the lesser attenuation.

#### **Measurement Uncertainty**

Compliance or non- compliance with a disturbance limit shall be determined in the following manner:

If  $U_{\text{lab}}$  is less than or equal to  $U_{\text{cispr}}$  of Table 1, then:

- compliance is deemed to occur if no measured disturbance level exceeds the disturbance limit;
- non compliance is deemed to occur if any measured disturbance level exceeds the disturbance limit. If  $U_{\text{lab}}$  is greater than  $U_{\text{cispr}}$  of Table 1, then:
- compliance is deemed to occur if no measured disturbance level, increased by  $(U_{lab} U_{cispr})$ , exceeds the disturbance limit;
- non compliance is deemed to occur if any measured disturbance level, increased by  $(U_{\text{lab}} U_{\text{cispr}})$ , exceeds the disturbance limit.





The radiated emission and out of band emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2003. The specification used was the FCC 15.209/15.205 and FCC 15.249 limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

#### **Test Equipment Setup**

The system was investigated from 30 MHz to 40 GHz.

During the radiated emission test, the EMI test receiver & Spectrum Analyzer Setup were set with the following configurations:

#### **Test Procedure**

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detection mode from 30MHz to 1GHz, Peak and average detection mode above 1 GHz.

#### **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin = Limit –Extrapolation result

## FCC §15.215(c)-20 dB BANDWIDTH TESTING

#### **Applicable Standard**

Intentional radiators operating under the alternative provisions to the general emission limits, as contained in §§ 15.217 through 15.257 and in Subpart E of this part, must be designed to ensure that the 20 dB bandwidth of the emission, or whatever bandwidth may otherwise be specified in the specific rule section under which the equipment operates, is contained within the frequency band designated in the rule section under which the equipment is operated.

#### **Test Procedure**

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT on the test table without connection to measurement instrument. Turn on the EUT. Then set it to any one convenient frequency within its operating range. Set a reference level on the measuring instrument equal to the highest peak value.
- 3. Measure the frequency difference of two frequencies that were attenuated 20 dB from the reference level. Record the frequency difference as the emission bandwidth.
- 4. Repeat above procedures until all frequencies measured were complete.



#### **Low Channel**




#### Middle Channel
