GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The Shenzhen Rapoo Technology Co., Ltd.'s product, model number: S160 (FCC ID: PP2S160) (the "EUT") in this report was a Bluetooth Touch Headset, which was measured approximately: 17.0cm (L) x 15.0 cm (W) x 6.3 cm (H), rated input voltage: DC3.7V from Li-ion battery or DC5V from system.

Objective

This report is prepared on behalf of *Shenzhen Rapoo Technology Co., Ltd.* in accordance with Part 2, Subpart J, Part 15, Subparts A, B and C of the Federal Communications Commission's rules

The tests were performed in order to determine the compliance of the EUT with FCC Part 15-Subpart C, section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Dongguan).

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp. (Dongguan) to collect test data is located on the No.69 Pulongcun, Puxinhu Industrial Zone, Tangxia, Dongguan, Guangdong, China

Test site at Bay Area Compliance Laboratories Corp. (Dongguan) has been fully described in reports submitted to the Federal Communications Commission (FCC). 

Measurement Result

The maximum peak conducted output power= 7.2 dBm (5.25mW) at 2440 MHz [(max. power of channel, mW)/(min. test separation distance, mm)][$\sqrt{f(GHz)}$] = 5.25/5*($\sqrt{2.44}$) = 1.64 < 3.0

So the stand-alone SAR evaluation is not necessary.







The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2009. The specification used was the FCC 15.209, and FCC 15.247 limits. The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

The adapter was connected to a 120 VAC/60 Hz power source.

The system was investigated from 30 MHz to 25 GHz.

Test Procedure

During the radiated emission test, the adapter was connected to the first AC floor outlet and the other support equipments were connected to the second AC floor outlet.

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz-1 GHz, peak and Average detection modes for frequencies above 1 GHz.




Conducted Spurious Emissions at Antenna Port

BLE Low Channel





BLE Middle Channel





FCC §15.247(b) (3) - MAXIMUM CONDUCTED OUTPUT POWER

Applicable Standard

According to FCC §15.247(b) (3), for systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. 




BLE Middle Channel

FCC §15.247(d) – 100 kHz BANDWIDTH OF FREQUENCY BAND EDGE

Report No.: RDG150826003-00B

Applicable Standard

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

Test Procedure

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT without connection to measurement instrument. Turn on the EUT and connect its antenna terminal to measurement instrument via a low loss cable. Then set it to any one measured frequency within its operating range, and make sure the instrument is operated in its linear range.
- 3. Set RBW to 100 kHz and VBW of spectrum analyzer to 300 kHz with a convenient frequency span including 100 kHz bandwidth from band edge.
- 4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
- 5. Repeat above procedures until all measured frequencies were complete.




BLE Band Edge , Left Side



Power Spectral Density, BLE Low Channel




Power Spectral Density, BLE Middle Channel
