1.4 Test Methodology

Both conducted and radiated testing were performed according to the procedures in ANSI C63.4/1992. Radiated testing was performed at an antenna to EUT distance of 10 meters.

1.5 Test Facility

5. Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor. The basic equation with a sample calculation is as follows:

$$FS = RA + AF + CF$$

where FS = Field Strength

RA = Receiver Amplitude

AF = Antenna Factor

CF = Cable Attenuation Factor

Assume a receiver reading of 21.5 dBuV is obtained. The Antenna Factor of 7.4 and a Cable Factor of 1.1 is added. The 30 dBuV/m value was mathematically converted to its corresponding level in uV/m.

$$FS = 21.5 + 7.4 + 1.1 = 30 dBuV/m$$
