1. Maximum Permissible Exposure

1.1. Applicable Standard

Systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy levels in excess limit for maximum permissible exposure. In accordance with 47 CFR FCC Part 2 Subpart J, section 2.1091 this device has been defined as a mobile device whereby a distance of 0.2m normally can be maintained between the user and the device.

1.2. MPE Calculation Method

E (V/m) =
$$\frac{\sqrt{30 \times P \times G}}{d}$$
 Power Density: Pd (W/m²) = $\frac{E^2}{377}$

 \mathbf{E} = Electric field (V/m)

P = Peak RF output power (W)

G = EUT Antenna numeric gain (numeric)

d = Separation distance between radiator and human body (m)

The formula can be changed to

$$Pd = \frac{30 \times P \times G}{377 \times d^2}$$

From the peak EUT RF output power, the minimum mobile separation distance, d=0.2m, as well as the gain of the used antenna, the RF power density can be obtained.

CONCULSION:

Both of the WLAN and Bluetooth can transmit simultaneously, the formula of calculated the MPE is:

CPD1 / LPD1 + CPD2 / LPD2 +etc. < 1

CPD = Calculation power density

LPD = Limit of power density

Therefore, the worst-case situation is 0.181531 / 1 + 0.001202 / 1 = 0.182733, which isless than "1". This confirmed that the device comply with FCC 1.1310 MPE limit.
