Here is some additional information. I looked at the original grant, and the low pass filters added in this C2PC are inserted in the signal paths for both DTS and NII. The C2PC letter says that no change was made to hardware or firmware, so this would indicate it is still capable of operation on NII frequencies.

So they either need to file an NII composite C2PC or revise the C2PC letter to add an explanation that the NII capability is disabled.

Please let me know asap what they will do.

I was not able to catch this sooner because nothing in the application mentions it. I only noticed when I went to FCC to check the grant conditions.

This is not the official notice for this application, but so far I have no technical issues, but need to clear this issue to complete.
