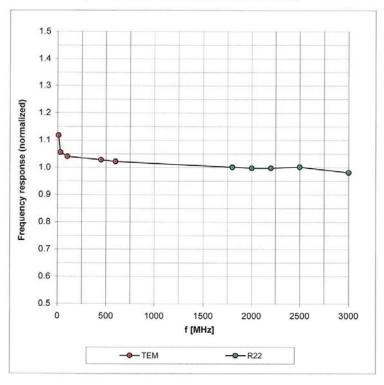

Uncertainty of Frequency Response of E-field: ± 6.3% (k=2)

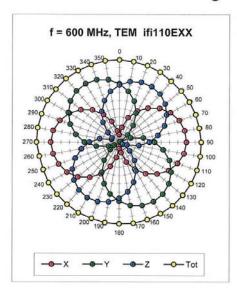

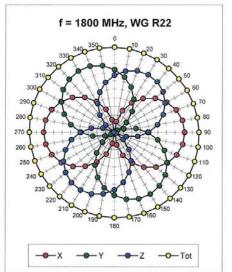

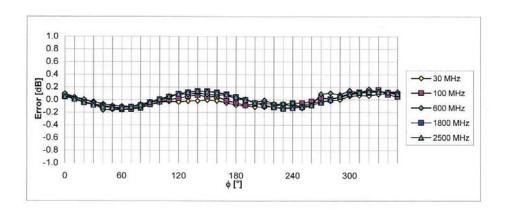




Receiving Pattern (ϕ), $\vartheta = 0^{\circ}$
