- The EUT is designed to consume power from host equipment (100-240V, 50/60Hz). For radiated evaluation (30-1000MHz), 230V/50Hz (for EN 55022) & 120V/60Hz (for FCC Part 15), had been covered during the pre-test. The EUT worst radiated emission data (30-1000MHz) was founded at 230V/50Hz and recorded in the applied test report.






#### 4.1.3 TEST PROCEDURE

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150kHz to 30MHz was searched. Emission levels under (Limit 20dB) was not recorded.

- 3. The support unit 1 (Notebook Computer) sends messages to support unit 6 (Notebook Computer) under transmission condition continuously via Bluetooth.





### **4.2.3 TEST PROCEDURE**

#### Below 1 GHz:

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meters chamber room. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 10 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to quasi-peak detect function and specified bandwidth with maximum hold mode when the test frequency is below 1 GHz. **NOTE:** 
  - 1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 kHz for quasi-peak detection (QP) at frequency 30MHz to 1GHz.

#### Above 1 GHz:

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meters chamber room. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The height of antenna can be varied from one meter to four meters, the height of adjustment depends on the EUT height and the antenna 3dB beamwidth both, detect the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- The spectrum analyzer system was set to peak and average detect function and specified bandwidth with maximum hold mode when the test frequency is above 1 GHz.

#### NOTE:

- 1. The resolution bandwidth is 1MHz and video bandwidth of test receiver/spectrum analyzer is 3MHz for Peak detection at frequency above 1GHz. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz for Average detection (AV) at frequency above 1GHz.
- 2. For measurement of frequency above 1000 MHz, the EUT was set 3 meters away from the interference-receiving antenna.


