


Fig.1 Photograph of the SAR measurement system






Fig.3 EUT Lap-held mode to flat phantom






Fig.4 EUT Top side to flat phantom






Fig.5 EUT Left side to flat phantom




Fig.10 Antenna position of EUT (Front view of the tablet mode)
