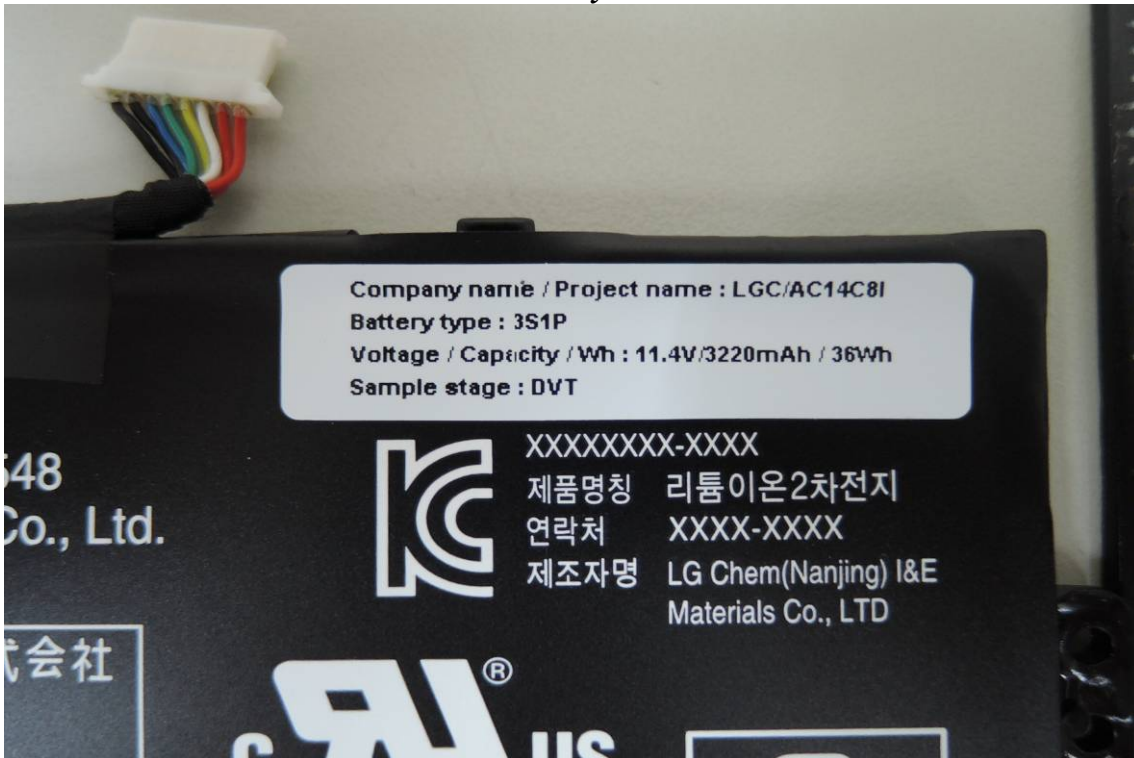

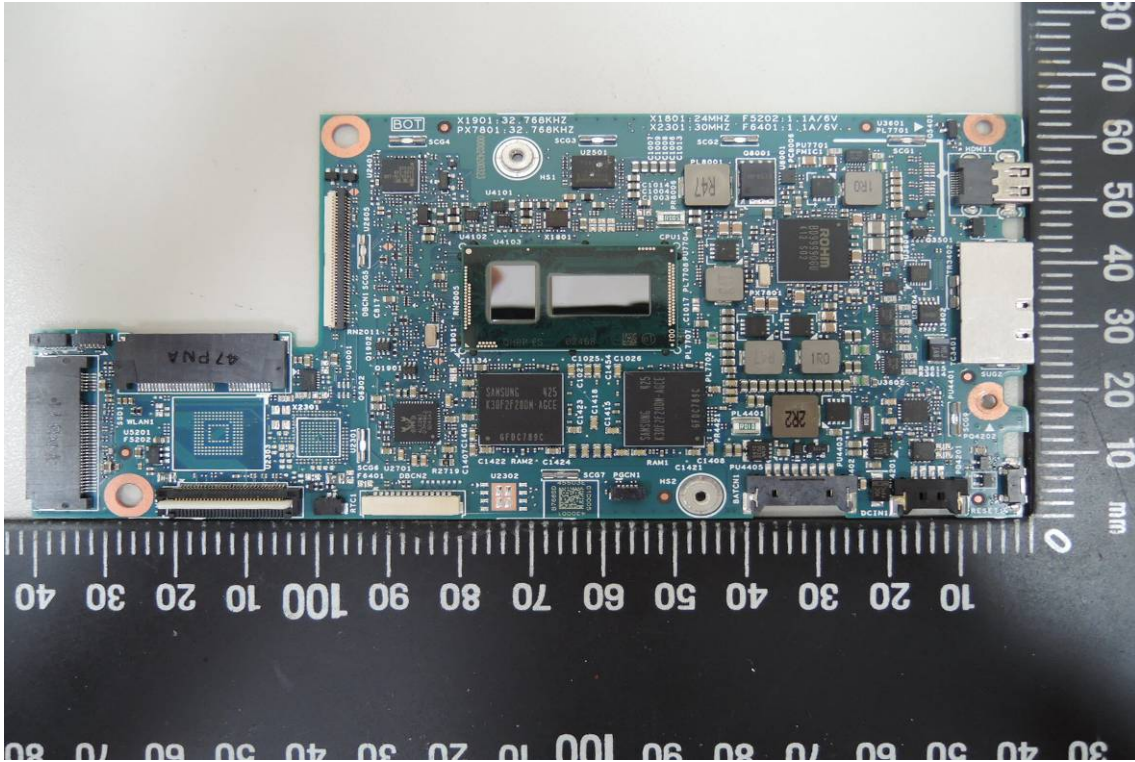

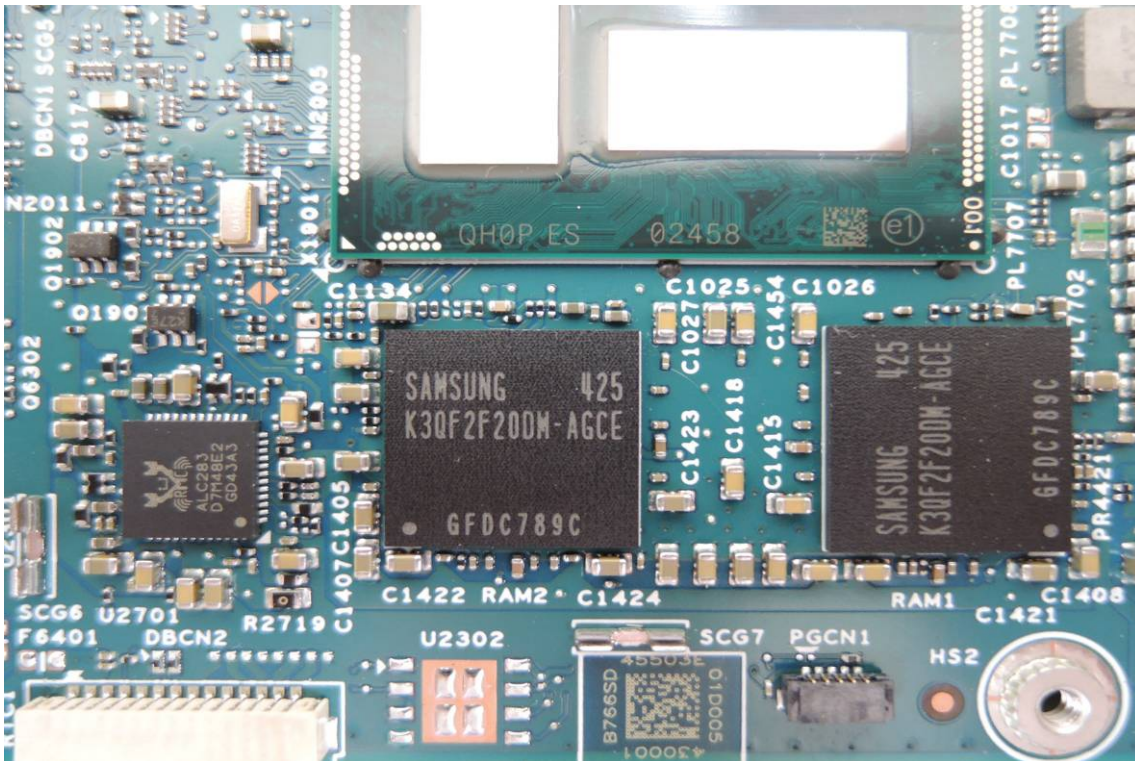

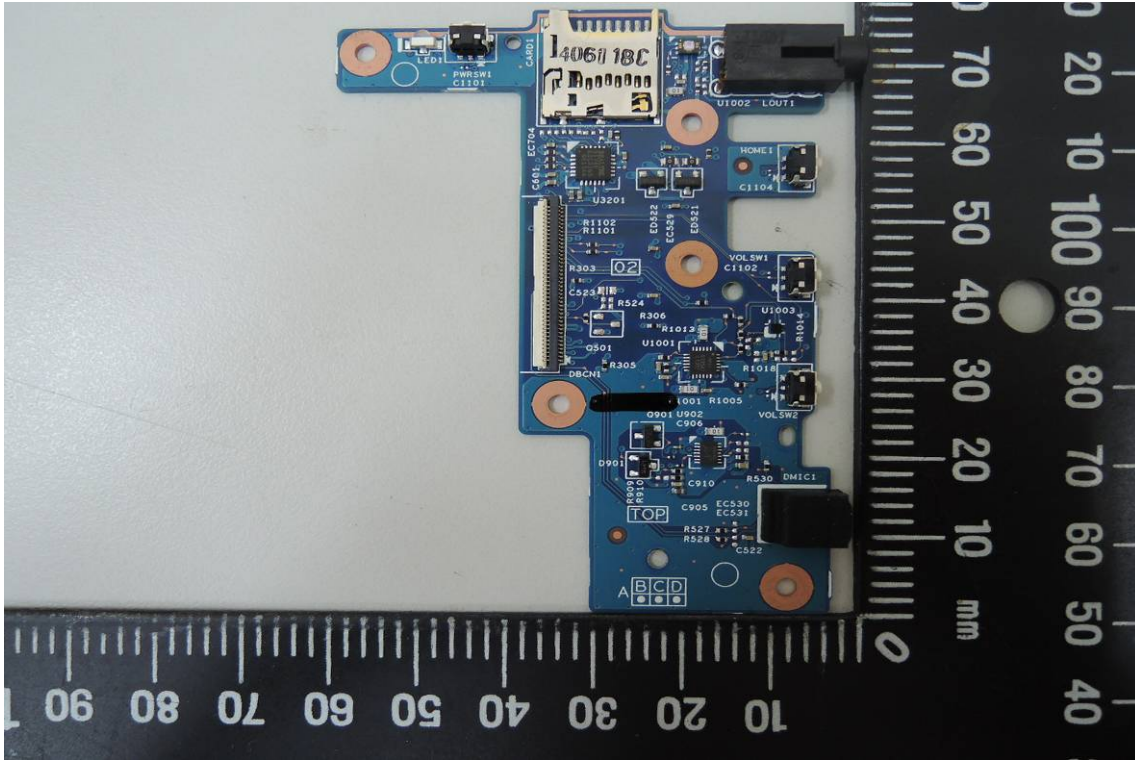

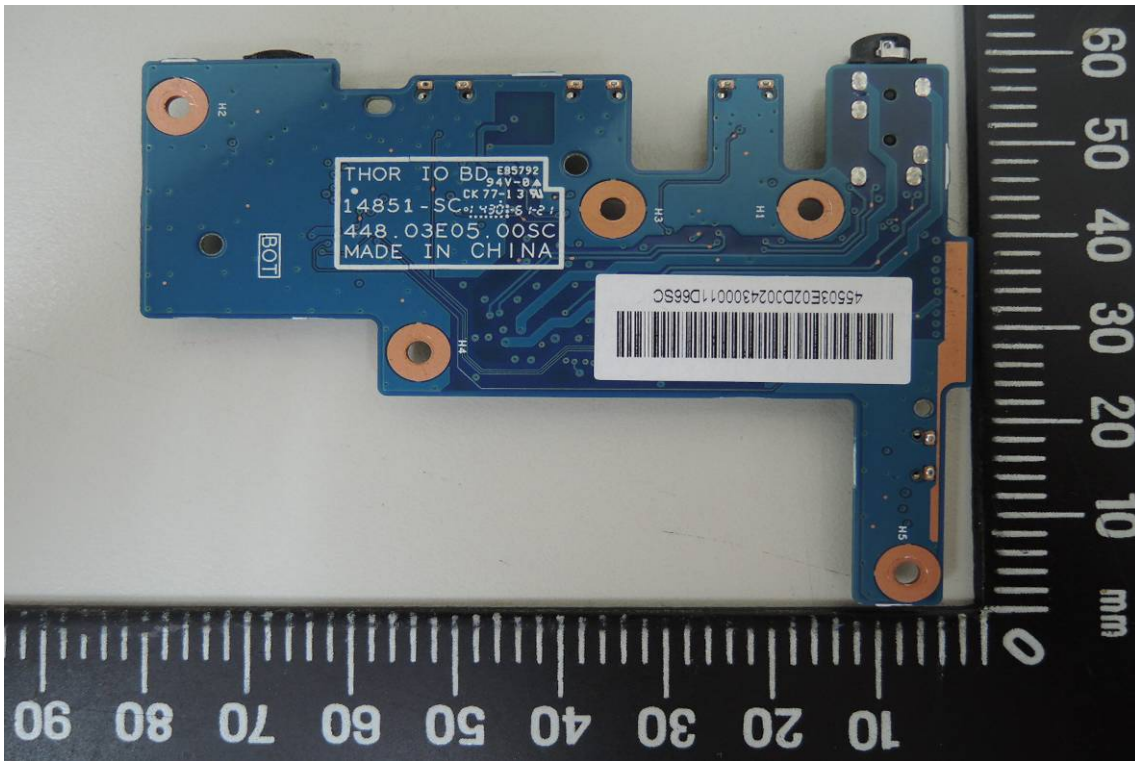

*Internal View of EUT - 4*



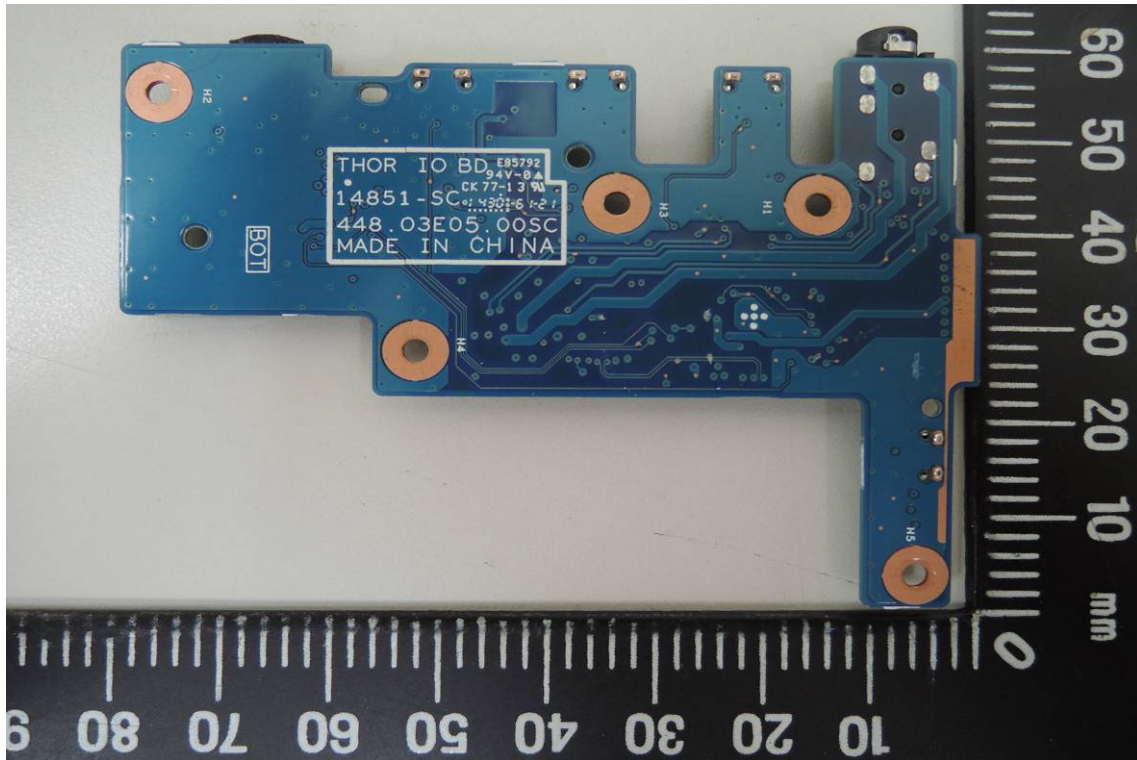

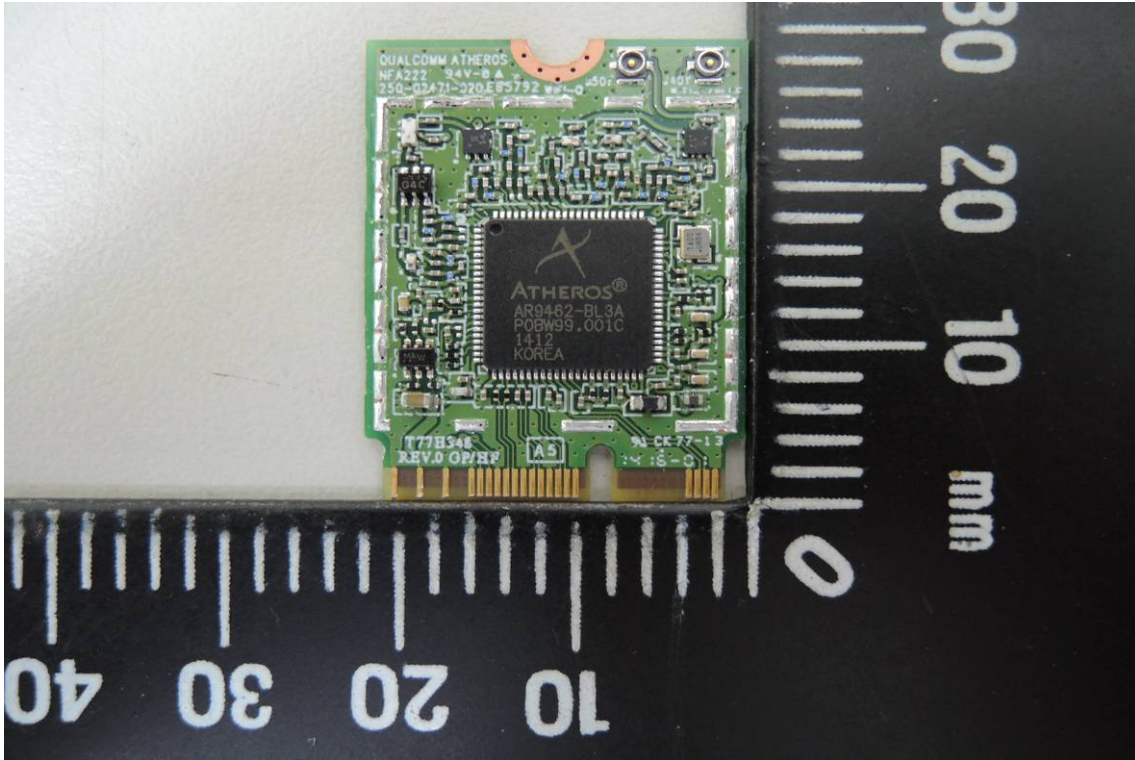

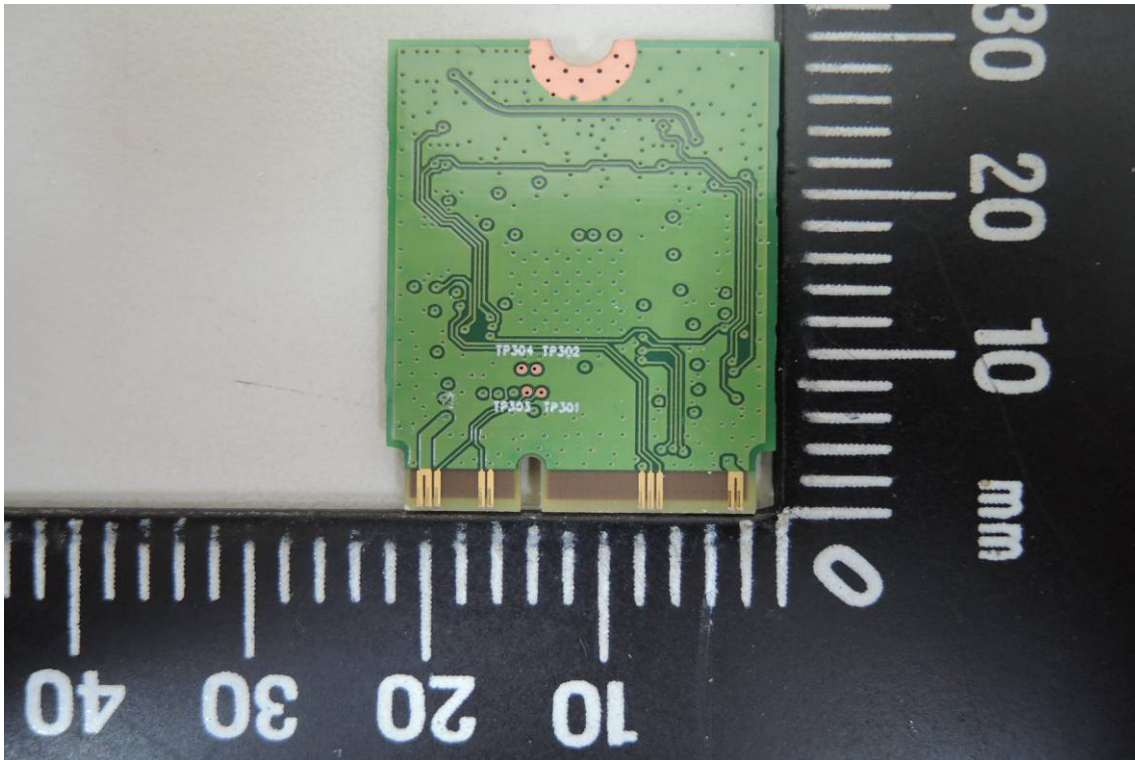

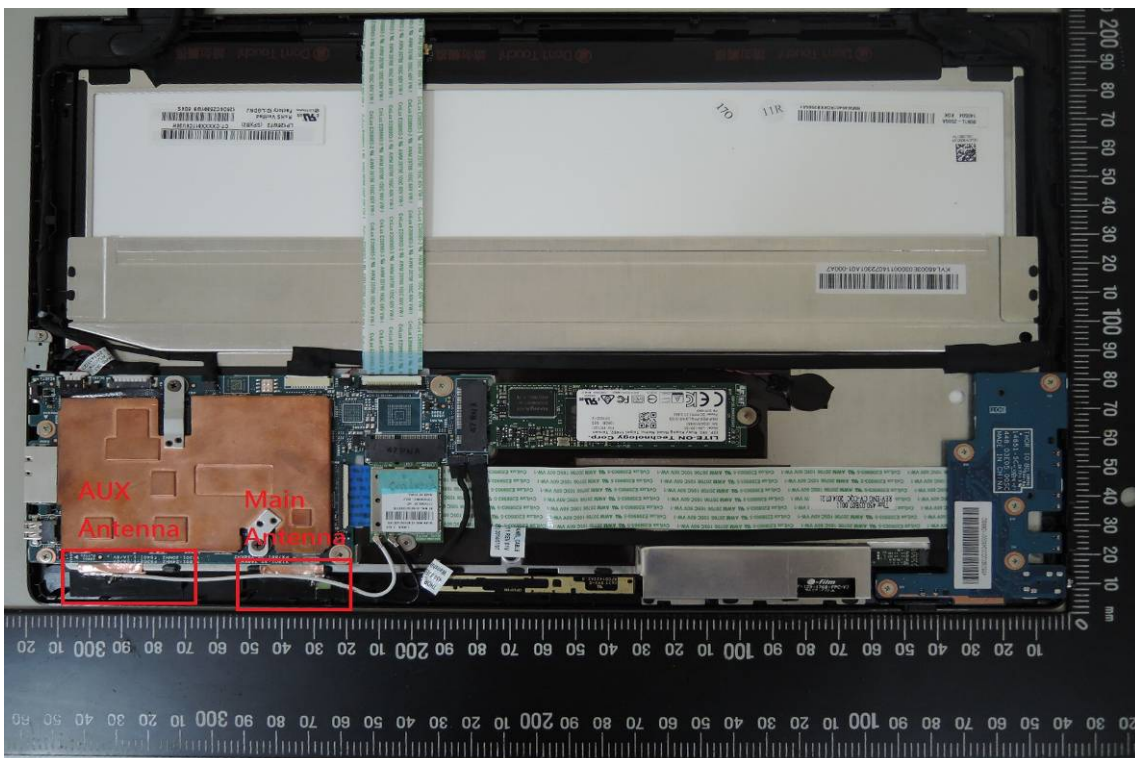

*BT/WLAN Antenna Location*



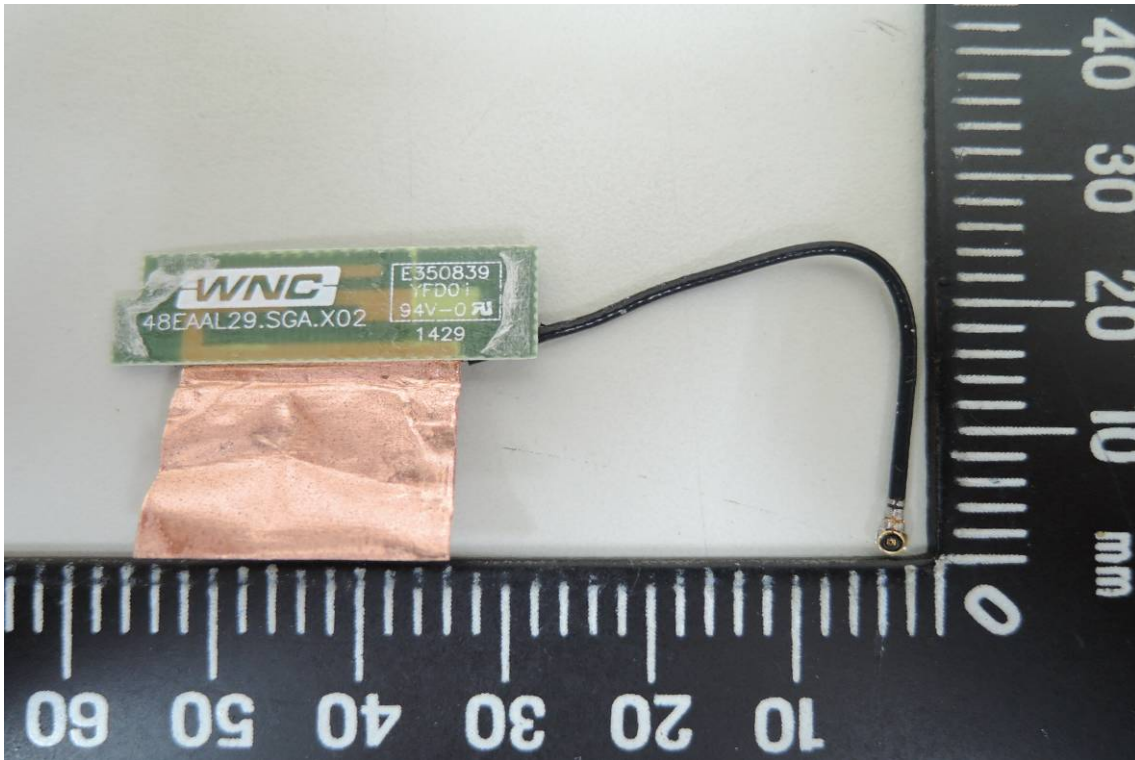
