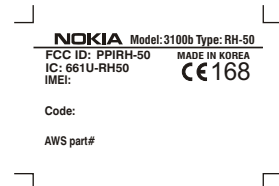

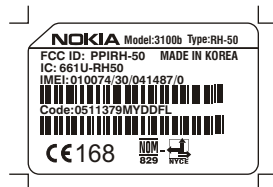
Example AWS part: 1:1



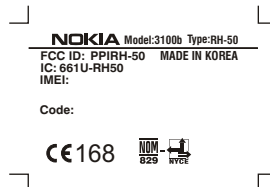
