Friis Formula

Friis transmission formula:  $Pd = (Pout*G)/(4*pi*r^2)$ 

Where

 $Pd = power density in mW/cm^2$ 

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm<sup>2</sup>. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

#### 1.2. Test Procedure

Software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel individually.

The temperature and related humidity:  $18^{\circ}\text{C}$  and 78% RH.

### **Antenna Gain**

Antenna Gain: The maximum Gain measured in fully anechoic chamber is 1.6 dBi in logarithm scale.
