# 2.4 MPE Calculation Method

The MPE was calculated at 20 cm to show compliance with the power density limit. The following formula was used to calculate the Power Density:

$$\mathsf{E}(\mathsf{V/m}) = \frac{\sqrt{30 \times P \times G}}{d}$$

Power Density: 
$$Pd(W/m^2) = \frac{E^2}{377}$$

E = Electric field (V/m)P = RF output power (W)

**G** = EUT Antenna numeric gain (numeric)

d = Separation distance between radiator and human body (m)

The formula can be changed to

$$Pd = \frac{30 \times P \times G}{377 \times d^2}$$
