2.2. MPE Calculation Method

The MPE was calculated at 20 cm to show compliance with the power density limit.

The following formula was used to calculate the Power Density:

$$E \text{ (V/m)} = \frac{\sqrt{30 \times P \times G}}{d} \quad \text{Power Density: } Pd \text{ (W/m}^2\text{)} = \frac{E^2}{377}$$

E = Electric field (V/m)

P = Peak RF output power (W)

G = EUT Antenna numeric gain (numeric)

d = Separation distance between radiator and human body (m)

The formula can be changed to

$$Pd = \frac{30 \times P \times G}{377 \times d^2}$$

Conclusion:

1. Both of the WLAN 2.4GHz Band and BT can transmit simultaneously, the formula of calculated the MPE is:

$$CPD1 / LPD1 + CPD2 / LPD2 + \dots \text{etc.} < 1$$

CPD = Calculation power density

LPD = Limit of power density

Therefore, the worst-case situation is $0.077909 / 1 + 0.002051 / 1 = 0.079960$, which is less than "1". This confirmed that the device complies.

2. Both of the WLAN 5GHz Band and BT can transmit simultaneously, the formula of calculated the MPE is:

$$CPD1 / LPD1 + CPD2 / LPD2 + \dots \text{etc.} < 1$$

CPD = Calculation power density

LPD = Limit of power density

Therefore, the worst-case situation is $0.114682 / 1 + 0.002051 / 1 = 0.116733$, which is less than "1". This confirmed that the device complies.

1. Both of the WLAN 2.4GHz Band and BT can transmit simultaneously, the formula of calculated the MPE is:

$$CPD1 / LPD1 + CPD2 / LPD2 + \dots \text{etc.} < 1$$

CPD = Calculation power density

LPD = Limit of power density

Therefore, the worst-case situation is $0.124447 / 1 + 0.002051 / 1 = 0.126498$, which is less than "1". This confirmed that the device complies.

2. Both of the WLAN 5GHz Band and BT can transmit simultaneously, the formula of calculated the MPE is:

$$CPD1 / LPD1 + CPD2 / LPD2 + \dots \text{etc.} < 1$$

CPD = Calculation power density

LPD = Limit of power density

Therefore, the worst-case situation is $0.092574 / 1 + 0.002051 / 1 = 0.094625$, which is less than "1". This confirmed that the device complies.
