

# 5 MEASUREMENTS, EXAMINATION AND DERIVED RESULTS

## 5.1 §15.247 (i) and §2.1093 – RF Exposure

**Standard Requirement:**

According to §15.247 (i) and §1.1307(b)(1), systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy level in excess of the Commission’s guidelines.

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at *test separation distances* ≤ 50 mm are determined by:

$$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f_{\text{GHz}}}] \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR,}^{16} \text{ where}$$

- $f_{\text{GHz}}$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum *test separation distance* is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum *test separation distance* is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.

Routine SAR evaluation refers to that specifically required by § 2.1093, using measurements or computer simulation. When routine SAR evaluation is not required, portable transmitters with output power greater than the applicable low threshold require SAR evaluation to qualify for TCB approval.

Two antennas are available for the EUT (GSM antenna, Bluetooth/WIFI/BLE antenna).  
 The maximum average output power(turn-up power) in low channel of WIFI is 9.26 dBm= 8.43 mW  
 The calculation results=  $8.43 / 5 * \sqrt{2.412} = 2.62 < 3$

The maximum average output power(turn-up power) in middle channel of WIFI is 9.42 dBm= 8.75 mW  
 The calculation results=  $8.75 / 5 * \sqrt{2.437} = 2.73 < 3$

The maximum average output power(turn-up power) in high channel of WIFI is 9.31dBm= 8.53 mW  
 The calculation results=  $8.53 / 5 * \sqrt{2.462} = 2.68 < 3$

According to KDB 447498, no stand-alone required for WIFI antenna, and no simultaneous SAR measurement is required , please refer to SAR report.

## **5.2 §15.203 - ANTENNA REQUIREMENT**

### **Applicable Standard**

According to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. The structure and application of the EUT were analyzed to determine compliance with section §15.203 of the rules. §15.203 state that the subject device must meet the following criteria:

- a. Antenna must be permanently attached to the unit.
- b. Antenna must use a unique type of connector to attach to the EUT.

Unit must be professionally installed, and installer shall be responsible for verifying that the correct antenna is employed with the unit.

And according to FCC 47 CFR section 15.247 (b), if the transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

### **Antenna Connector Construction**

The EUT has 2 antennas: a PIFA antenna for WIFI/Bluetooth/BLE, the gain is 0 dBi for WIFI/ Bluetooth/ BLE.

a PIFA antenna for GSM and UMTS, the gain is 1 dBi for GSM850/ PCS1900 and 0.5 dBi for UMTS-FDD Band V/UMTS-FDD Band II .

- g) Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

## **5.6 §15.247(d) –Band-Edge & Unwanted Emissions into Non-Restricted Frequency Bands**

#### **Band-Edge Measurements**

An additional consideration when performing conducted measurements of restricted band emissions is that unwanted emissions radiating from the EUT cabinet, control circuits, power leads, or intermediate circuit elements will likely go undetected in a conducted measurement configuration. To address this concern, a radiated test shall be performed to ensure that emissions emanating from the EUT cabinet (rather than the antenna port) also comply with the applicable limits.

For these cabinet radiated spurious emission measurements the EUT transmit antenna may be replaced with a termination matching the nominal impedance of the antenna. Procedures for performing radiated measurements are specified in ANSI C63.10. All detected emissions shall comply with the applicable limits.

### **Procedures: (Radiated Method Only)**

- Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- Position the EUT without connection to measurement instrument. Put it on the Rotated table and turn on the EUT and make it operate in transmitting mode. Then set it to Low Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.
- First, set both RBW and VBW of spectrum analyzer to 100 kHz with a convenient frequency span including 100kHz bandwidth from band edge, check the emission of EUT, if pass then set Spectrum Analyzer as below:
  - The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 kHz for Quasiy Peak detection at frequency below 1GHz.
  - The resolution bandwidth of test receiver/spectrum analyzer is 1MHz and video bandwidth is 3MHz for Peak detection at frequency above 1GHz.
  - The resolution bandwidth of test receiver/spectrum analyzer is 1MHz and the video bandwidth for Average detection (AV) as below at frequency above 1GHz.

1. All possible modes of operation were investigated. Only the 6 worst case emissions measured, using the correct CISPR detectors, are reported. All other emissions were relatively insignificant.
2. A "-ve" margin indicates a PASS as it refers to the margin present below the limit line at the particular frequency.
3. Radiated Emissions Measurement Uncertainty  
All test measurements carried out are traceable to national standards. The uncertainty of the measurement at a confidence level of approximately 95% (in the case where distributions are normal), with a coverage factor of 2, in the range 30MHz – 1GHz & 1GHz above ( 3m & 10m) is +/-6dB.

### **Requirement:**

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. ### **Procedures:**

1. The EUT was switched on and allowed to warm up to its normal operating condition.
2. The test was carried out at the selected frequency points obtained from the EUT characterisation. Maximization of the emissions was carried out by rotating the EUT, changing the antenna polarization, and adjusting the antenna height in the following manner:
  - a. Vertical or horizontal polarisation (whichever gave the higher emission level over a full rotation of the EUT) was chosen.
  - b. The EUT was then rotated to the direction that gave the maximum emission.
  - c. Finally, the antenna height was adjusted to the height that gave the maximum emission.
3. A Quasi-peak measurement was then made for that frequency point for below 1GHz test, PK and AV for above 1GHz emission test.
  - a. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 kHz for Quasiy Peak detection at frequency below 1GHz.
  - b. The resolution bandwidth of test receiver/spectrum analyzer is 1MHz and video bandwidth is 3MHz for Peak detection at frequency above 1GHz.
  - c. The resolution bandwidth of test receiver/spectrum analyzer is 1MHz and the video bandwidth for Average detection (AV) as below at frequency above 1GHz.

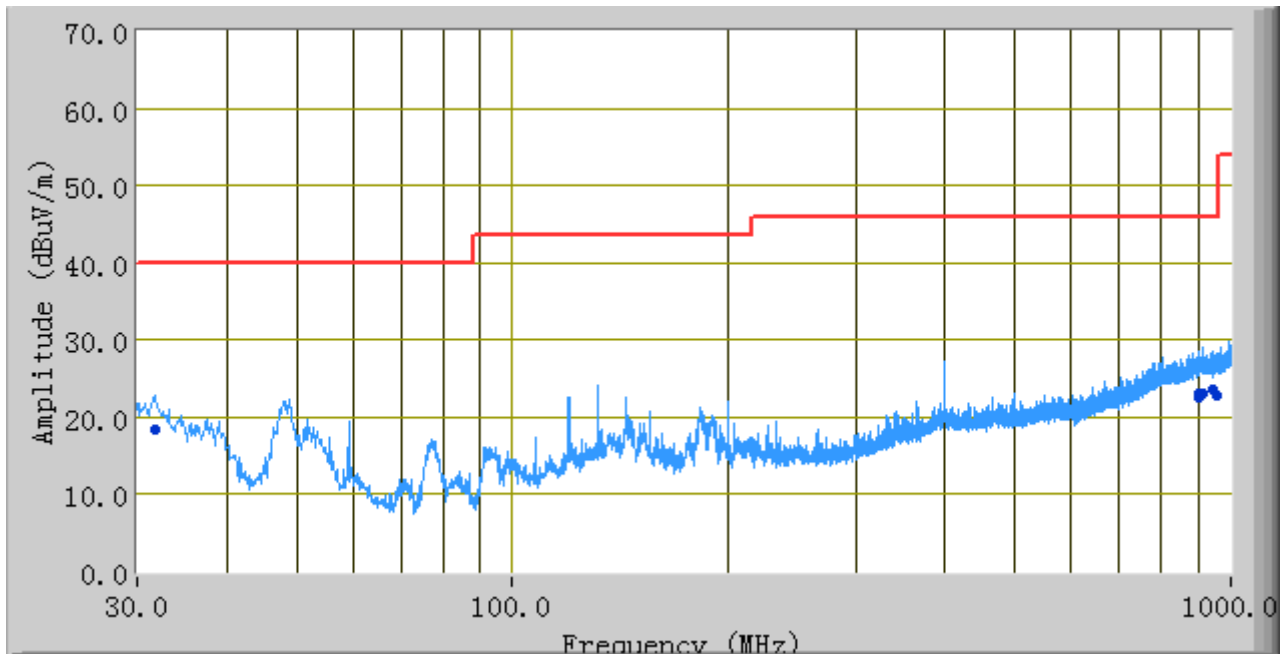

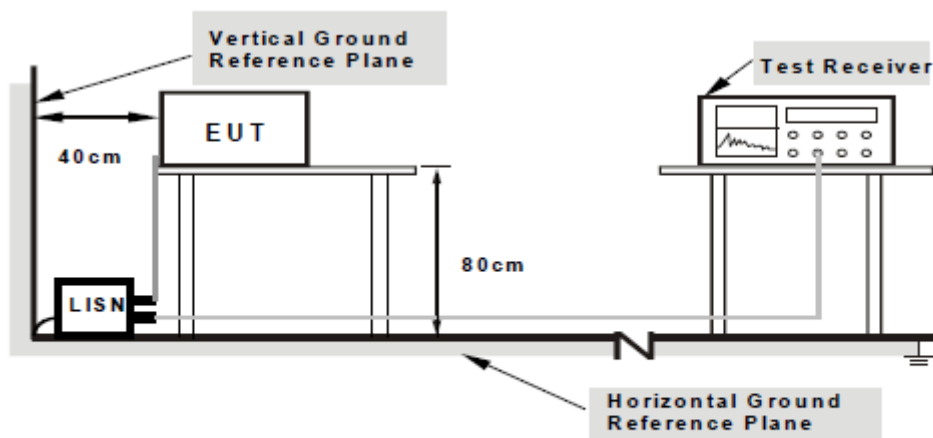

## **Annex A.ii. CONDUCTED EMISSIONS TEST DESCRIPTION**

### **Test Set-up**

1. The EUT and supporting equipment were set up in accordance with the requirements of the standard on top of a 1.5m x 1m x 0.8m high, non-metallic table, as shown in Annex B.
2. The power supply for the EUT was fed through a 50Ω/50μH EUT LISN, connected to filtered mains.
3. The RF OUT of the EUT LISN was connected to the EMI test receiver via a low-loss coaxial cable.
4. All other supporting equipments were powered separately from another main supply.



**Note: 1. Support units were connected to second LISN.  
 2. Both of LISNs (AMN) are 80cm from EUT and at least 80cm from other units and other metal planes support units.**

For the actual test configuration, please refer to the related item – Photographs of the Test Configuration1.

### **Test Method**

1. The EUT was switched on and allowed to warm up to its normal operating condition.
2. A scan was made on the NEUTRAL line (for AC mains) or Earth line (for DC power) over the required frequency range using an EMI test receiver.
3. High peaks, relative to the limit line, were then selected.
4. The EMI test receiver was then tuned to the selected frequencies and the necessary measurements made with a receiver bandwidth setting of 10 kHz. For FCC tests, only Quasi-peak measurements were made; while for CISPR/EN tests, both Quasi-peak and Average measurements were made.
5. Steps 2 to 4 were then repeated for the LIVE line (for AC mains) or DC line (for DC power).

### **Description of Conducted Emission Program**

This EMC Measurement software run LabView automation software and offers a common user interface for electromagnetic interference (EMI) measurements. This software is a modern and powerful tool for controlling and monitoring EMI test receivers and EMC test systems. It guarantees reliable collection, evaluation, and documentation of measurement results. Basically, this program will run a pre-scan measurement before it proceeds with the final measurement. The pre-scan routine will run the common scan range from 150 kHz to 30 MHz; the program will first start a peak and average scan on selectable measurement time and step size. After the program complete the pre-scan, this program will perform the Quasi Peak and Average measurement, based on the pre-scan peak data reduction result.

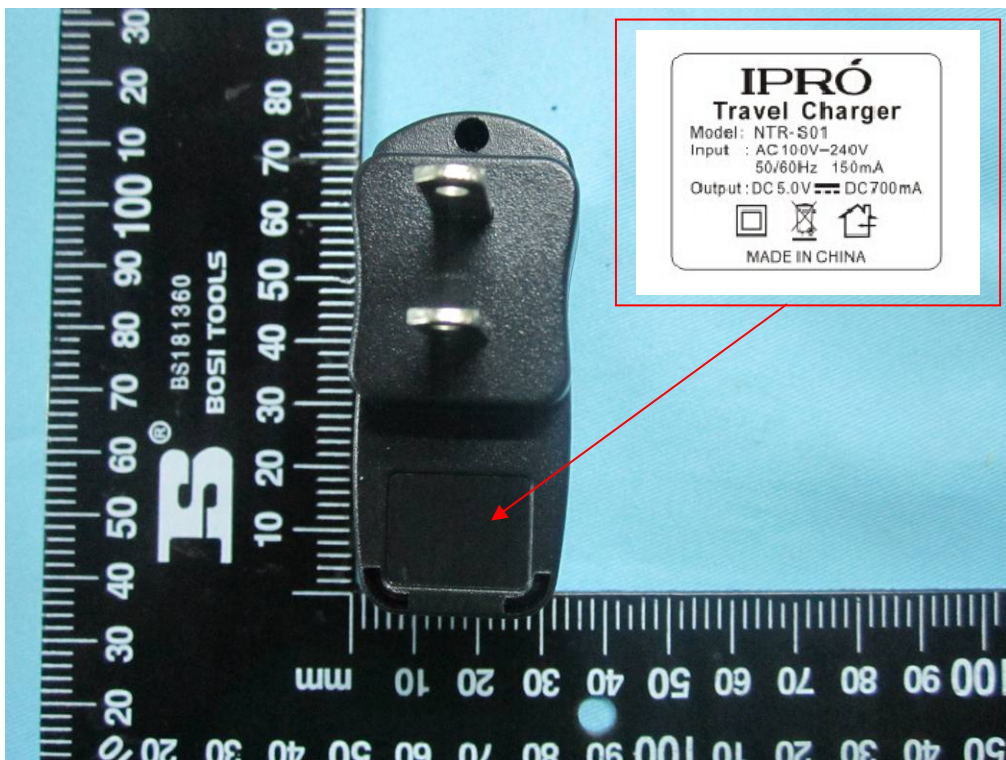

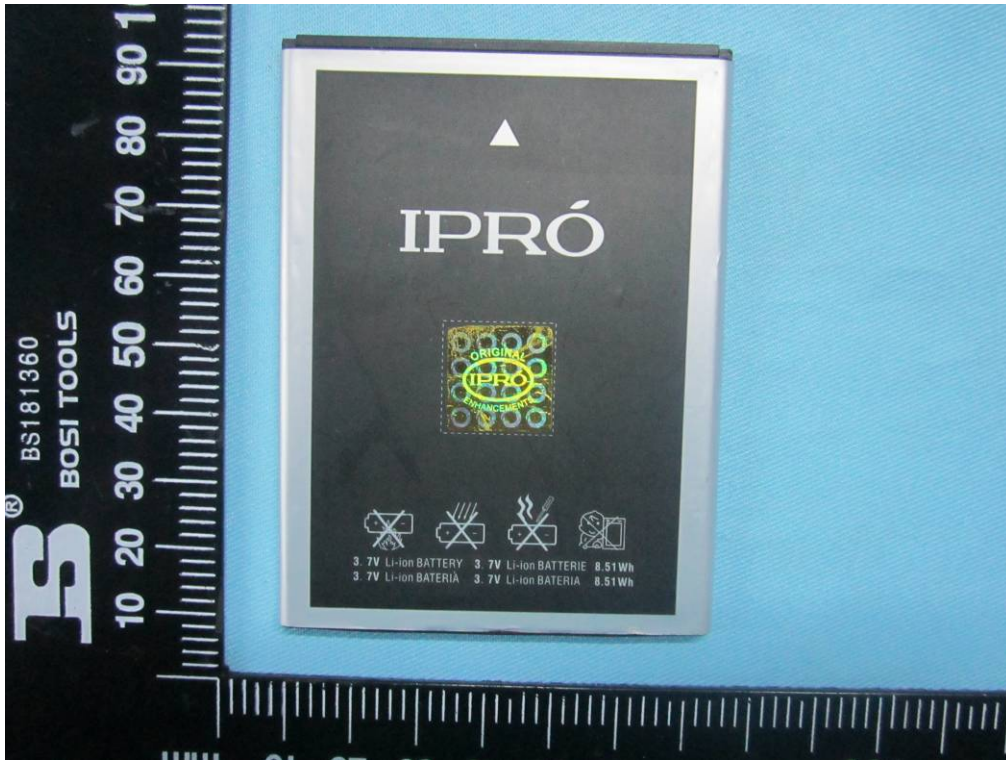

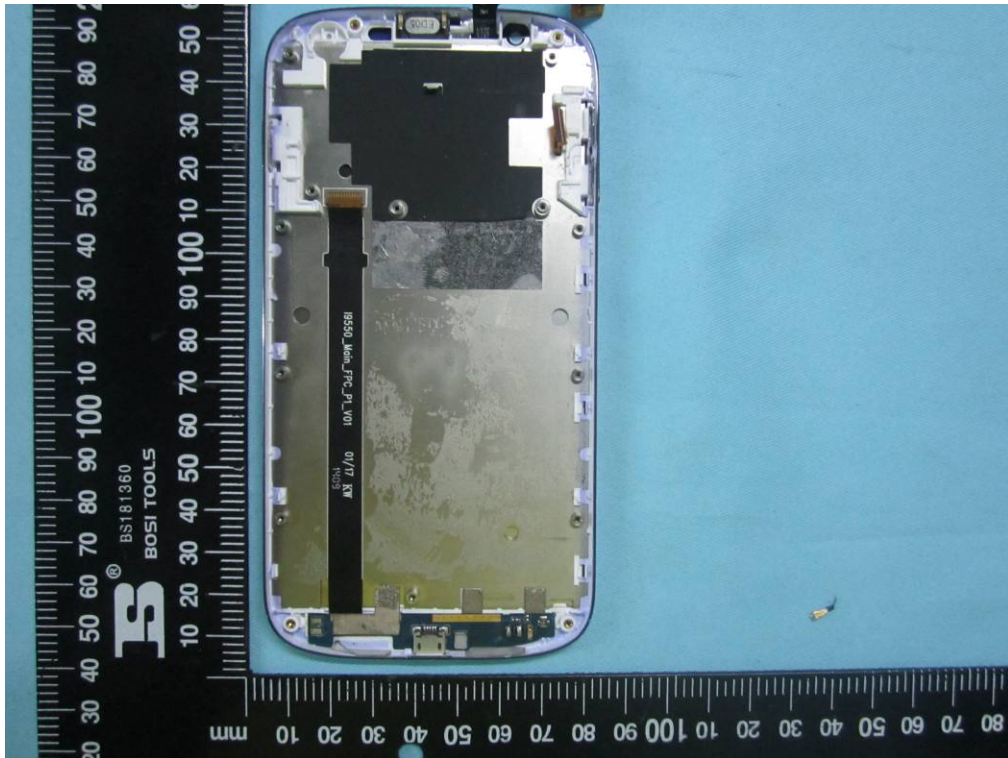

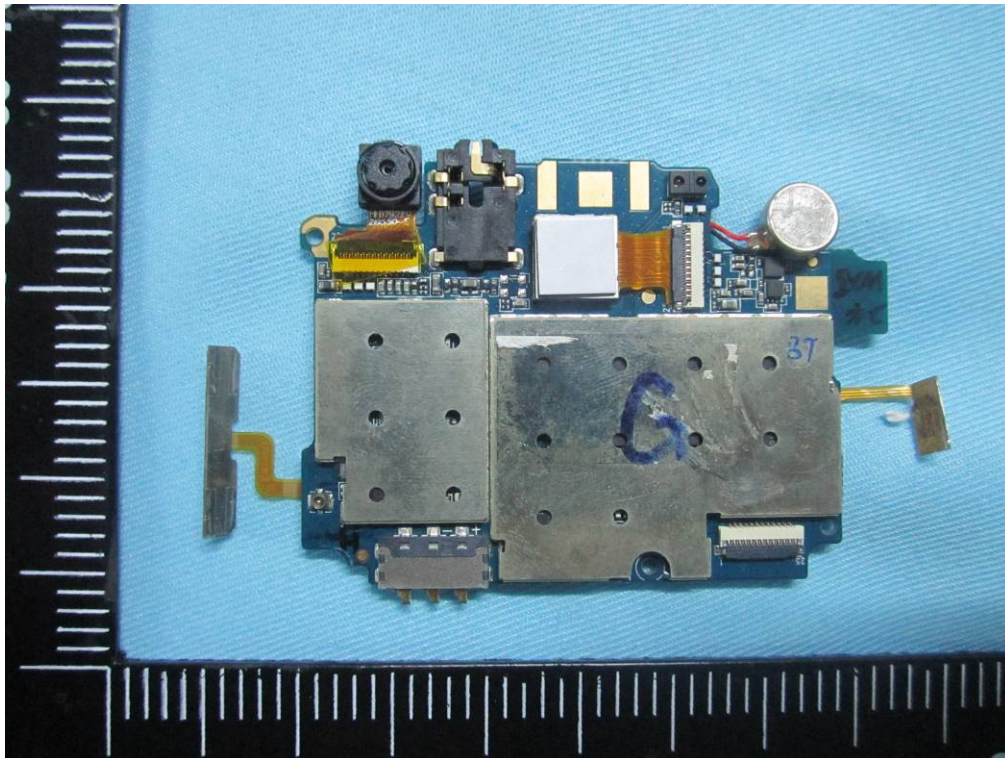

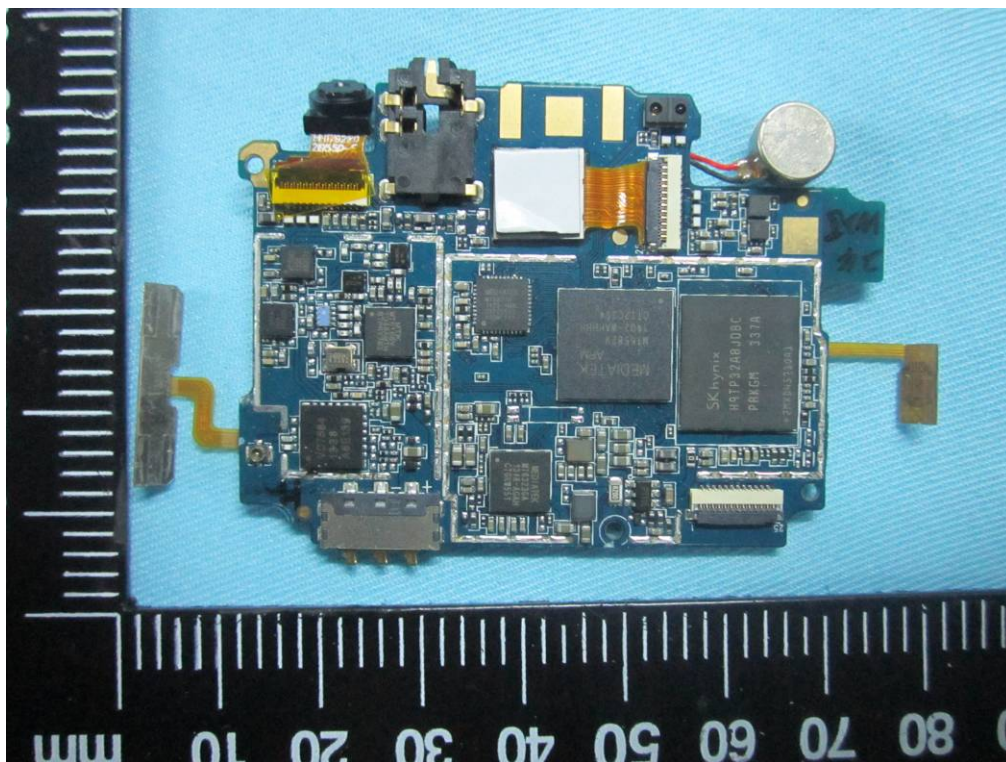

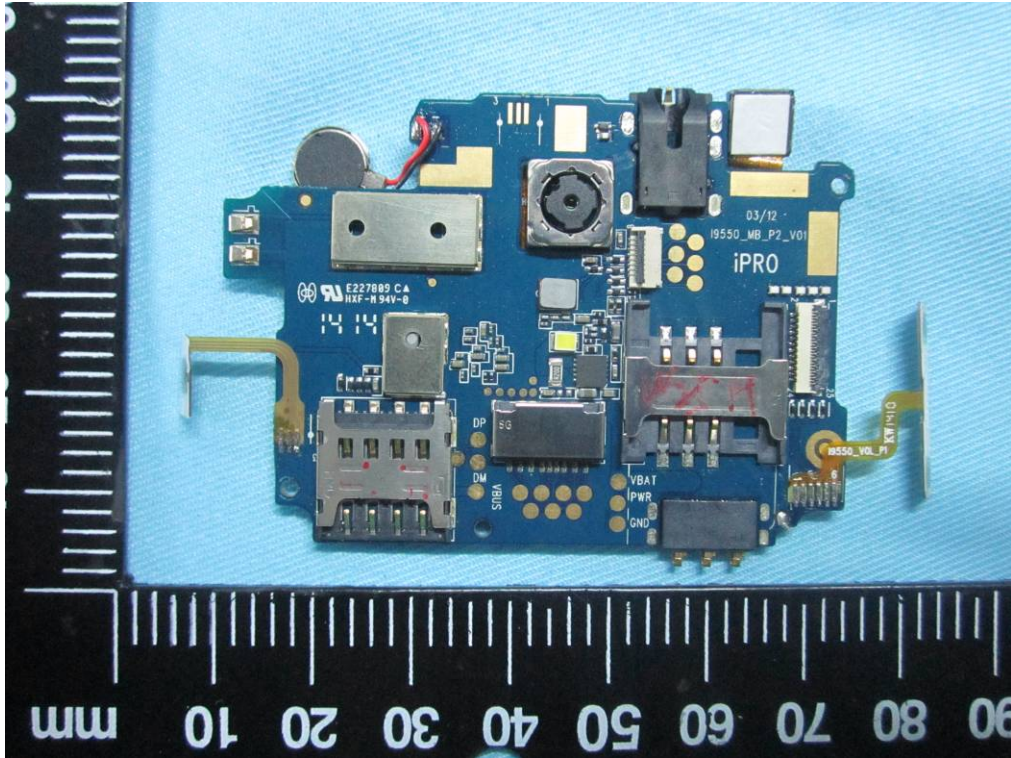

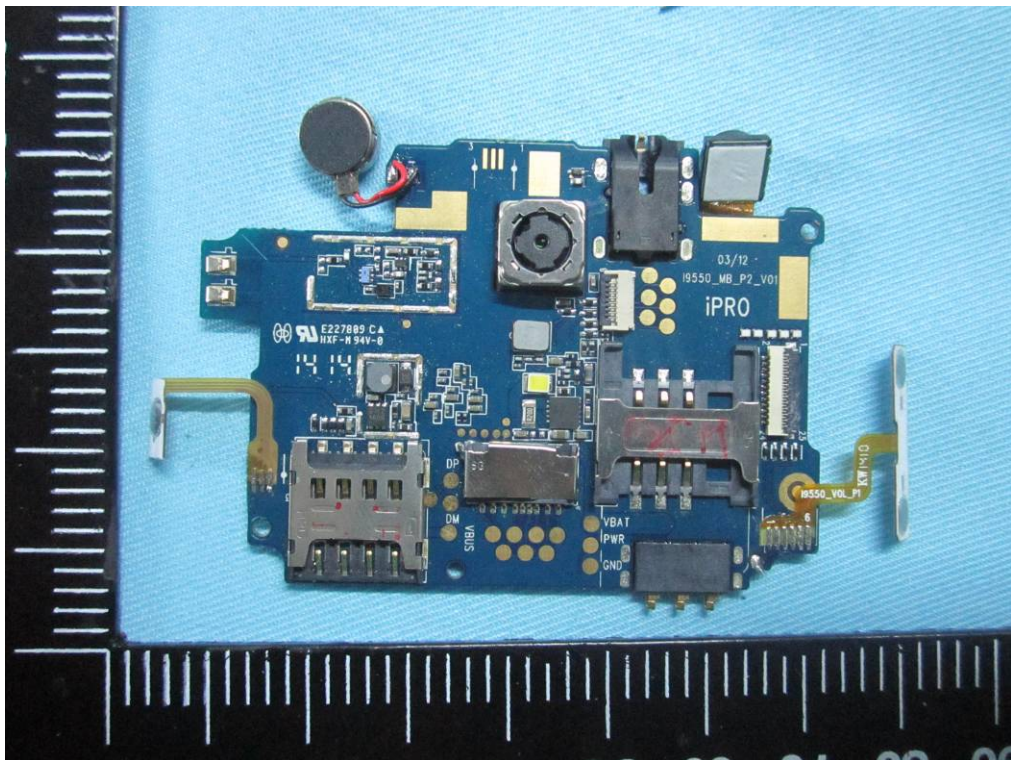

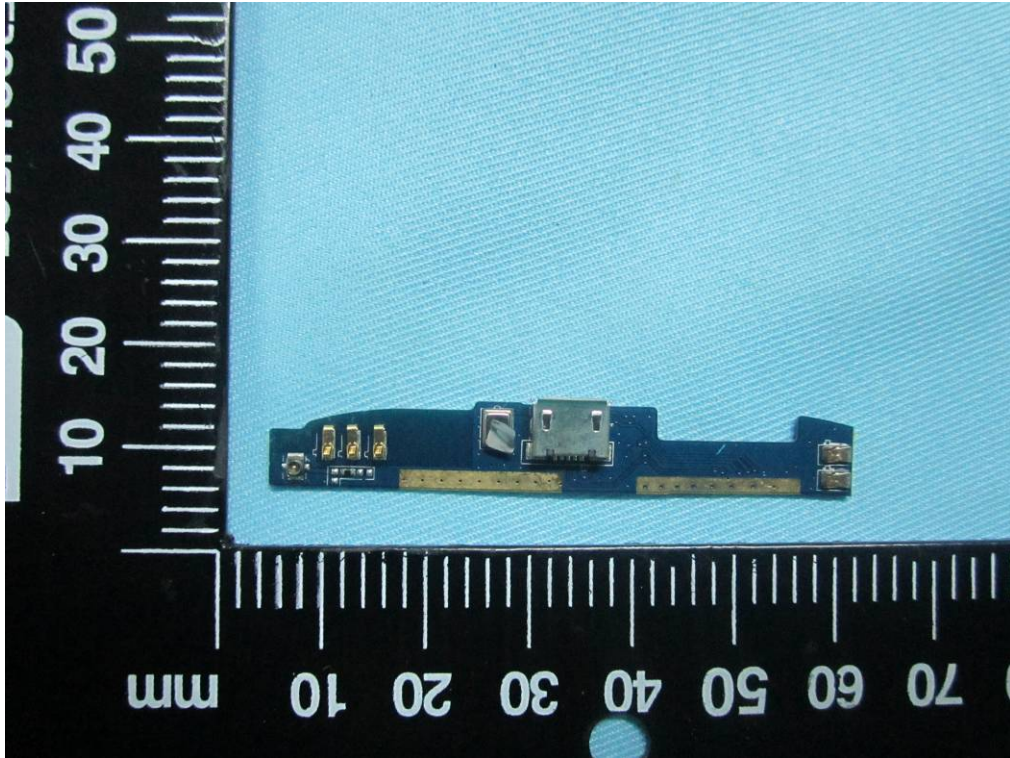

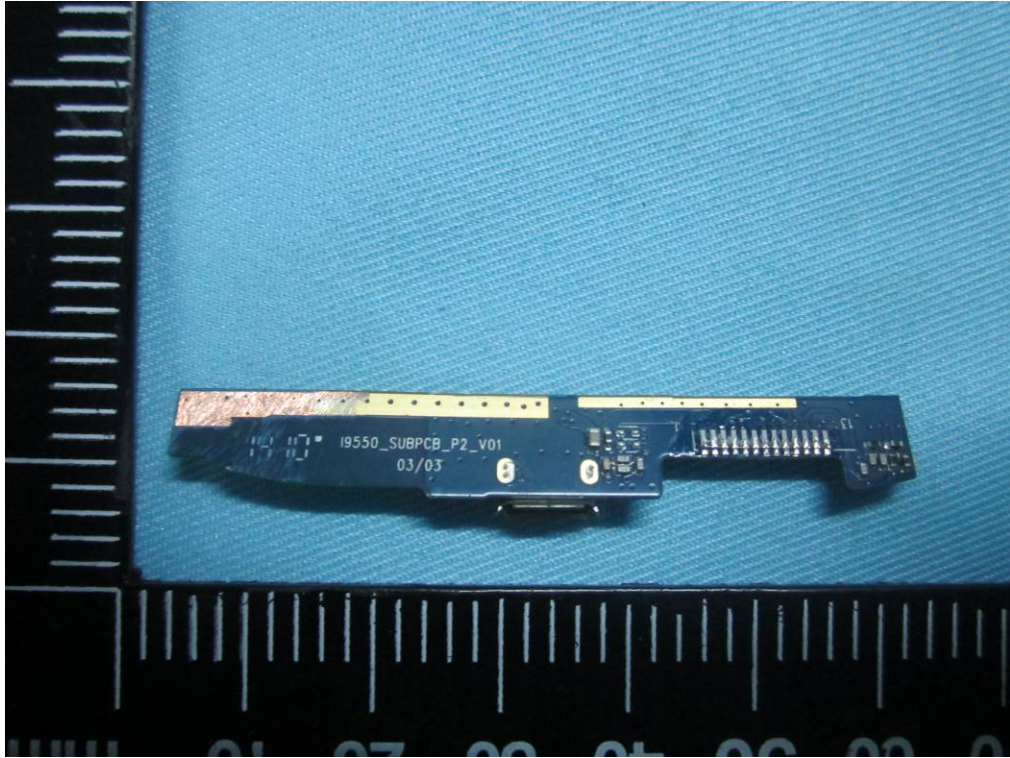

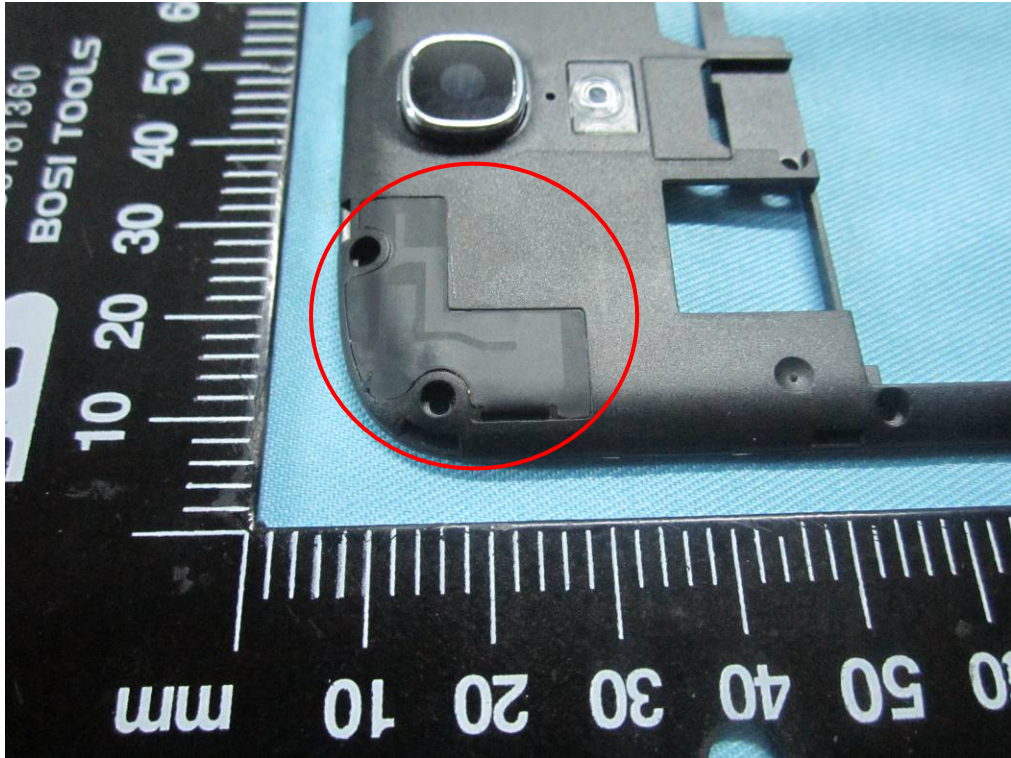

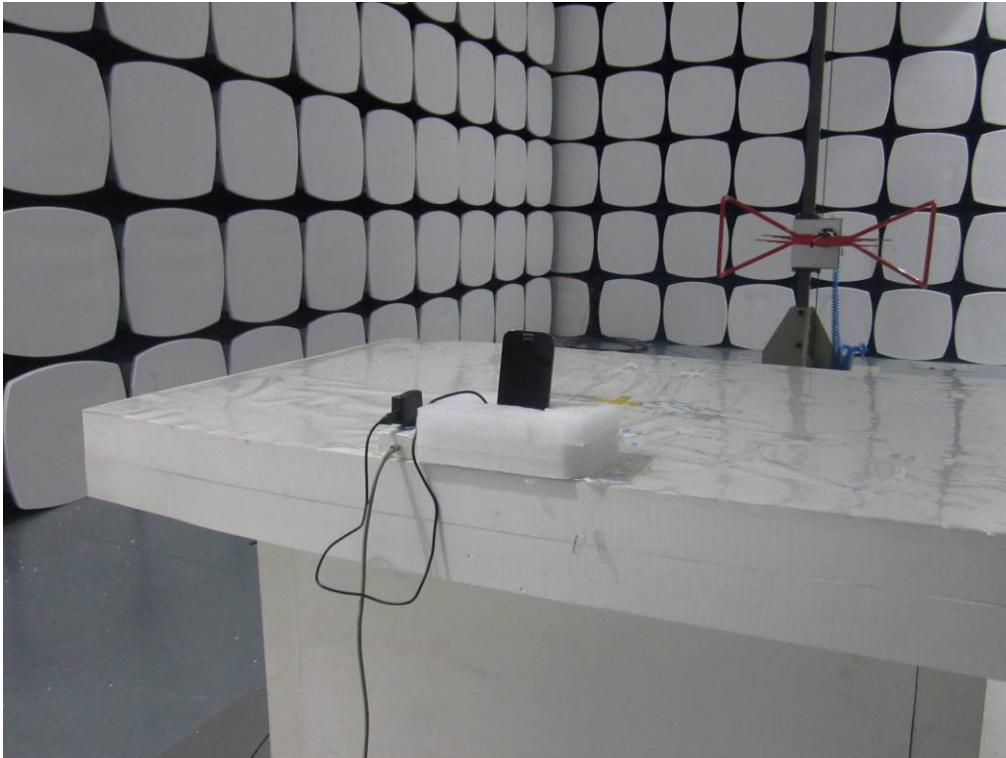

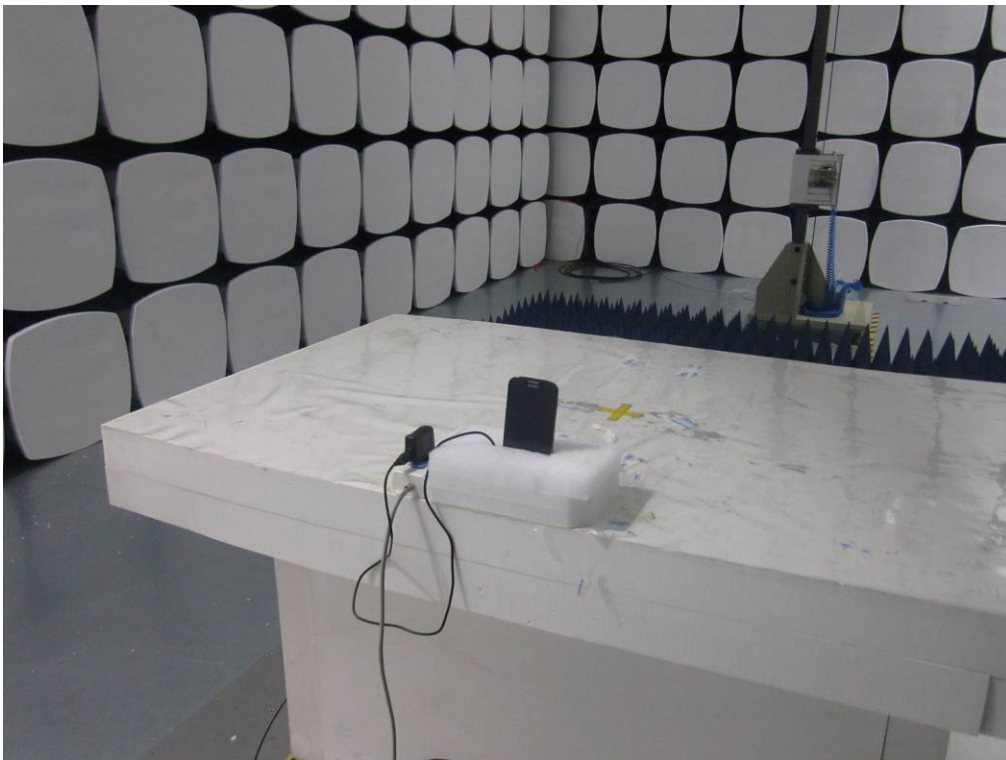

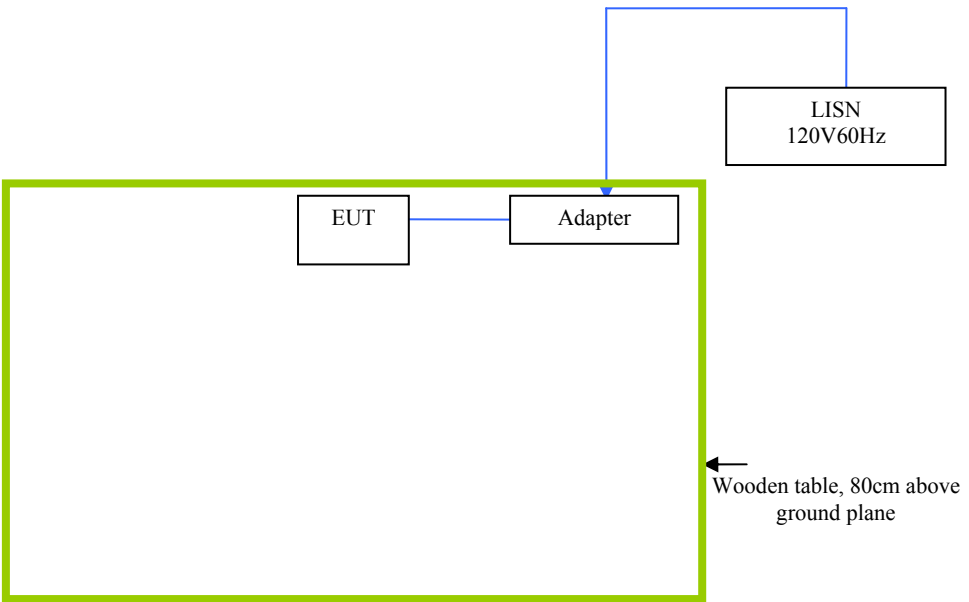

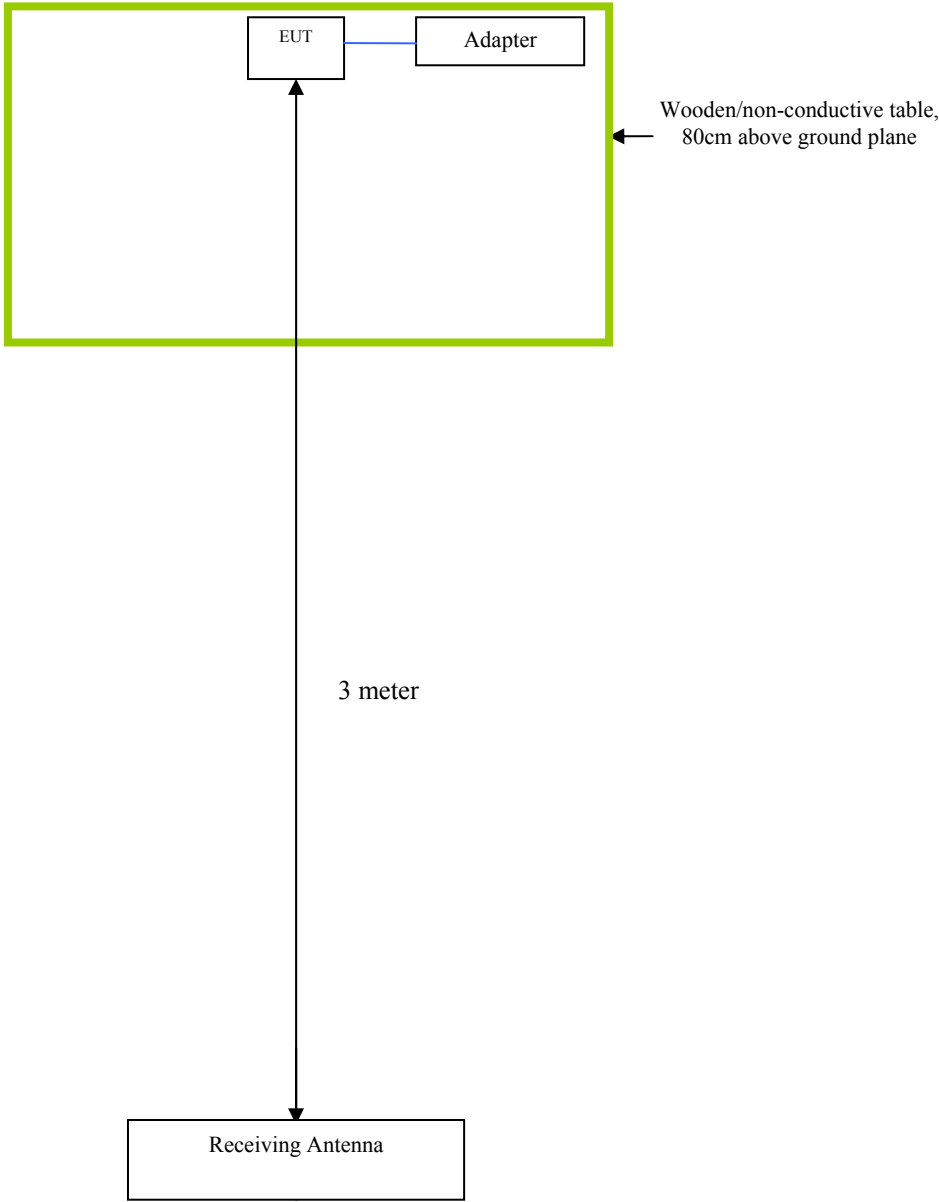
