I. Executive Summary



A. Purpose of Test

An EMC evaluation was performed to determine compliance of the Caterpillar Inc. PL671, with the requirements of Part 15, §15.407. All references are to the most current version of Title 47 of the Code of Federal Regulations in effect. In accordance with §2.1033, the following data is presented in support of the Certification of the PL671. Caterpillar Inc. should retain a copy of this document which should be kept on file for at least two years after the manufacturing of the PL671, has been **permanently** discontinued.

B. Executive Summary

The following tests were conducted on a sample of the equipment for the purpose of demonstrating compliance with Part 15, §15.407, in accordance with Caterpillar Inc., purchase order number PO9516. All tests were conducted using measurement procedure ANSI C63.4-2014.

C. Test Site

All testing was performed at MET Laboratories, Inc., 914 West Patapsco Avenue, Baltimore, MD 21230. All equipment used in making physical determinations is accurate and bears recent traceability to the National Institute of Standards and Technology.

Radiated Emissions measurements were performed in a 3 meter semi-anechoic chamber (equivalent to an Open Area Test Site). In accordance with §2.948(a)(3), a complete site description is contained at MET Laboratories.

D. Description of Test Sample

The Caterpillar Inc. PL671, Equipment Under Test (EUT), is a dedicated short range communication (DSRC) device. Units are mounted on heavy machinery on both sides of the vehicle to minimize blind spots. It is intended to provide proximity information vehicle to vehicle. A dedicated radio module in the EUT is used to do provide this link. EUT can also communicate to a stationary device or device on a smaller vehicle by Wi-Fi or BT. A GNSS module inside the EUT provides positioning information to the EUT. The two EUTs communicate with each other and the vehicle using Ethernet. An audio module in the EUT can send audible warnings in case of collision possibilities.





Figure 1. Block Diagram of Test Configuration 1.1

H. Mode of Operation

Mode 1: The DSRC module in the EUT is put in a continuous transmit mode using the test script. It will broadcast at full power till turned off.

Mode 2: The Wi-Fi module in the EUT is put into continuous transmit mode using the test script. It will broadcast at full power till turned off.

Mode 3: The GNSS module in the EUT is activated using the test script and sends out NMEA data to the CPU. It will receive and send data till turned off. The EUT must be connected to an active antenna and have a clear sky view

Mode 4: The Ethernet is used to set up the test modes. The Ethernet is set to full duplex and set to communicate with the computer in a continuous mode.

I. Method of Monitoring EUT Operation

Mode 1: The DSRC is activated for the test menu using "d". It will down load firmware to the DSRC module. A secondary menu will appear. Select "b" (TX with no GPS). Current will increase and a rolling script will appear in the terminal window continuously. Please refer to Quake document 1153-3011 for instructions.

Mode 2: The Wi-Fi is activated by opening another terminal. Use the test script to select "w". Select TX mode. A continuous script will scroll in the terminal as the module transmits.

Mode 3: Open another terminal and select "g" to activate the GNSS module. The NMEA data stream from the module will scroll continuously.

Mode 4: Open another terminal and set up a ping on the ENET. Continuous acknowledgement will be sent.










Plot 1. Maximum Conducted Output Power, BW 20M, Ch 5745M, A Mode Port 1




Plot 2. Maximum Conducted Output Power, BW 20M, Ch 5745M, A Mode Port 2




Plot 3. Maximum Conducted Output Power, BW 20M, Ch 5745M, N Mode Port 1






Plot 4. Maximum Conducted Output Power, BW 20M, Ch 5745M, N Mode Port 2




Plot 5. Maximum Conducted Output Power, BW 20M, Ch 5785M, A Mode Port 1




Plot 6. Maximum Conducted Output Power, BW 20M, Ch 5785M, A Mode Port 2






Plot 7. Maximum Conducted Output Power, BW 20M, Ch 5785M, N Mode Port 1




Plot 8. Maximum Conducted Output Power, BW 20M, Ch 5785M, N Mode Port 2




Plot 9. Maximum Conducted Output Power, BW 20M, Ch 5825M, A Mode Port 1






Plot 10. Maximum Conducted Output Power, BW 20M, Ch 5825M, A Mode Port 2




Plot 11. Maximum Conducted Output Power, BW 20M, Ch 5825M, N Mode Port 1




Plot 12. Maximum Conducted Output Power, BW 20M, Ch 5825M, N Mode Port 2






Plot 13. Maximum Conducted Output Power, BW 40M, Ch 5755M, N Mode Port 1




Plot 14. Maximum Conducted Output Power, BW 40M, Ch 5755M, N Mode Port 2








Plot 17. Power Spectral Density, BW 20M, Ch 5745M, A Mode Port 1




Plot 18. Power Spectral Density, BW 20M, Ch 5745M, A Mode Port 2






Plot 19. Power Spectral Density, BW 20M, Ch 5745M, N Mode Port 1




Plot 20. Power Spectral Density, BW 20M, Ch 5745M, N Mode Port 2




Plot 21. Power Spectral Density, BW 20M, Ch 5785M, A Mode Port 1






Plot 22. Power Spectral Density, BW 20M, Ch 5785M, A Mode Port 2




Plot 23. Power Spectral Density, BW 20M, Ch 5785M, N Mode Port 1




Plot 24. Power Spectral Density, BW 20M, Ch 5785M, N Mode Port 2






Plot 25. Power Spectral Density, BW 20M, Ch 5825M, A Mode Port 1




Plot 26. Power Spectral Density, BW 20M, Ch 5825M, A Mode Port 2




Plot 27. Power Spectral Density, BW 20M, Ch 5825M, N Mode Port 1






Plot 28. Power Spectral Density, BW 20M, Ch 5825M, N Mode Port 2




Plot 29. Power Spectral Density, BW 40M, Ch 5755M, N Mode Port 1




Plot 30. Power Spectral Density, BW 40M, Ch 5755M, N Mode Port 2

$\S15.407(b)(4) \& (6-7)$ Undesirable Emissions

Test Requirements:

§ 15.407(b)(4): For transmitters operating in the 5.725-5.85 GHz band: All emissions within the frequency range from the band edge to 10 MHz above or below the band edge shall not exceed an e.i.r.p. of -17 dBm/MHz; for frequencies 10 MHz or greater above or below the band edge, emissions shall not exceed an e.i.r.p. of -27 dBm/MHz.

§ 15.407(b)(6): Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in Section 15.209. Further, any U-NII devices using an AC power line are required to comply also with the conducted limits set forth in Section 15.207.

§ 15.407(b)(7): The provisions of Section 15.205 of this part apply to intentional radiators operating under this section.

Test Procedure:

The EUT was placed on a non-conducting stand on a turntable in a chamber. To find the maximum emission the EUT was set to transmit on low, mid, and high channels. Additionally, the turntable was rotated 360 degrees, the EUT was oriented through its three orthogonal axes, and the receive antenna height was varied in order to maximize emissions.

For frequencies from 30 MHz to 1 GHz, measurements were first made using a peak detector with a 100 kHz resolution bandwidth. Emissions which exceeded the limits were re-measured using a quasi-peak detector with a 120 kHz resolution bandwidth.

Above 1 GHz, measurements were made pursuant the method described in FCC KDB 789033 D02 General UNII Test Procedure New Rules v02r01.

For emissions above 1 GHz and in restricted bands, measurements of the field strength were made with a peak detector and an average detector and compared with the limits of 15.209.

As an alternative, according to FCC KDB 789033 D02 General UNII Test Procedure New Rules v02r01, all emissions above 1 GHz that comply with the peak and average limits of 15.209 satisfy the requirements of unwanted emissions in 15.407. Emissions were investigated upto 10th harmoincs of the fundamental.




Plot 33. Undesirable Emissions, Average Band Edge Spurious, BW 20M, Ch 5745M, A Mode Port 2




Plot 34. Undesirable Emissions, Average Band Edge Spurious, BW 20M, Ch 5745M, N Mode Port 2






Plot 35. Undesirable Emissions, Average Band Edge Spurious, BW 20M, Ch 5825M, A Mode Port 2




Plot 36. Undesirable Emissions, Average Band Edge Spurious, BW 20M, Ch 5825M, N Mode Port 2






Plot 37. Undesirable Emissions, Average Band Edge Spurious, BW 40M, Ch 5755M, N Mode Port 2




Plot 38. Undesirable Emissions, Average Band Edge Spurious, BW 40M, Ch 5795M, N Mode Port 2






Plot 39. Undesirable Emissions, Peak Band Edge Spurious, BW 20M, Ch 5745M, A Mode Port 2




Plot 40. Undesirable Emissions, Peak Band Edge Spurious, BW 20M, Ch 5745M, N Mode Port 2






Plot 41. Undesirable Emissions, Peak Band Edge Spurious, BW 20M, Ch 5825M, A Mode Port 2




Plot 42. Undesirable Emissions, Peak Band Edge Spurious, BW 20M, Ch 5825M, N Mode Port 2






Plot 43. Undesirable Emissions, Peak Band Edge Spurious, BW 40M, Ch 5755M, N Mode Port 2




Plot 44. Undesirable Emissions, Peak Band Edge Spurious, BW 40M, Ch 5795M, N Mode Port 2






Plot 45. Undesirable Emissions, Average Band Edge Spurious, BW 20M, Ch 5745M, A Mode




Plot 46. Undesirable Emissions, Average Band Edge Spurious, BW 20M, Ch 5745M, N Mode






Plot 47. Undesirable Emissions, Average Band Edge Spurious, BW 20M, Ch 5825M, A Mode




Plot 48. Undesirable Emissions, Average Band Edge Spurious, BW 20M, Ch 5825M, N Mode






Plot 49. Undesirable Emissions, Average Band Edge Spurious, BW 40M, Ch 5755M, N Mode




Plot 50. Undesirable Emissions, Average Band Edge Spurious, BW 40M, Ch 5795M, N Mode






Plot 51. Undesirable Emissions, Peak Band Edge Spurious, BW 20M, Ch 5745M, A Mode




Plot 52. Undesirable Emissions, Peak Band Edge Spurious, BW 20M, Ch 5745M, N Mode






Plot 53. Undesirable Emissions, Peak Band Edge Spurious, BW 20M, Ch 5825M, A Mode




Plot 54. Undesirable Emissions, Peak Band Edge Spurious, BW 20M, Ch 5825M, N Mode







Plot 55. Undesirable Emissions, Peak Band Edge Spurious, BW 40M, Ch 5755M, N Mode




Plot 56. Undesirable Emissions, Peak Band Edge Spurious, BW 40M, Ch 5795M, N Mode








Plot 57. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5745M, A Mode




Plot 58. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5745M, N Mode






Plot 59. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5785M, A Mode




Plot 60. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5785M, N Mode






Plot 61. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5825M, A Mode




Plot 62. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5825M, N Mode






Plot 63. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 40M, Ch 5755M, N Mode




Plot 64. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 40M, Ch 5795M, N Mode






Plot 65. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5745M, A Mode




Plot 66. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5745M, N Mode






Plot 67. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5785M, A Mode




Plot 68. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5785M, N Mode






Plot 69. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5825M, A Mode




Plot 70. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5825M, N Mode






Plot 71. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 40M, Ch 5755M, N Mode




Plot 72. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 40M, Ch 5795M, N Mode






Plot 73. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5745M, A Mode Port 2




Plot 74. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5745M, N Mode Port 2






Plot 75. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5785M, A Mode Port 2




Plot 76. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5785M, N Mode Port 2






Plot 77. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5825M, A Mode Port 2




Plot 78. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 20M, Ch 5825M, N Mode Port 2






Plot 79. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 40M, Ch 5755M, N Mode Port 2




Plot 80. Undesirable Emissions, Average Spurious Emission 1-18GHz, BW 40M, Ch 5795M, N Mode Port 2






Plot 81. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5745M, A Mode Port 2




Plot 82. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5745M, N Mode Port 2






Plot 83. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5785M, A Mode Port 2




Plot 84. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5785M, N Mode Port 2






Plot 85. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5825M, A Mode Port 2




Plot 86. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 20M, Ch 5825M, N Mode Port 2






Plot 87. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 40M, Ch 5755M, N Mode Port 2




Plot 88. Undesirable Emissions, Peak Spurious Emission 1-18GHz, BW 40M, Ch 5795M, N Mode Port 2





Plot 89. Undesirable Emissions, 30 MHz - 1 GHz 5745 MHz A Mode Port 1




Plot 90. Undesirable Emissions, 30 MHz - 1 GHz 5745 MHz A Mode Port 2




Plot 91. Undesirable Emissions, 30 MHz - 1 GHz 5745 MHz N Mode Port 1






Plot 92. Undesirable Emissions, 30 MHz - 1 GHz 5745 MHz N Mode Port 2




Plot 93. Undesirable Emissions, 30 MHz - 1 GHz 5755 MHz N Mode Port 1




Plot 94. Undesirable Emissions, 30 MHz - 1 GHz 5755 MHz N Mode Port 2






Plot 95. Undesirable Emissions, 30 MHz - 1 GHz 5785 MHz A Mode Port 1




Plot 96. Undesirable Emissions, 30 MHz - 1 GHz 5785 MHz A Mode Port 2




Plot 97. Undesirable Emissions, 30 MHz - 1 GHz 5785 MHz N Mode Port 1






Plot 98. Undesirable Emissions, 30 MHz - 1 GHz 5785 MHz N Mode Port 2




Plot 99. Undesirable Emissions, 30 MHz - 1 GHz 5795 MHz N Mode Port 1




Plot 100. Undesirable Emissions, 30 MHz - 1 GHz 5795 MHz N Mode Port 2






Plot 101. Undesirable Emissions, 30 MHz - 1 GHz 5825 MHz A Mode Port 1




Plot 102. Undesirable Emissions, 30 MHz - 1 GHz 5825 MHz A Mode Port 2




Plot 103. Undesirable Emissions, 30 MHz - 1 GHz 5825 MHz N Mode Port 1






Plot 104. Undesirable Emissions, 30 MHz - 1 GHz 5825 MHz N Mode Port 2 $\,$






Plot 105. 6 dB Occupied Bandwidth, BW 20M, Ch 5745M, A Mode Port 1




Plot 106. 6 dB Occupied Bandwidth, BW 20M, Ch 5745M, A Mode Port 2




Plot 107. 6 dB Occupied Bandwidth, BW 20M, Ch 5745M, N Mode Port 1






Plot 108. 6 dB Occupied Bandwidth, BW 20M, Ch 5745M, N Mode Port 2




Plot 109. 6 dB Occupied Bandwidth, BW 20M, Ch 5785M, A Mode Port 1




Plot 110. 6 dB Occupied Bandwidth, BW 20M, Ch 5785M, A Mode Port 2






Plot 111. 6 dB Occupied Bandwidth, BW 20M, Ch 5785M, N Mode Port 1




Plot 112. 6 dB Occupied Bandwidth, BW 20M, Ch 5785M, N Mode Port 2




Plot 113. 6 dB Occupied Bandwidth, BW 20M, Ch 5825M, A Mode Port 1






Plot 114. 6 dB Occupied Bandwidth, BW 20M, Ch 5825M, A Mode Port 2




Plot 115. 6 dB Occupied Bandwidth, BW 20M, Ch 5825M, N Mode Port 1




Plot 116. 6 dB Occupied Bandwidth, BW 20M, Ch 5825M, N Mode Port 2






Plot 117. 6 dB Occupied Bandwidth, BW 40M, Ch 5755M, N Mode Port 1




Plot 118. 6 dB Occupied Bandwidth, BW 40M, Ch 5755M, N Mode Port 2

L. Certification Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart I — Marketing of Radio frequency devices:

§ 2.801 Radio-frequency device defined.

As used in this part, a radio-frequency device is any device which in its operation is capable of Emitting radio-frequency energy by radiation, conduction, or other means. Radio-frequency devices include, but are not limited to:

- (a) The various types of radio communication transmitting devices described throughout this chapter.
- (b) The incidental, unintentional and intentional radiators defined in Part 15 of this chapter.
- (c) The industrial, scientific, and medical equipment described in Part 18 of this chapter.
- (d) Any part or component thereof which in use emits radio-frequency energy by radiation, conduction, or other means.

§ 2.803 Marketing of radio frequency devices prior to equipment authorization.

- (a) Except as provided elsewhere in this chapter, no person shall sell or lease, or offer for sale or lease (including advertising for sale or lease), or import, ship or distribute for the purpose of selling or leasing or offering for sale or lease, any radio frequency device unless:
 - (1) In the case of a device subject to certification, such device has been authorized by the Commission in accordance with the rules in this chapter and is properly identified and labeled as required by §2.925 and other relevant sections in this chapter; or
 - (2) In the case of a device that is not required to have a grant of equipment authorization issued by the Commission, but which must comply with the specified technical standards prior to use, such device also complies with all applicable administrative (including verification of the equipment or authorization under a Declaration of Conformity, where required), technical, labeling and identification requirements specified in this chapter.
- (d) Notwithstanding the provisions of paragraph (a) of this section, the offer for sale solely to business, commercial, industrial, scientific or medical users (but not an offer for sale to other parties or to end users located in a residential environment) of a radio frequency device that is in the conceptual, developmental, design or preproduction stage is permitted prior to equipment authorization or, for devices not subject to the equipment authorization requirements, prior to a determination of compliance with the applicable technical requirements provided that the prospective buyer is advised in writing at the time of the offer for sale that the equipment is subject to the FCC rules and that the equipment will comply with the appropriate rules before delivery to the buyer or to centers of distribution.



- (e)(1) Notwithstanding the provisions of paragraph (a) of this section, prior to equipment authorization or determination of compliance with the applicable technical requirements any radio frequency device may be operated, but not marketed, for the following purposes and under the following conditions:
 - (i) Compliance testing;
 - (ii) Demonstrations at a trade show provided the notice contained in paragraph (c) of this section is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iii) Demonstrations at an exhibition conducted at a business, commercial, industrial, scientific or medical location, but excluding locations in a residential environment, provided the notice contained in paragraphs (c) or (d) of this section, as appropriate, is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iv) Evaluation of product performance and determination of customer acceptability, provided such operation takes place at the manufacturer's facilities during developmental, design or pre-production states; or
 - (v) Evaluation of product performance and determination of customer acceptability where customer acceptability of a radio frequency device cannot be determined at the manufacturer's facilities because of size or unique capability of the device, provided the device is operated at a business, commercial, industrial, scientific or medical user's site, but not at a residential site, during the development, design or pre-production stages.
- (e)(2) For the purpose of paragraphs (e)(1)(iv) and (e)(1)(v) of this section, the term *manufacturer's facilities* includes the facilities of the party responsible for compliance with the regulations and the manufacturer's premises, as well as the facilities of other entities working under the authorization of the responsible party in connection with the development and manufacture, but not the marketing, of the equipment.
- (f) For radio frequency devices subject to verification and sold solely to business, commercial, industrial, scientific and medical users (excluding products sold to other parties or for operation in a residential environment), parties responsible for verification of the devices shall have the option of ensuring compliance with the applicable technical specifications of this chapter at each end user's location after installation, provided that the purchase or lease agreement includes a proviso that such a determination of compliance be made and is the responsibility of the party responsible for verification of the equipment.



The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart J — Equipment Authorization Procedures:

§ 2.901 Basis and Purpose

- (a) In order to carry out its responsibilities under the Communications Act and the various treaties and international regulations, and in order to promote efficient use of the radio spectrum, the Commission has developed technical standards for radio frequency equipment and parts or components thereof. The technical standards applicable to individual types of equipment are found in that part of the rules governing the service wherein the equipment is to be operated. In addition to the technical standards provided, the rules governing the service may require that such equipment be verified by the manufacturer or importer, be authorized under a Declaration of Conformity, or receive an equipment authorization from the Commission by one of the following procedures: certification or registration.
- (b) The following sections describe the verification procedure, the procedure for a Declaration of Conformity, and the procedures to be followed in obtaining certification from the Commission and the conditions attendant to such a grant.

§ 2.907 Certification.

(a) Certification is an equipment authorization issued by the Commission, based on representation and test data submitted by the applicant.

(b) Certification attaches to all units subsequently marketed by the grantee which are identical (see Section 2.908) to the sample tested except for permissive changes or other variations authorized by the Commission pursuant to Section 2.1043.

¹ In this case, the equipment is subject to the rules of Part 15. More specifically, the equipment falls under Subpart B (of Part 15), which deals with unintentional radiators.



§ 2.948 Description of measurement facilities.

- (a) Each party making measurements of equipment that is subject to an equipment authorization under Part 15 or Part 18 of this chapter, regardless of whether the measurements are filed with the Commission or kept on file by the party responsible for compliance of equipment marketed within the U.S. or its possessions, shall compile a description of the measurement facilities employed.
 - (1) If the measured equipment is subject to the verification procedure, the description of the measurement facilities shall be retained by the party responsible for verification of the equipment.
 - (i) If the equipment is verified through measurements performed by an independent laboratory, it is acceptable for the party responsible for verification of the equipment to rely upon the description of the measurement facilities retained by or placed on file with the Commission by that laboratory. In this situation, the party responsible for the verification of the equipment is not required to retain a duplicate copy of the description of the measurement facilities.
 - (ii) If the equipment is verified based on measurements performed at the installation site of the equipment, no specific site calibration data is required. It is acceptable to retain the description of the measurement facilities at the site at which the measurements were performed.
 - (2) If the equipment is to be authorized by the Commission under the certification procedure, the description of the measurement facilities shall be filed with the Commission's Laboratory in Columbia, Maryland. The data describing the measurement facilities need only be filed once but must be updated as changes are made to the measurement facilities or as otherwise described in this section. At least every three years, the organization responsible for filing the data with the Commission shall certify that the data on file is current.



Label and User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart A — General:

§ 15.19 Labeling requirements.

- (a) In addition to the requirements in Part 2 of this chapter, a device subject to certification or verification shall be labeled as follows:
 - (1) Receivers associated with the operation of a licensed radio service, e.g., FM broadcast under Part 73 of this chapter, land mobile operation under Part 90, etc., shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the condition that this device does not cause harmful interference.

(2) A stand-alone cable input selector switch, shall bear the following statement in a conspicuous location on the device:

This device is verified to comply with Part 15 of the FCC Rules for use with cable television service.

(3) All other devices shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

- (4) Where a device is constructed in two or more sections connected by wires and marketed together, the statement specified under paragraph (a) of this section is required to be affixed only to the main control unit.
- (5) When the device is so small or for such use that it is not practicable to place the statement specified under paragraph (a) of this section on it, the information required by this paragraph shall be placed in a prominent location in the instruction manual or pamphlet supplied to the user or, alternatively, shall be placed on the container in which the device is marketed. However, the FCC identifier or the unique identifier, as appropriate, must be displayed on the device.

§ 15.21 Information to user.

The users manual or instruction manual for an intentional or unintentional radiator shall caution the user that changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.



The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart B — Unintentional Radiators:

§ 15.105 Information to the user.

(a) For a Class A digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class A digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a commercial environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. Operation of this equipment in a residential area is likely to cause harmful interference in which case the user will be required to correct the interference at own expense.

(b) For a Class B digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a residential environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. If this equipment does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

- Reorient or relocate the receiving antenna.
- Increase the separation between the equipment and receiver.
- Connect the equipment into an outlet on a circuit different from that to which the receiver is connected.
- Consult the dealer or an experienced radio/TV technician for help.
