1.0 **General Description**

1.1 Product Description

The Equipment Under Test (EUT) is a 2.4GHz Transceiver (Helicopter Unit) for a RC helicopter operating at 2412 – 2469MHz with 1 MHz channel spacing. The EUT is powered by 1 X3.7V rechargeable battery (Li-Poly). After switch on the EUT and paired with controller, the EUT can be controlled to fly forward, backward, turning left and right direction by the corresponding controller. To charge the internal battery in the helicopter, either plug the charging connector from the controller into the charging jack on the helicopter for starting the charge process or using USB charging cable for charging via PC.

The Model: 6018687, 6020182 and 6021264 are the same as the Model: 44438RX in hardware aspect. The difference is in model number only.

Antenna Type: Internal, Integral

1.2 Related Submittal(s) Grants

The Certification procedure of transceiver for this transmitter (with FCC ID: PQN44438TX2G4) is being processed as the same time of this application.

1.3 Test Methodology

Radiated emission measurement was performed according to the procedures in ANSI C63.4 (2009). All radiated measurements were performed in an Open Area Test Site. Preliminary scans were performed in the Open Area Test Site only to determine worst case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application.

1.4 Test Facility

The open area test site and conducted measurement facility used to collect the radiated data is located at Garment Centre, 576 Castle Peak Road, Kowloon, Hong Kong. This test facility and site measurement data have been placed on file with the FCC.

2.0 **System Test Configuration**

2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.4 (2009).

The device was powered by 1 x 3.7V Lithium Rechargeable Battery Pack.

For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. This step by step procedure for maximizing emissions led to the data reported in Exhibit 3.0.

The unit was operated standalone and placed in the center of the turntable.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was mounted to a plastic stand if necessary and placed on the wooden turntable, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

2.2 EUT Exercising Software

There was no special software to exercise the device. Once the unit is powered up, it transmits the RF signal continuously.

2.3 Special Accessories

There are no special accessories necessary for compliance of this product.

2.4 Equipment Modification

Any modifications installed previous to testing by Spin Master Toys Far East Ltd. will be incorporated in each production model sold/leased in the United States.

No modifications were installed by Intertek Testing Services Hong Kong Ltd.

2.5 Measurement Uncertainty

When determining of the test conclusion, the Measurement Uncertainty of test has been considered.

3.0 **Emission Results**

Data is included of the worst case configuration (the configuration which resulted in the highest emission levels). A sample calculation, configuration photographs and data tables of the emissions are included.

3.1 Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any), Average Factor (optional) from the measured reading. The basic equation with a sample calculation is as follows:

FS = RA + AF + CF - AG - AV

where $FS = Field Strength in dB\mu V/m$

RA = Receiver Amplitude (including preamplifier) in dBµV

CF = Cable Attenuation Factor in dB

AF = Antenna Factor in dB AG = Amplifier Gain in dB AV = Average Factor in dB

In the following table(s), the reading shown on the data table reflects the preamplifier gain. An example for the calculations in the following table is as follows:

FS = RR + LF

where $FS = Field Strength in dB\mu V/m$

 $RR = RA - AG - AV \text{ in } dB\mu V$

LF = CF + AF in dB

Assume a receiver reading of 52.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB are added. The amplifier gain of 29 dB and average factor of 5 dB are subtracted, giving a field strength of 27 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

 $RA = 52.0 dB\mu V/m$

AF = 7.4 dB RR = 18.0 dB μ V

CF = 1.6 dB LF = 9.0 dB

AG = 29.0 dB AV = 5.0 dB FS = RR + LF

 $FS = 18 + 9 = 27 \, dB\mu V/m$

Level in μ V/m = Common Antilogarithm [(27 dB μ V/m)/20] = 22.4 μ V/m

3.2 Radiated Emission Configuration Photograph

8.0 **Miscellaneous Information**

The miscellaneous information includes details of the test procedure.

8.1 Measured Bandwidth

From the following plots, they show that the fundamental emissions are confined in the specified band 2400MHz to 2483.5MHz. In case of the fundamental emissions are within two standard bandwidths from the bandedge, the delta measurement technique is used for determining bandedge compliance. Standard bandwidth is the bandwidth specified by ANSI C63.4 (2009) for frequency being measured.

Emissions radiated outside of the specified frequency bands, except harmonics, are attenuated by 50dB below the level of the fundamental or to the general radiated emissions limits in Section 15.209, whichever is the lesser attenuation, which meet the requirement of part 15.249(d).

Peak Measurement

Bandedge compliance is determined by applying marker-delta method, i.e. (Bandedge Plot).

Lower bandedge

Peak Resultant field strength = Fundamental emissions (peak value) – delta from the plot

= 89.4 dBuV/m - 36.0 dB

 $= 53.4 dB\mu V/m$

Upper bandedge

Peak Resultant field strength = Fundamental emissions (peak value) – delta from the plot

 $= 89.3 dB\mu V/m - 38.4 dB$

 $= 50.9 \, dB \mu V/m$

The resultant field strength meets the general radiated emission limit in section 15.209, which does not exceed 74 dB μ V/m (Peak Limit) and 54 dB μ V/m (Average Limit).

8.2 Discussion of Pulse Desensitization

Pulse desensitivity is not applicable for this device. Since the transmitter transmits the RF signal continuously.

8.3 Calculation of Average Factor

The average factor is not applicable for this device as the transmitted signal is a continuously signal.

8.4 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services Hong Kong Ltd. in the measurements of transmitter operating under the Part 15, Subpart C rules.

The transmitting equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately one meter in height above the ground plane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjusted through all three orthogonal axis to obtain maximum emission levels. The antenna height and polarization are also varied during the testing to search for maximum signal levels. The height of the antenna is varied from one to four meters.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings. A detailed description for the calculation of the average factor can be found in Exhibit 8.3.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower.

8.4 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements were made as described in ANSI C63.4 (2009).

The IF bandwidth used for measurement of radiated signal strength was 100 kHz or greater when frequency is below 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. A discussion of whether pulse desensitivity is applicable to this unit is included in this report (See Exhibit 8.1). Above 1000 MHz, a resolution bandwidth of 1 MHz is used.

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the forbidden bands and above 1 GHz, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, unless otherwise reported. Measurements taken at a closer distance are so marked.
