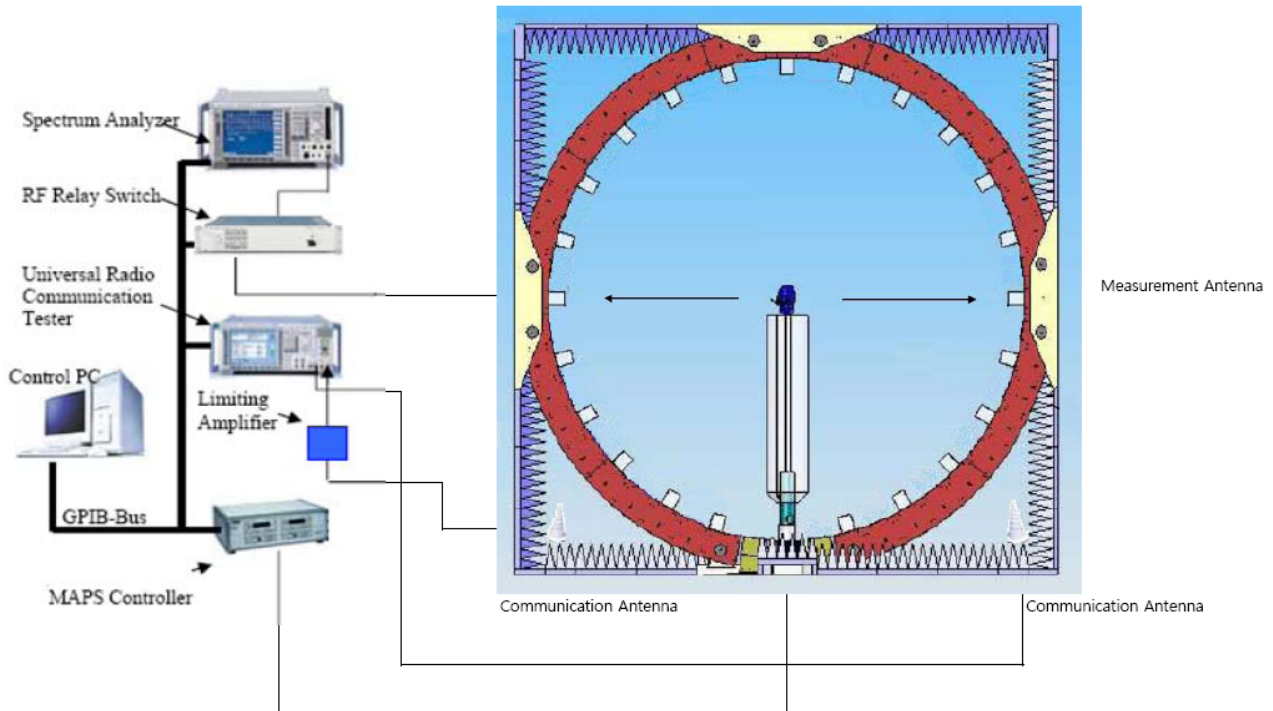

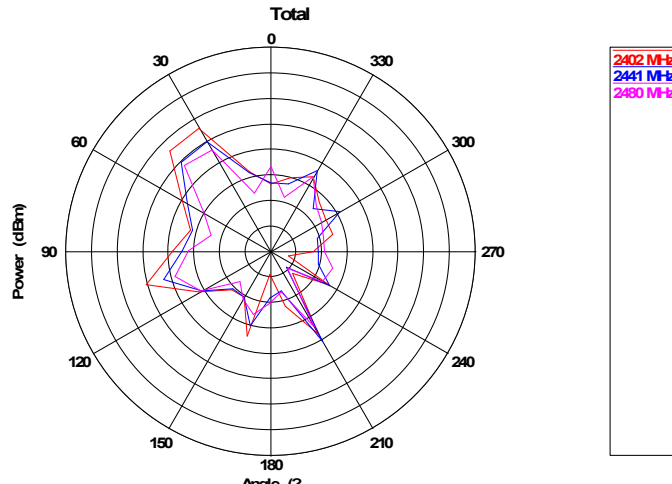
## 7 2-D Antenna Pattern(Theta=90°)
