SYSTEM TEST CONFIGURATION

2.1 **EUT Configuration**

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 **EUT Exercise**

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

2.3 **Test Procedure**

2.3.1 **Conducted Emissions**

The EUT is a placed on a table which is 0.8 m above ground plane. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz. The CISPR Quasi-Peak and Average detector mode is employed according to §15.207. The two LISNs provide 50uH/50 ohm of coupling impedance for the measuring instrument. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.

2.3.2 Conducted Test (RF)

The active antenna port of the unlicensed wireless device is connected to the spectrum analyzer with attenuator to protect the instrumentation. If a second antenna port is available, it is tested at one operating frequency, with other port(s) appropriately terminated, to verify it has similar output characteristics as the fully tested port.

2.3.3 Radiated Emissions

The EUT is a placed on a turn table. For emissions testing at or below 1 GHz, the table height shall be 0.8 m above the reference ground plane. For emission measurements above 1 GHz, the table height shall be 1.5 m. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.

Measurement Results Explanation Example

2.4.1 Radiated Emission Test Sites For Measurements From 9 kHz To 30 MHz

Radiated emission below 30MHz is measured in a 9m*6m*6m semi-anechoic chamber, the measurements correspond to those obtained at an open-field test site.

There is a comparison data of both open-field test site and semi-Anechoic chamber, and the result came out very similar.

2.4.2 For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuation factor between EUT conducted port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly EUT RF output level.



9.3.2 Radiated Emission Test Set-Up, Frequency From 30MHz to 1000MHz.





Intentional radiators operating under the alternative provisions to the general emis-(c) sion limits, as contained in §§ 15.217 through 15.257 and in subpart E of this part, must be designed to ensure that the 20 dB bandwidth of the emission, or whatever bandwidth may otherwise be specified in the specific rule section under which the equipment operates, is contained within the frequency band designated in the rule section under which the equipment is operated. In the case of intentional radiators operating under the provisions of subpart E, the emission bandwidth may span across multiple contiguous frequency bands identified in that subpart. The requirement to contain the designated bandwidth of the emission within the specified frequency band includes the effects from frequency sweeping, frequency hopping and other modulation techniques that may be employed as well as the frequency stability of the transmitter over expected variations in temperature and supply voltage. 





11 ANTENNA REQUIREMENT

Standard Applicable:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §§ 15.211, 15.213, 15.217, 15.219, 15.221, or § 15.236. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with § 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.
