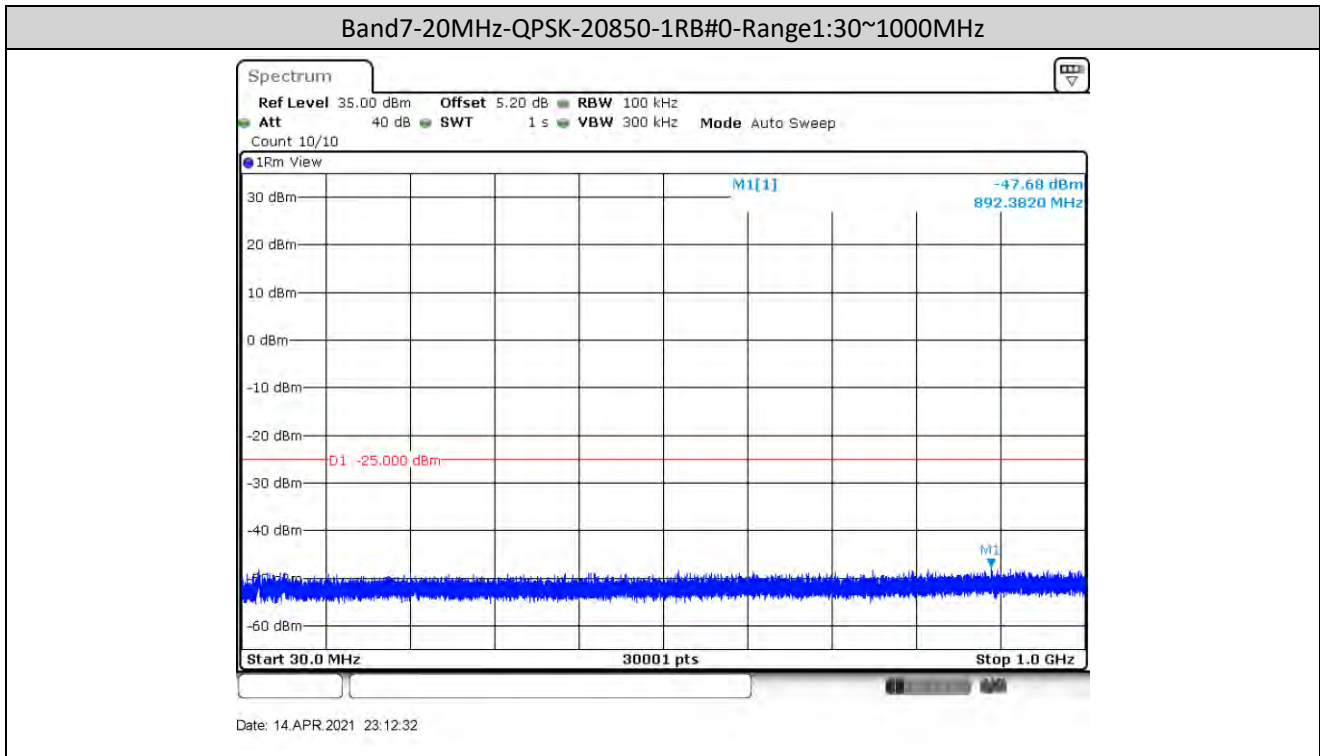
6. Spurious Emission at Antenna Terminal
