Maximum peak conducted output power_11B_2412_Ant1



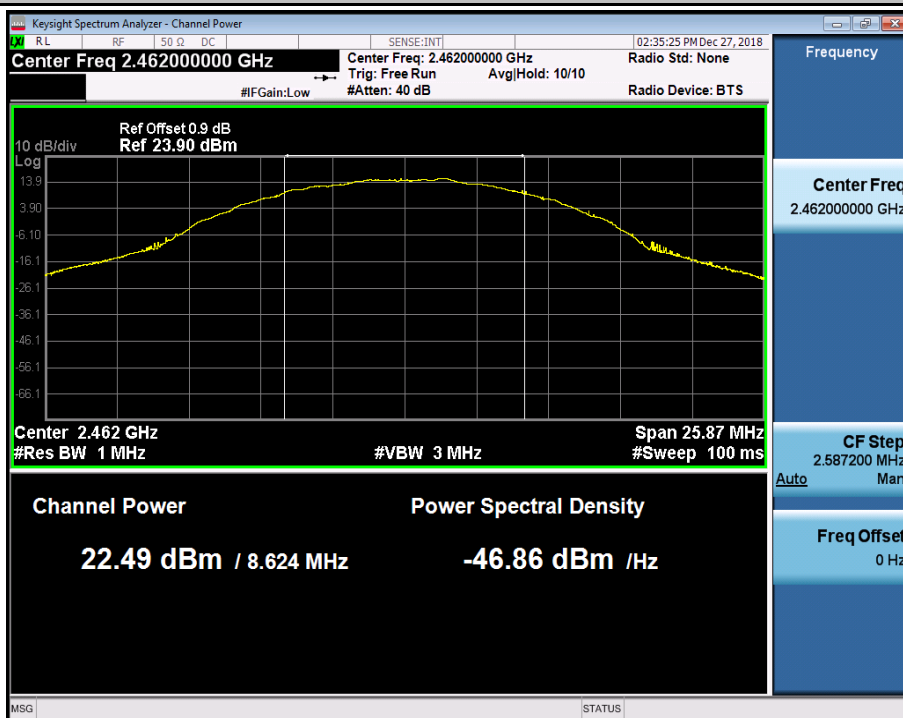

Maximum Peak power spectral density_11B_2412_Ant1



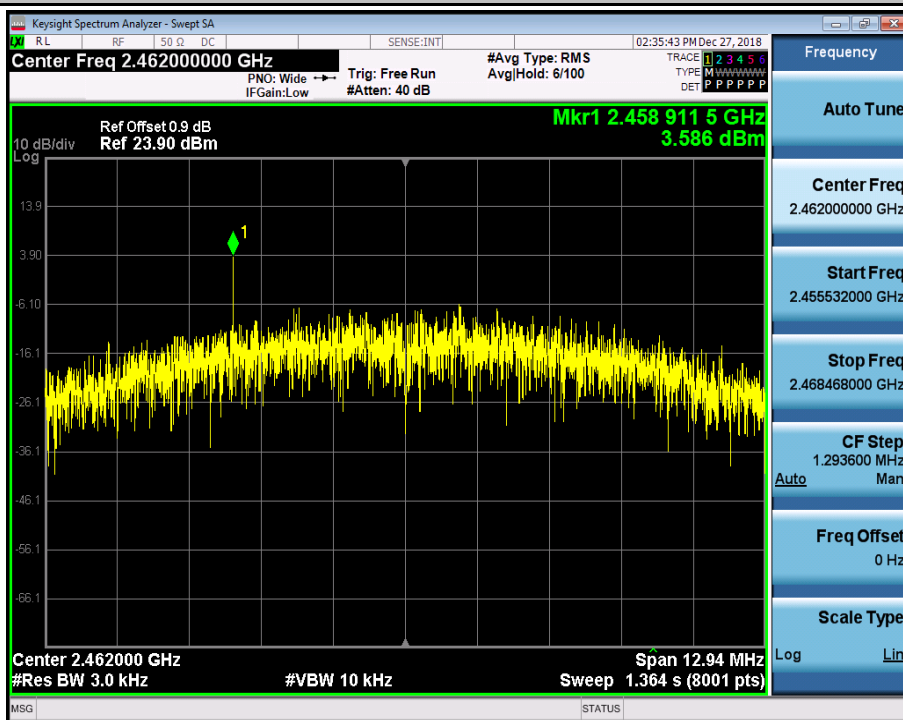

Maximum Peak power spectral density_11N20SISO_2412_Ant1



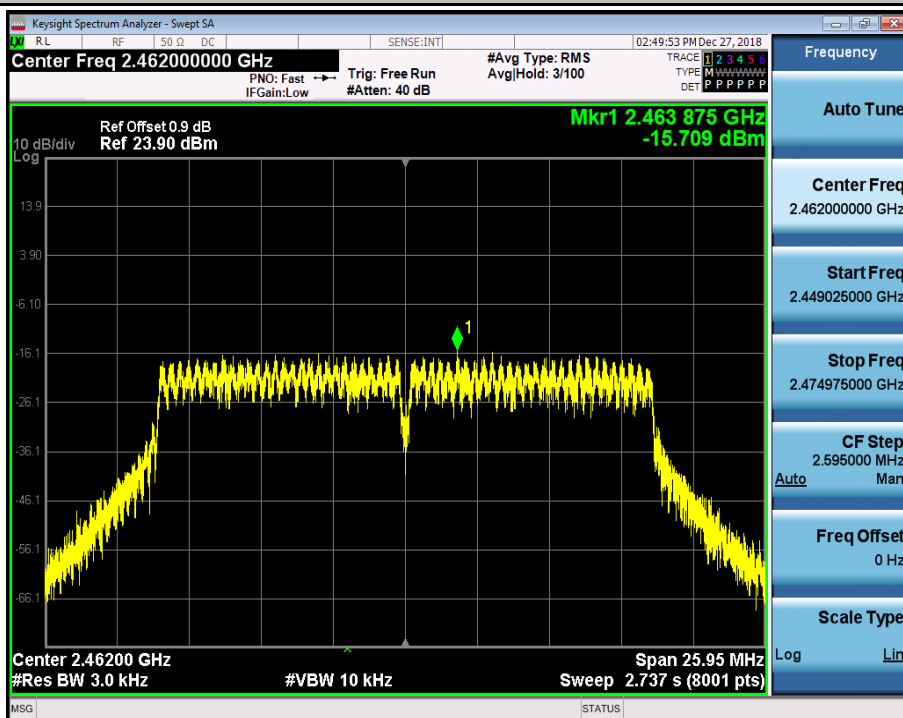

Band-edge for RF Conducted Emissions_11B_2412_Ant1



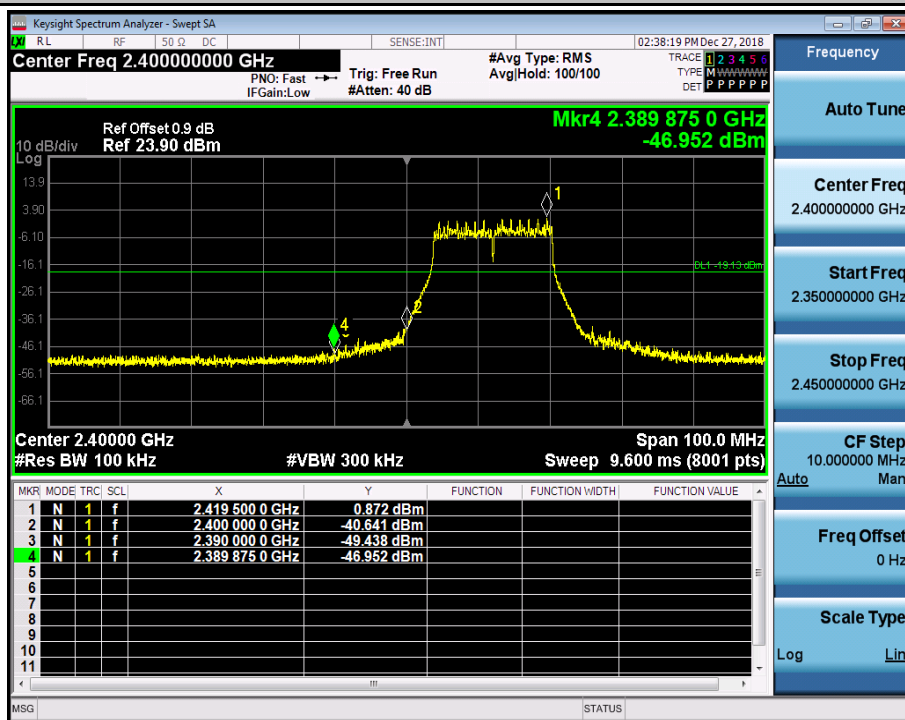
