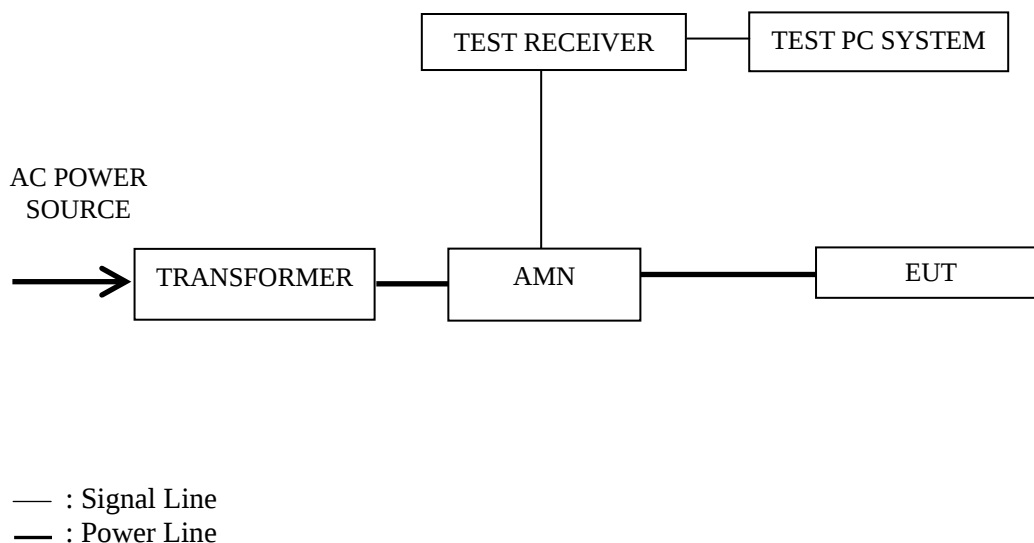

3.4 Test Configuration

The EUT (listed in Sec.2.1) was installed as shown on Sec.3.2 to meet FCC requirement and operating in a manner which tends to maximize its emission level in a normal application.

3.5 Operating Condition of EUT

3.5.1 Setup the EUT as shown in Sec. 3.2.

3.5.2 Turn on the power of all equipment.

3.5.3 Turn the EUT on the test mode, and then test.

3.6 Test Procedures

The EUT was placed upon a non-metallic table, which is 0.8 m above the horizontal conducting ground plane and 0.4 m from a vertical reference plane. The EUT was connected to the power mains through an Artificial Mains Network (AMN) to provide a 50 Ω coupling impedance for the measuring equipment. Both sides of AC line (Line & Neutral) were checked to find out the maximum conducted emission according to FCC Part 15 Subpart C and ANSI C63.10: 2013 requirements during conducted disturbance test.

The I.F. bandwidth of Test Receiver ESCI was set at 9 kHz.

The frequency range from 150 kHz to 30 MHz was checked.

Test with a dummy load in lieu of the antenna to determine compliance with Section 15.207 limits within the transmitter's fundamental emission band. (According to KDB 174176 D01 Line Conducted FAQ)

The test modes were done on conducted disturbance test and all the test results are listed in Sec. 3.7

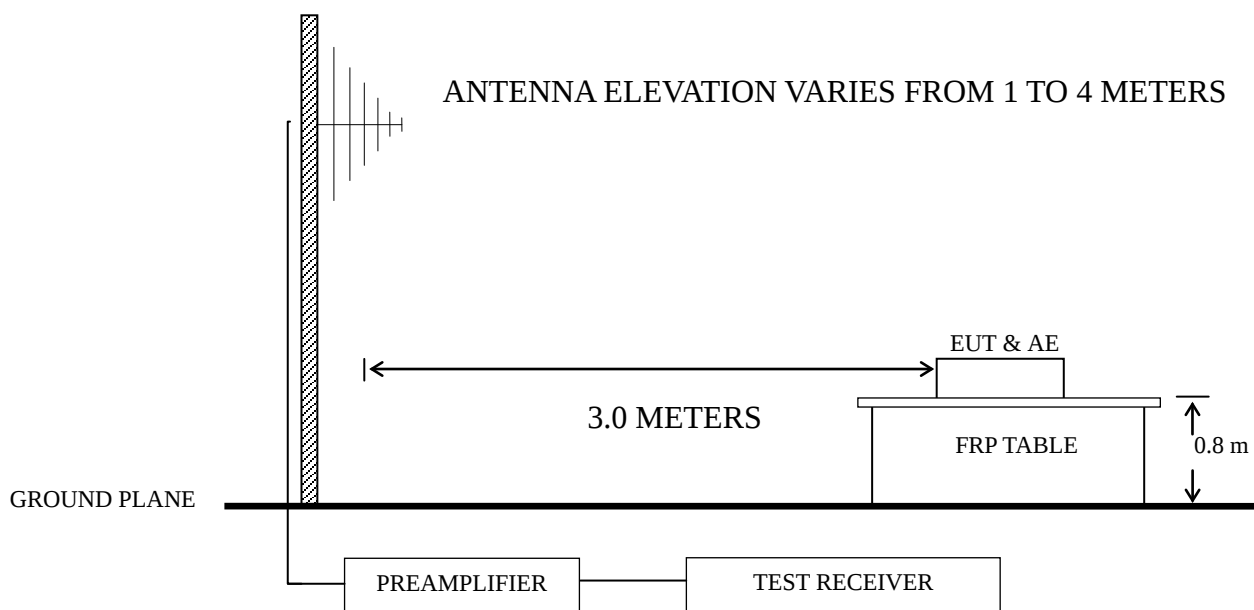

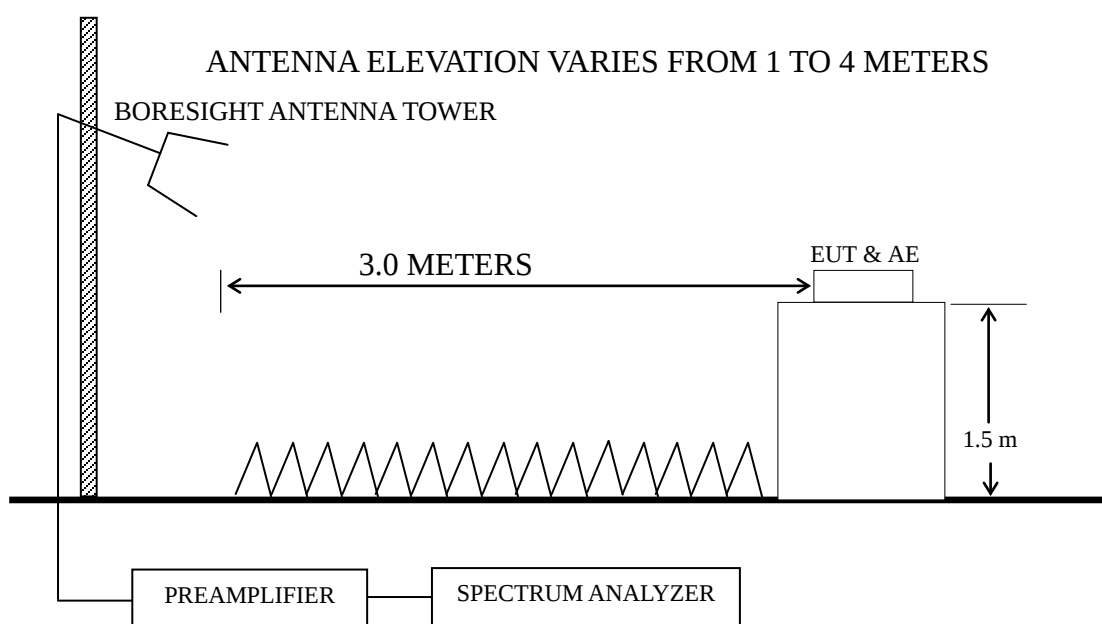

4.4 Test Configuration

The EUT (listed in Sec.2.1) and the simulators (listed in Sec.2.2) were installed as shown on Sec.4.2 to meet FCC requirements and operating in a manner that tends to maximize its emission level in a normal application.

4.5 Operating Condition of EUT

4.5.1 Setup the EUT as shown in Sec. 3.2.

4.5.2 Connect the EUT and the TTL terminal of Test Fixture through three HCI cables of EUT, as follows (3V3 to 3V3, TX to RXD, RX to TXD, GND to GND). Plug the USB terminal of Test Fixture to the USB port of Notebook PC.

4.5.3 Use the software as section 2.3 to select the test mode, then test.

4.5.4 Repeat step 3.5.2 and 3.5.5, until the test of all modes finished.

4.6 Test Procedures

Radiated emission test applies to harmonics/spurs that fall in the restricted bands listed in Section 15.205. The maximum permitted average field strength is listed in Section 15.209. A pre-amp is necessary for this measurement. For measurement above 1 GHz, set RBW = 1MHz, VBW = 10 Hz, Sweep: Auto. If the emission is pulsed, modify the unit for continuous operation; use the settings shown above, then correct the reading by subtracting the peak-average correction factor, derived from the appropriate duty cycle calculation.

The EUT was placed on a turntable. Below 1 GHz, the table height is 80 cm above the reference ground plane. Above 1 GHz, the table height is 1.5 m. The turntable rotated 360 degrees to determine the position of the maximum emission level. The EUT was set 3 meters away from the receiving antenna, which was mounted on an antenna tower. The antenna moved up and down between 1 meter and 4 meters to find out the maximum emission level.

Broadband antenna (Calibrated Bilog Antenna) or Horn antenna was used as receiving antenna. Both horizontal and vertical polarizations of the antenna were set on measurement. In order to find the maximum emission, all of the interference cables were manipulated according to ANSI C63.10: 2013 requirements during radiated emission test.

The bandwidth of Test Receiver R&S ESCI was set at 120 kHz from 30MHz to 1000MHz.

The bandwidth of Agilent N9010A was set at 1MHz for above 1GHz.

The frequency range from 30 MHz to 25 GHz (Up to 10th harmonics from fundamental frequency) was checked.

All the test results are listed in Sec.4.7.

7.3 Specification Limits (§15.247(d))

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits.
