No. Normally, the modular transmitter is in the state of receiving, when sending its signal strength will not exceed 4dbm; the average of antenna gaining is negative, it won't increase signal strength of antenna. Meanwhile the modular, assembled inner TV set, needn't install its own RF shielding.
2. The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with Part 15 requirements under conditions of excessive data rates or over-modulation.	YES, Modular and RC follow the zigbee rf4ce protocols, RC sending data rate won't exceed the limit of communication protocols.
3. The modular transmitter must have its own power supply regulation.	No The power is supplied by SSB board in TV set.
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c). The antenna must either be permanently attached or employ a "unique" antenna coupler (at all connections between the module and the antenna, including the cable)..	YES, it has chip antenna
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing. This is intended to demonstrate that the module is capable of complying with Part 15 emission limits regardless of the device into which it is eventually installed. The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module. Any similar wording that expresses the same meaning may be used.
