
Each function key sends a different series of characters, but each packet period (18.12msec) never exceeds a series of 4 long (1.375msec) and 10 short (500μsec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 4x1.375msec+10x500μsec per 18.12msec=57.9% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.

Figure B [Long Pulse]





Figure C [Short Pulse]




