

Figure 1 Setup: Transmitting mode









5.5.Test Procedure

The EUT is put on the plane 0.8m high above the ground by insulating support and is connected to the power mains through a line impedance stabilization network (L.I.S.N.). This provides a 500hm coupling impedance for the EUT system. Please refer the block diagram of the test setup and photographs. Both sides of AC lines are checked to find out the maximum conducted emission. In order to find the maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to ANSI C63.4: 2009 on Conducted Emission Measurement.

The bandwidth of test receiver (R & S ESCS30) is set at 9kHz.

The frequency range from 150kHz to 30MHz is checked.

The equipment are installed on the emission Measurement to meet the commission requirements and operating regulations in a manner which tends to maximize its emission characteristics in normal application.

7.4. Operating Condition of EUT

- 7.4.1. Setup the EUT and simulator as shown as Section 6.1.
- 7.4.2. Turn on the power of all equipment.

8.2. The Requirement For Section 15.247(e)

Section 15.247(e): For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

8.3.EUT Configuration on Measurement

The equipment is installed on the emission Measurement to meet the commission requirements and operating regulations in a manner which tends to maximize its emission characteristics in normal application.

8.4. Operating Condition of EUT

- 8.4.1. Setup the EUT and simulator as shown as Section 8.1.
- 8.4.2. Turn on the power of all equipment.
- 8.4.3.Let the EUT work in TX modes measure it. The transmit frequency are 2402-2480. We select 2402MHz, 2440MHz, and 2480MHz TX frequency to transmit.

8.5. Test Procedure

- 8.5.1. The EUT was tested according to DTS test procedure of Jun 05, 2014 KDB558074 D01 DTS Meas Guidance v03r02 for compliance to FCC 47CFR 15.247 requirements.
- 8.5.2. The transmitter output was connected to the spectrum analyzer through a low loss cable.

8.5.3. Measurement Procedure PKPSD:

This procedure must be used if maximum peak conducted output power was used to demonstrate compliance to the fundamental output power limit, and is optional if the maximum (average) conducted output power was used to demonstrate



compliance.



- 3. Set the RBW to: $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$.

- 5. Detector = peak.
- 6. Sweep time = auto couple.
- 7. Trace mode = max hold.
- 8. Allow trace to fully stabilize.

- 10. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

9.2. The Requirement For Section 15.247(d)

Section 15.247(d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. 



11.2. The Requirement of Section 15.247(d)

Section 15.247(d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a).

11.3.EUT Configuration on Measurement

The equipment is installed on the emission measurement to meet the commission requirements and operating regulations in a manner which tends to maximize its emission characteristics in normal application.




BLE Channel Low 2402MHz




BLE Channel Middle 2440MHz


