

#### 7.2. The Requirement For Section 15.247(e)

Section 15.247(e): For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

- 7.5.3.Measurement Procedure PKPSD:

This procedure must be used if maximum peak conducted output power was used to demonstrate compliance to the fundamental output power limit, and is optional if the maximum (average) conducted output power was used to demonstrate compliance.


- 1. Set analyzer center frequency to DTS channel center frequency.
- 2. Set the span to 1.5 times the DTS channel bandwidth.
- 3. Set the RBW to:  $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$ .
- 4. Set the VBW  $\geq$  3 x RBW.
- 5. Detector = peak.
- 6. Sweep time = auto couple.
- 7. Trace mode = max hold.
- 8. Allow trace to fully stabilize.
- 9. Use the peak marker function to determine the maximum amplitude level.
- 10. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

#### 8.2. The Requirement For Section 15.247(d)

Section 15.247(d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a).

- 8.4.2. Turn on the power of all equipment.
- 8.4.3.Let the EUT work in TX modes measure it. The transmit frequency are 2402-2480 MHz. We select 2402MHz, 2480MHz TX frequency to transmit.

#### 8.5.Test Procedure

#### Conducted Band Edge:

- 8.5.1. The transmitter output was connected to the spectrum analyzer via a low loss
- 8.5.2.Set RBW of spectrum analyzer to 100 kHz and VBW to 300 kHz.

#### Radiate Band Edge:

- 8.5.3. The EUT is placed on a turntable, which is 0.8m above the ground plane and worked at highest radiated power.
- 8.5.4. The turntable was rotated for 360 degrees to determine the position of maximum emission level.
- 8.5.5. EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission.
- 8.5.6. Set the spectrum analyzer in the following setting in order to capture the lower and upper band-edges of the emission:




9.1.1.Block diagram of connection between the EUT and peripherals

#### 9.2. The Limit For Section 15.247(d)

Section 15.247(d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. #### 9.4. Configuration of EUT on Measurement

The turntable can rotate 360 degrees to determine the position of the maximum emission level. EUT is set 3.0 meters away from the receiving antenna, which is mounted on an antenna tower. The antenna can be moved up and down between 1.0 meter and 4 meters to find out the maximum emission level. Both horizontal and vertical polarizations of the antenna are set on measurement. In order to find the maximum emission levels, all of the interface cables must be manipulated according to ANSI C63.10: 2013 on radiated emission measurement. The EUT was tested in 3 orthogonal planes.

The final measurement in band 9-90 kHz, 110-490 kHz and above 1000MHz is performed with Average detector. Except those frequency bands mention above, the final measurement for frequencies below 1000MHz is performed with Quasi Peak detector.

When average radiated emissions measurements are specified there is also a limit on the peak emissions level which is 20 dB above the applicable maximum permitted average emission limit




### **BLE Channel Low 2402MHz**



### **BLE Channel Middle 2440MHz**





