



# **Product Deployment**

Main unit



- 1. Massage head height adjust botton
- 2. On/off /mode switch
- 3. OLED display
- 4. Size adjust Knob
- 5. Earphone jack
- 6. DC power interface
- 7. Disassemble button for eye part

## **Operation**

### **Preparation before use**

- 1. Check if there are missing parts of the package.
- 2. Make sure the main unit with enough power.
- 3. Make sure there is no damage of the adaptor.

### Charge the unit

- 1. Open the cover of ⑥DC power interface, insert the adaptor.
- 2. When charging, the battery status on ③OLED display will flashing, when fully charged, it will stop flashing.

### **Attention**

- 1. Make sure the main unit is power off when charging; Charging time is about 4 hours.
- 2. Do not use the product when charging. The main unit doesn't work while charging
- 3. Download APP for customizing massage.

### How to wear

- 1. Press the button in the middle of ⓐ Size adjust Knob and wear the main unit.
- 2. Turn 4 Size adjust Knob to adjust the size to fit your head and eyes.

### **Operation**

- 3. The top side size could be adjusted after machine on.
  Short press ① Massage head height adjust botton for shorter the size(maximum 3 times), and long press for higher size.
- 4. The eye part could be disassembled before you wear the main unit by ? Disassemble button for eye part.

### **Operation& Mode Selection**

Short press ②On/off /mode switch, MED mode will on. Short press ②On/off /mode switch to switch the massage mode.

### **Shutdown**

Long press ② On/off /mode switch.

### **Precautions**

- 1. Do not use the head massager when driving.
- 2. Do not use the massager in places too hot and wet.
- 3. Check before using the massager: No hairpin, hair accessory on your head and no wear contact lenses.
- 4. Wear the massager before switch on to avoid overpressure damage to the air bag.
- 5. The massager is suitable for adults of 56cm~64cm head circumference.
- 6. For those who suffer from heavy inflammation, blood stasis or brain surgery, do not use the massager.
- 7. For those who suffer from heavy slow action, poor physical and mental function or disturbance of intelligence, use under the supervision of companion, and stop using immediately if there is any discomfort.
- 8. For those who suffer from apoplexy, high blood pressure and low blood pressure, please use with caution and consult professional physician, and stop using immediately if there is any discomfort.
- 9. Use the stabilized DC5V adaptor, and use safely.
- 10. The product is not suitable for diagnosis, treatment and other commercial purposes.
- 11. Use sterile cotton with neutral detergent for cleaning, rather than water.
- 12. The massager has heating function, those who are insensitive to temperature shall pay attention.
