NOTE: The calibration interval of the above test instruments is 12 months and the calibrations are traceable to NML/ROC and NIST/USA.

4.6.3 TEST PROCEDURE

For Single TX:

The transmitter output was connected to the spectrum analyzer via a low loss cable. Set both RBW and VBW of spectrum analyzer to 100kHz with suitable frequency span including 10Hz bandwidth from band edge. The band edges were measured and recorded.

The spectrum plots (Peak RBW = VBW = 100kHz; Average RBW = 1MHz, VBW = 10Hz) are attached on the following pages.

For Dual TX:

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. Set both RBW and VBW of spectrum analyzer to 100kHz with suitable frequency span including 100MHz bandwidth from band edge. The band edges were measured and recorded.

The spectrum plots (Peak RBW = VBW = 100kHz; Average RBW = 1MHz, VBW = 10Hz)

NOTE: The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 10Hz for Average detection (AV) at frequency above 1GHz.

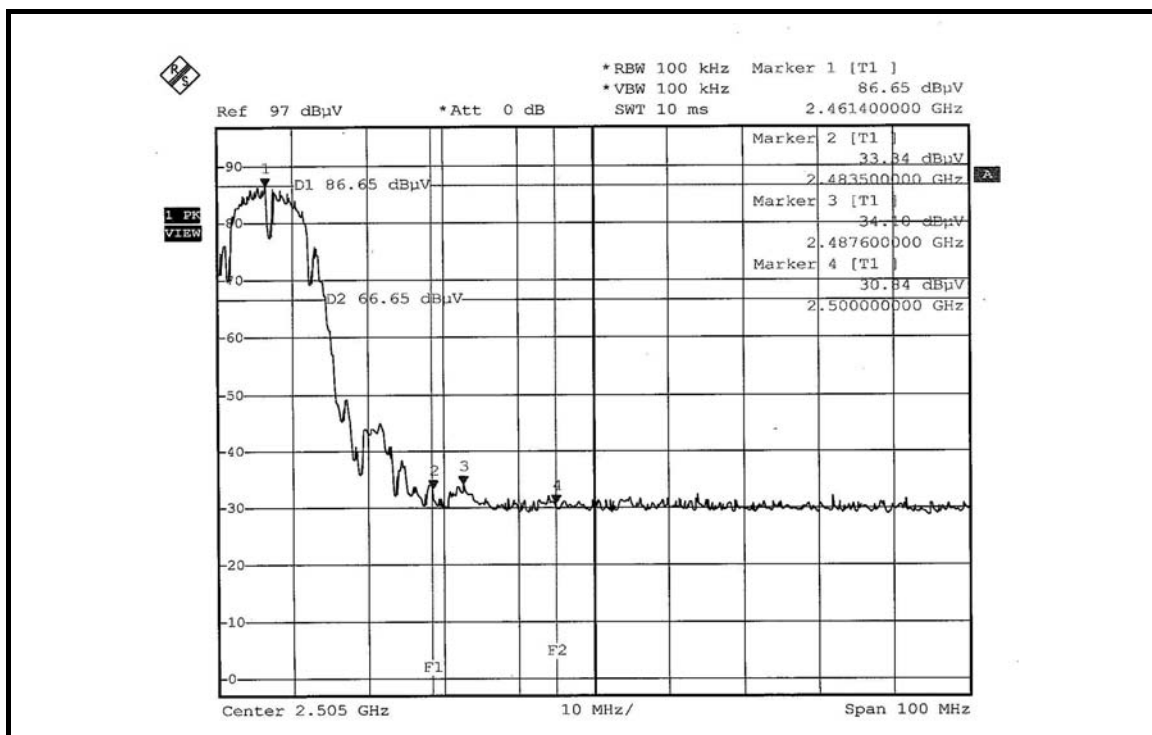
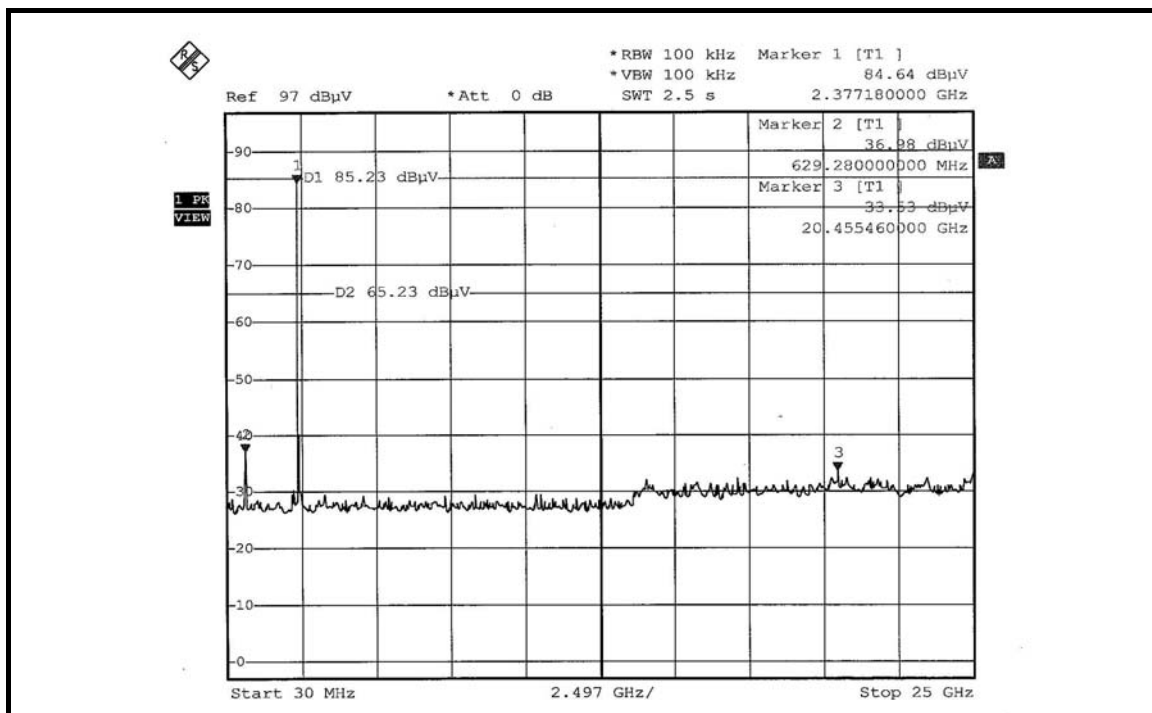
NOTE 1: The band edge emission plot on the next page shows 48.87dBc between carrier maximum power and local maximum emission in restrict band (2.38620GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 108.12dBuV/m (Peak), so the maximum field strength in restrict band is $108.12 - 48.87 = 59.25$ dBuV/m which is under 74dBuV/m limit.

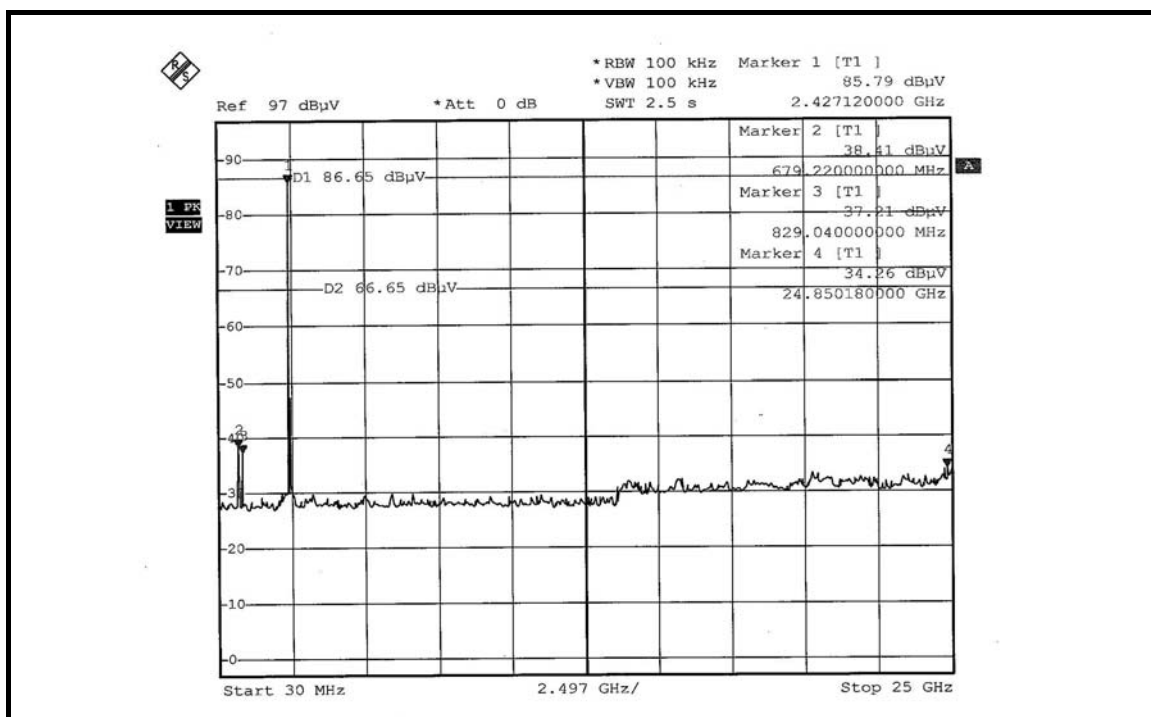
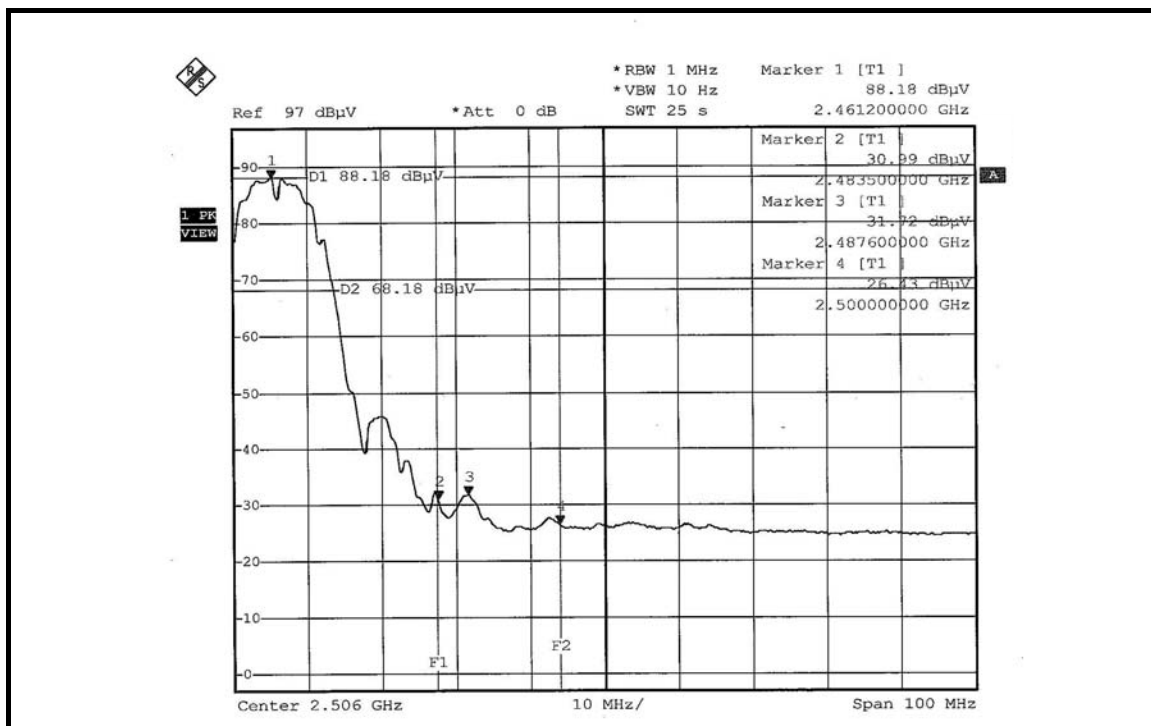
The band edge emission plot on the next page shows 51.46dBc between carrier maximum power and local maximum emission in restrict band (2.38660GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 104.37dBuV/m (Average), so the maximum field strength in restrict band is $104.37 - 51.46 = 52.91$ dBuV/m which is under 54dBuV/m limit.

NOTE 2: The band edge emission plot on the next second page shows 52.55dBc between carrier maximum power and local maximum emission in restrict band (2.48760GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 110.57dBuV/m (Peak), so the maximum field strength in restrict band is $110.57 - 52.55 = 58.02$ dBuV/m which is under 74dBuV/m limit.

The band edge emission plot on the next third page shows 56.46dBc between carrier maximum power and local maximum emission in restrict band (2.48760GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 107.22dBuV/m (Average), so the maximum field strength in restrict band is $107.22 - 56.46 = 50.76$ dBuV/m which is under 54dBuV/m limit.







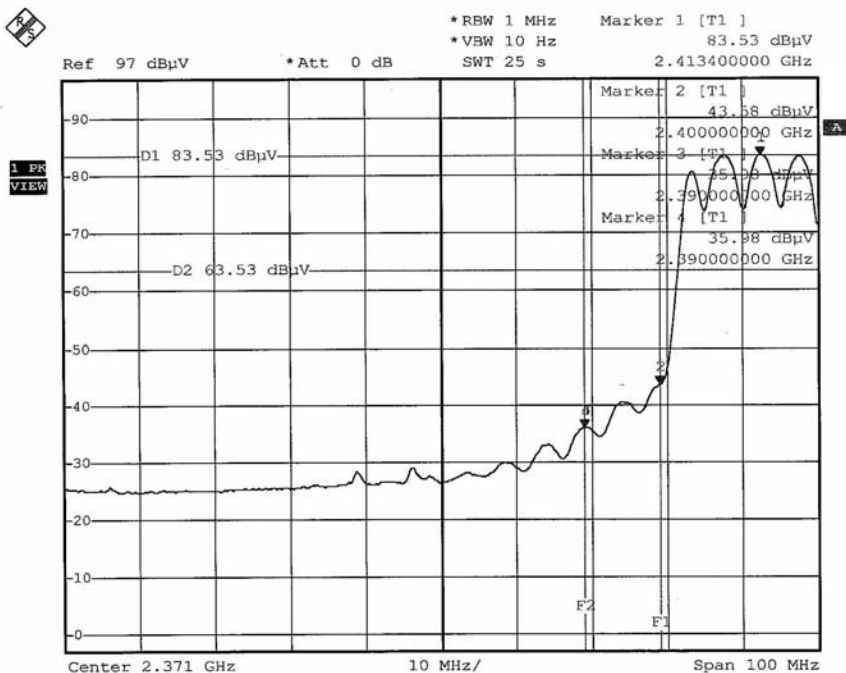
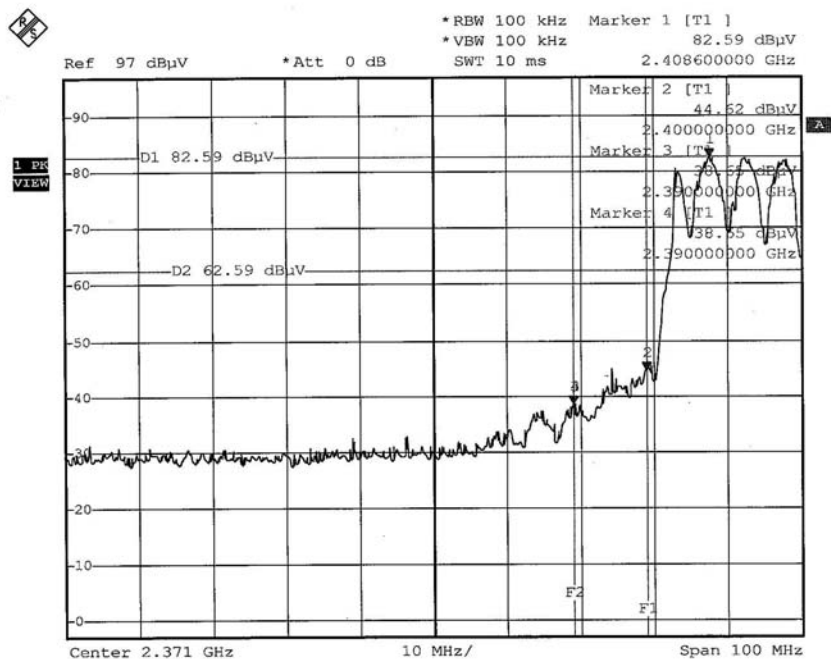

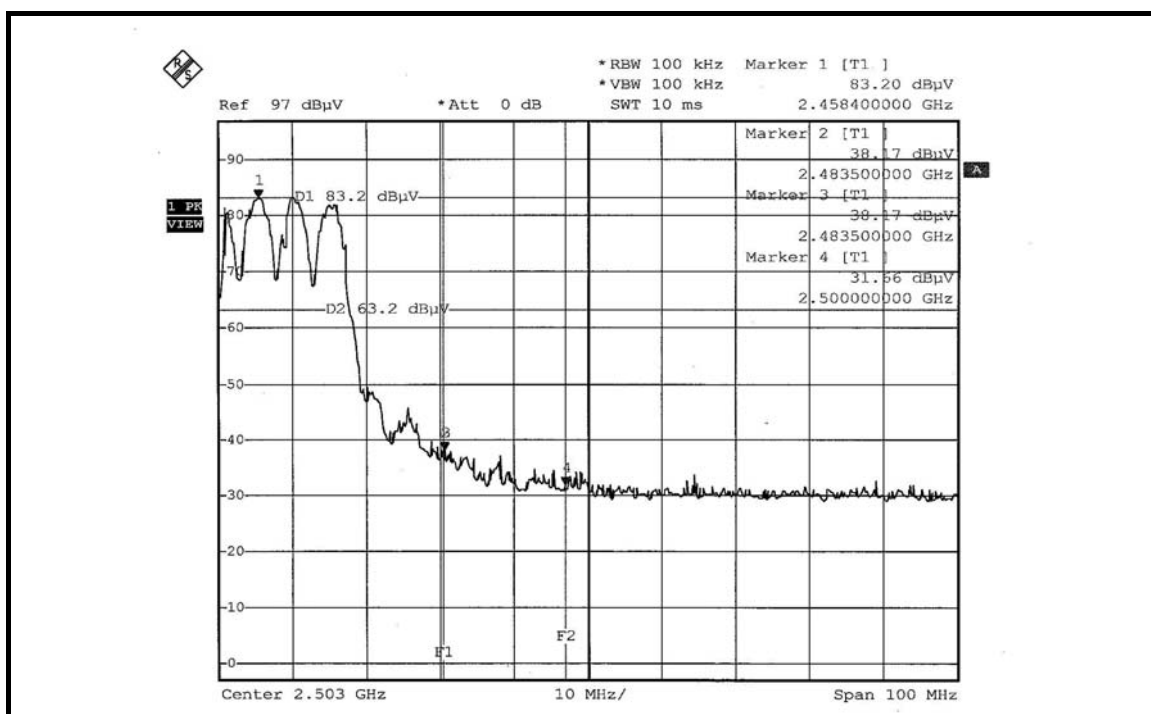
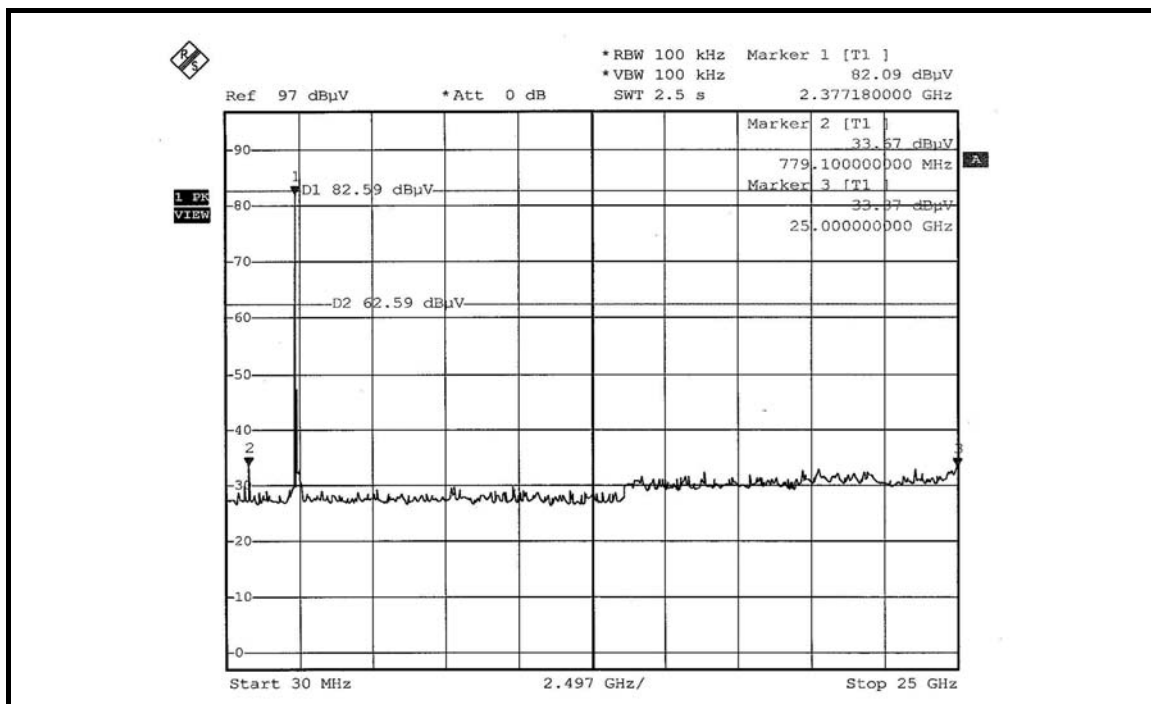
NOTE 1: The band edge emission plot on the next page shows 43.94dBc between carrier maximum power and local maximum emission in restrict band (2.39000GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 108.91dBuV/m (Peak), so the maximum field strength in restrict band is $108.91 - 43.94 = 64.97$ dBuV/m which is under 74dBuV/m limit.

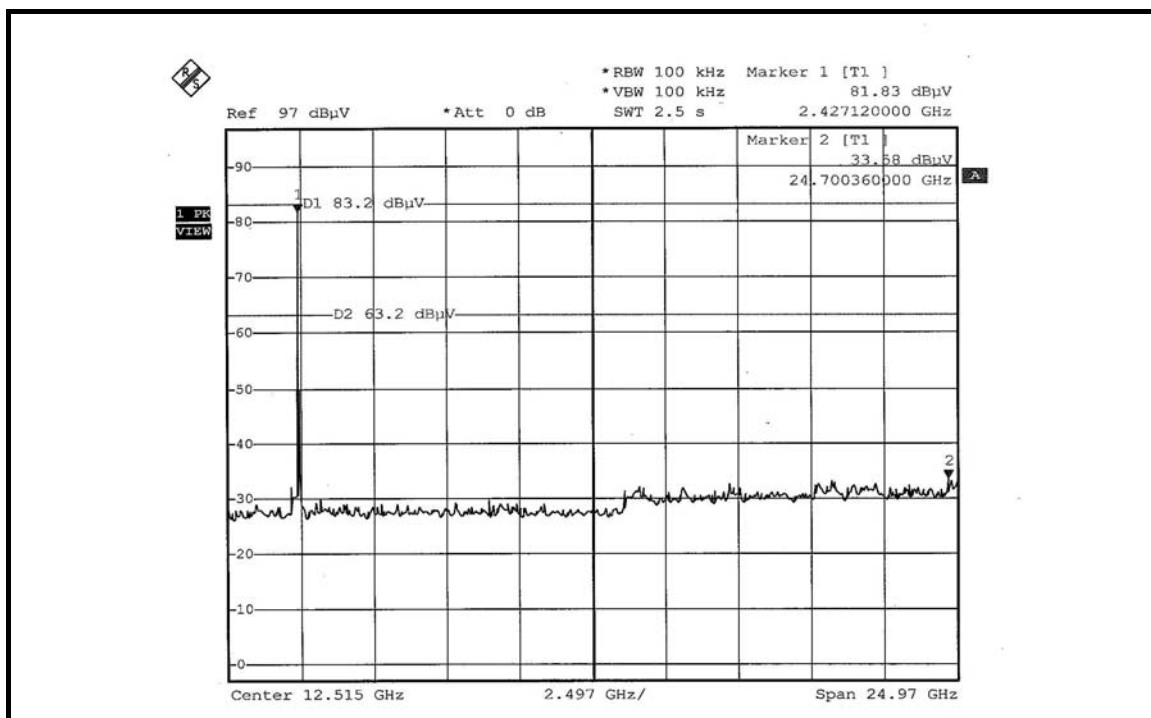
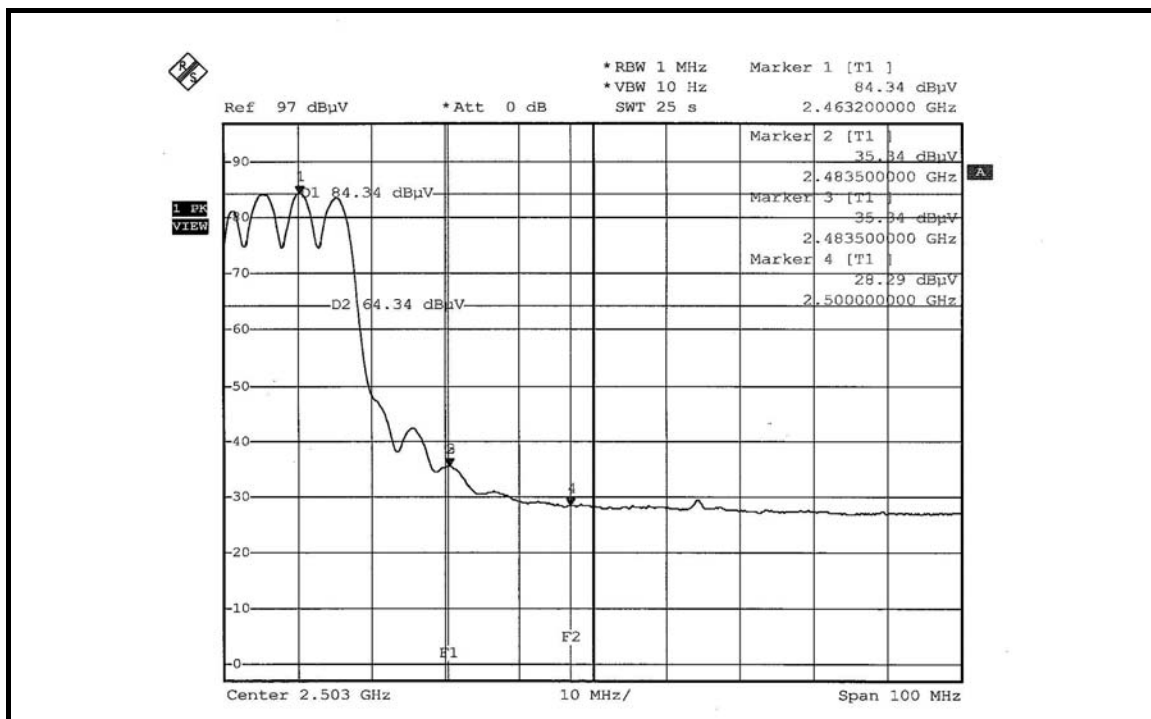
The band edge emission plot on the next page shows 47.55dBc between carrier maximum power and local maximum emission in restrict band (2.39000GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 99.31dBuV/m (Average), so the maximum field strength in restrict band is $99.31 - 47.55 = 51.76$ dBuV/m which is under 54dBuV/m limit.

NOTE 2: The band edge emission plot on the next second page shows 45.03dBc between carrier maximum power and local maximum emission in restrict band (2.48350GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 108.68dBuV/m (Peak), so the maximum field strength in restrict band is $108.68 - 45.03 = 63.65$ dBuV/m which is under 74dBuV/m limit.

The band edge emission plot on the next third page shows 49.00dBc between carrier maximum power and local maximum emission in restrict band (2.48350GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 99.52dBuV/m (Average), so the maximum field strength in restrict band is $99.52 - 49.00 = 50.52$ dBuV/m which is under 54dBuV/m limit.







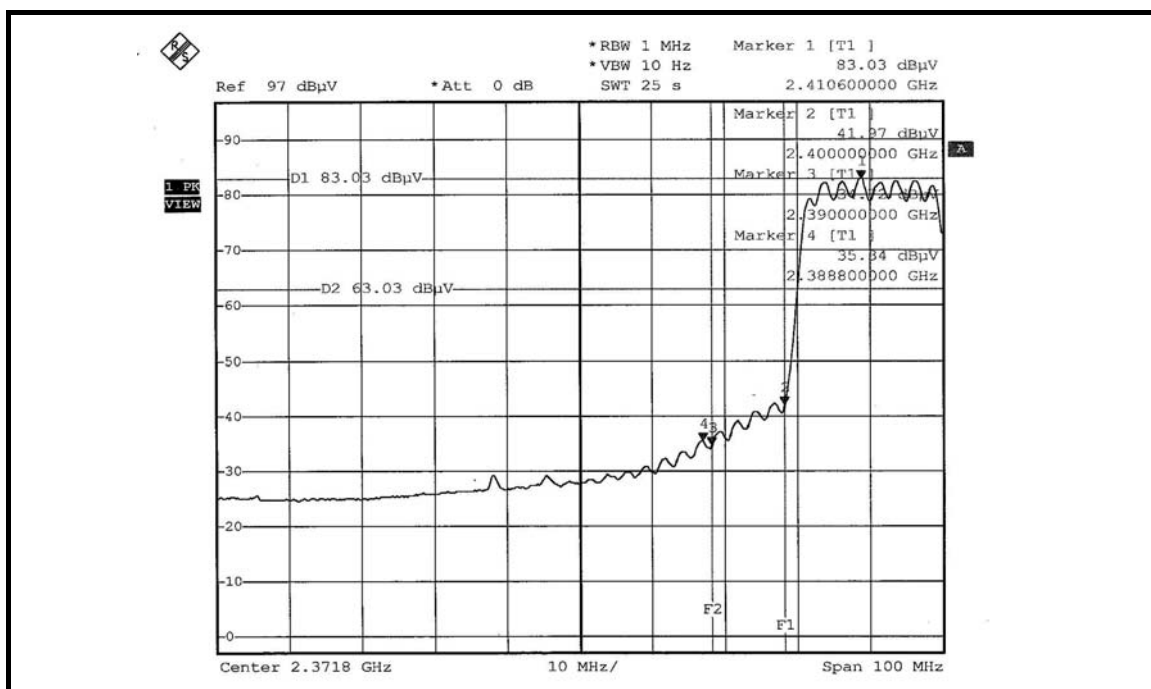
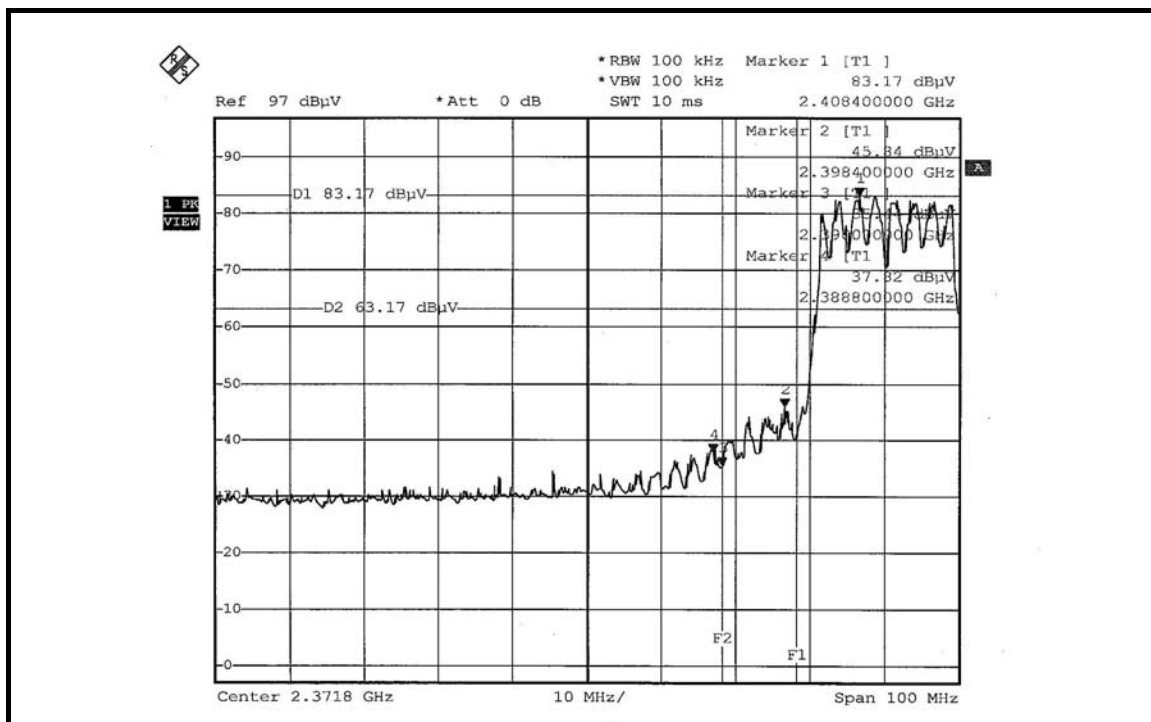

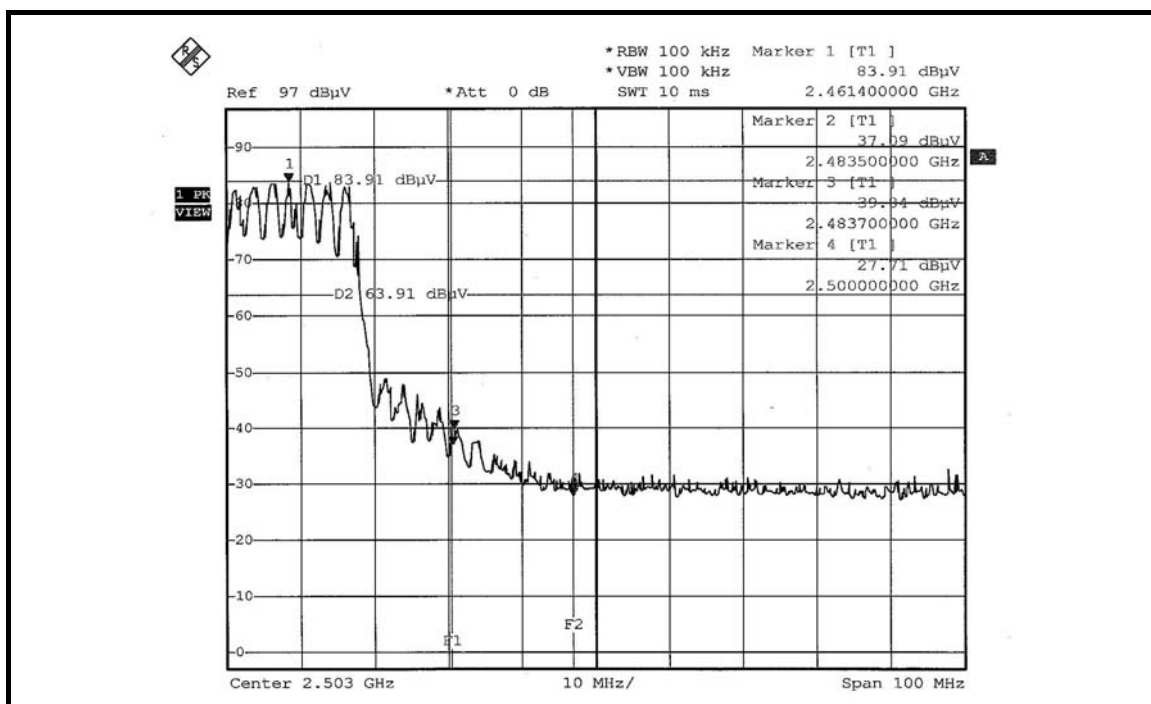
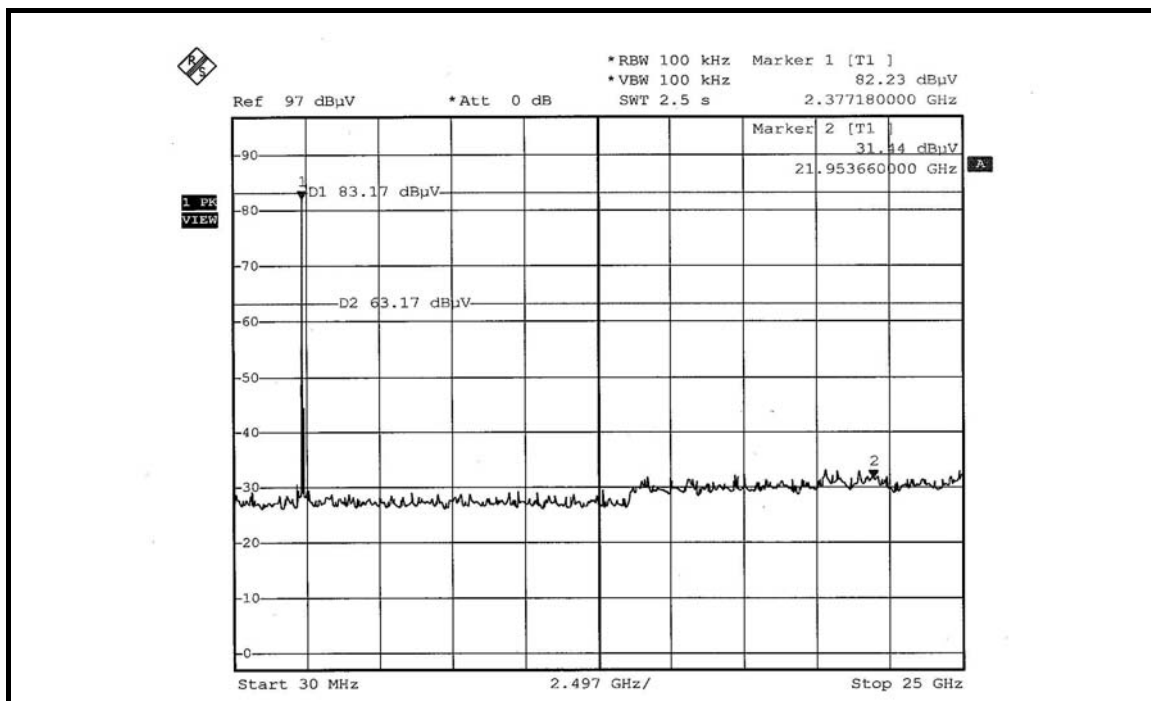
NOTE 1: The band edge emission plot on the next page shows 45.35dBc between carrier maximum power and local maximum emission in restrict band (2.38880GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 108.63dBuV/m (Peak), so the maximum field strength in restrict band is $108.63 - 45.35 = 63.28$ dBuV/m which is under 74dBuV/m limit.

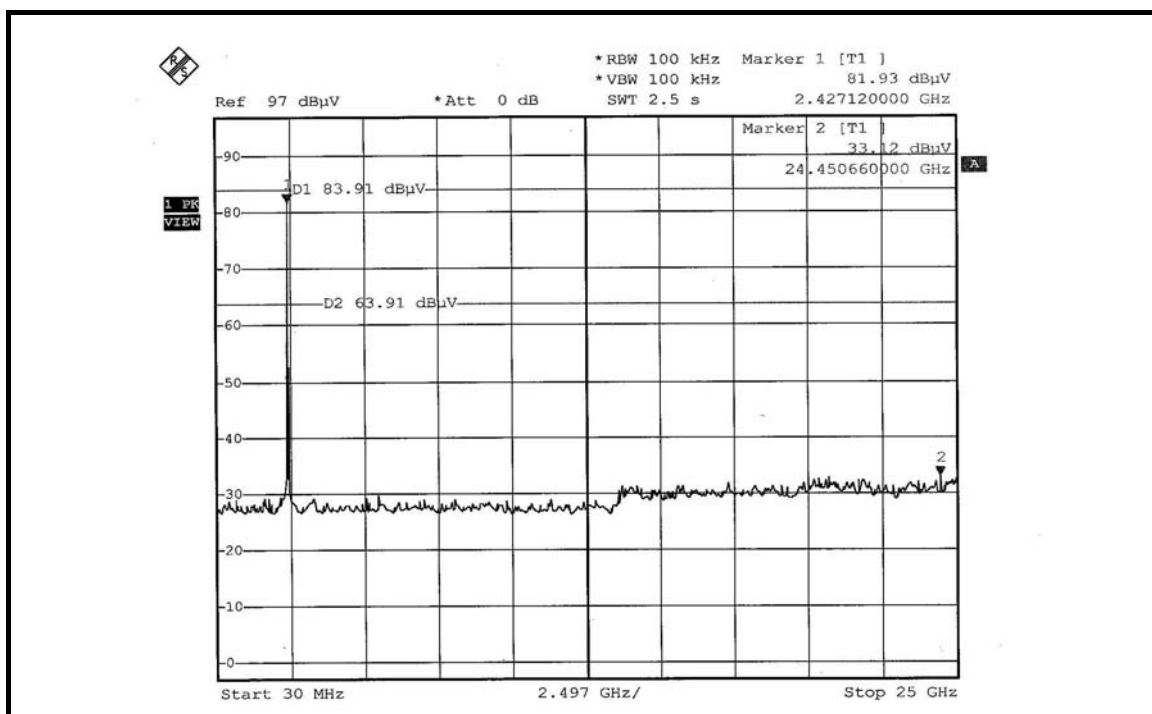
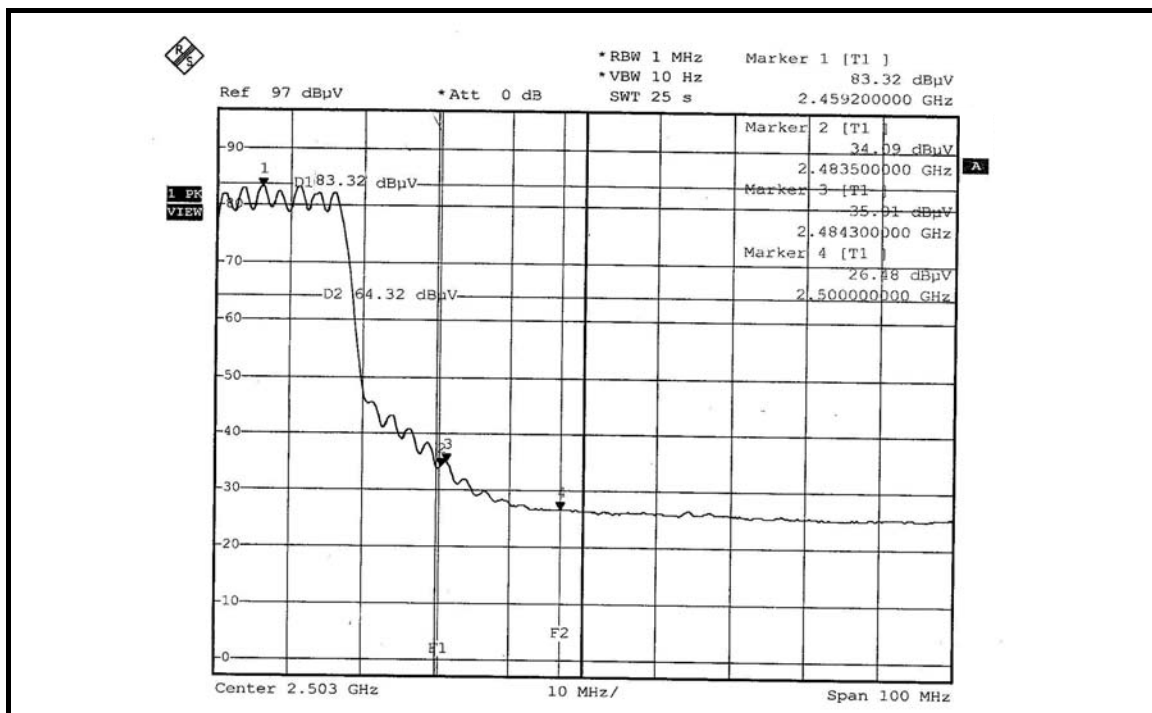
The band edge emission plot on the next page shows 47.69dBc between carrier maximum power and local maximum emission in restrict band (2.38880GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 98.83dBuV/m (Average), so the maximum field strength in restrict band is $98.83 - 47.69 = 51.14$ dBuV/m which is under 54dBuV/m limit.

NOTE 2: The band edge emission plot on the next second page shows 44.07dBc between carrier maximum power and local maximum emission in restrict band (2.48370GHz) is 109.52dBuV/m (Peak), so the maximum field strength in restrict band is $109.52 - 44.07 = 65.45$ dBuV/m which is under 74dBuV/m limit.

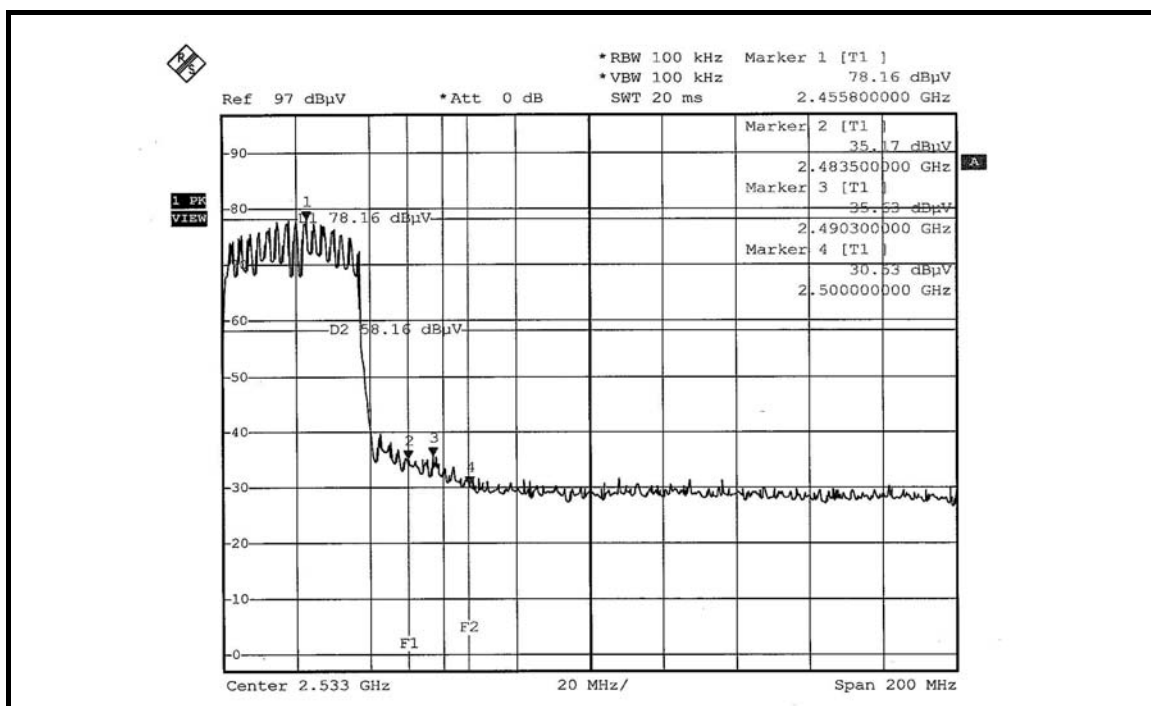
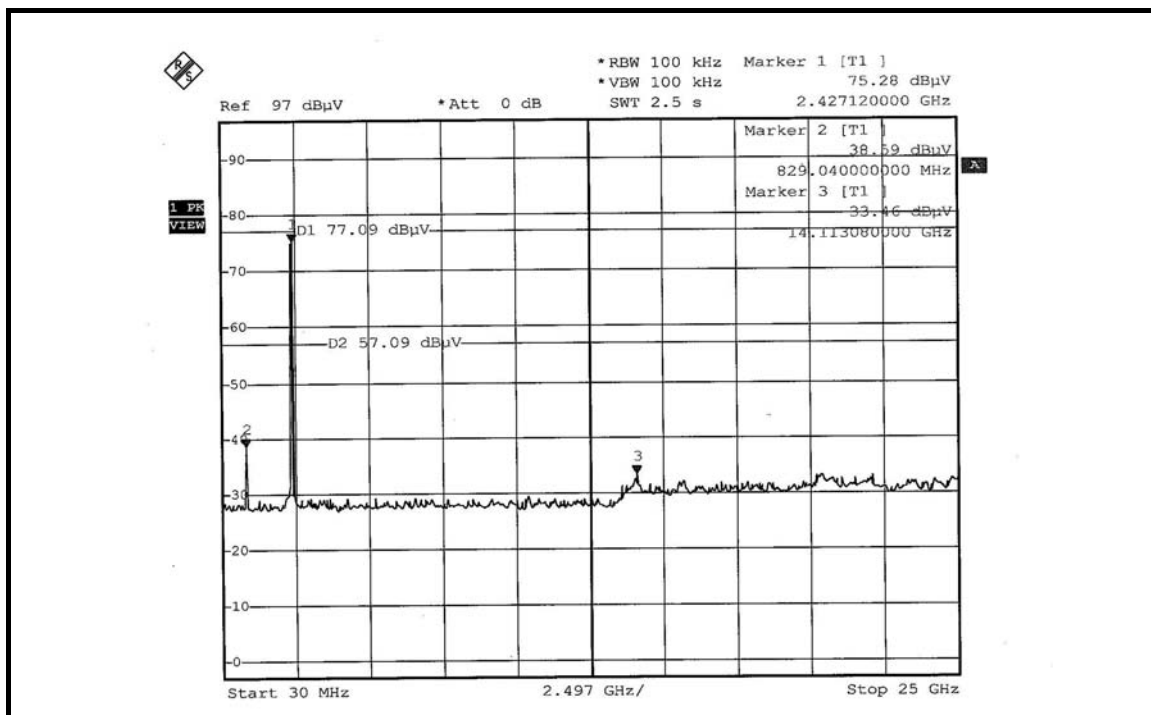
NOTE 1: The band edge emission plot on the next page shows 40.33dBc between carrier maximum power and local maximum emission in restrict band (2.38840GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 101.57dBuV/m (Peak), so the maximum field strength in restrict band is $101.57 - 40.33 = 61.24$ dBuV/m which is under 74dBuV/m limit.

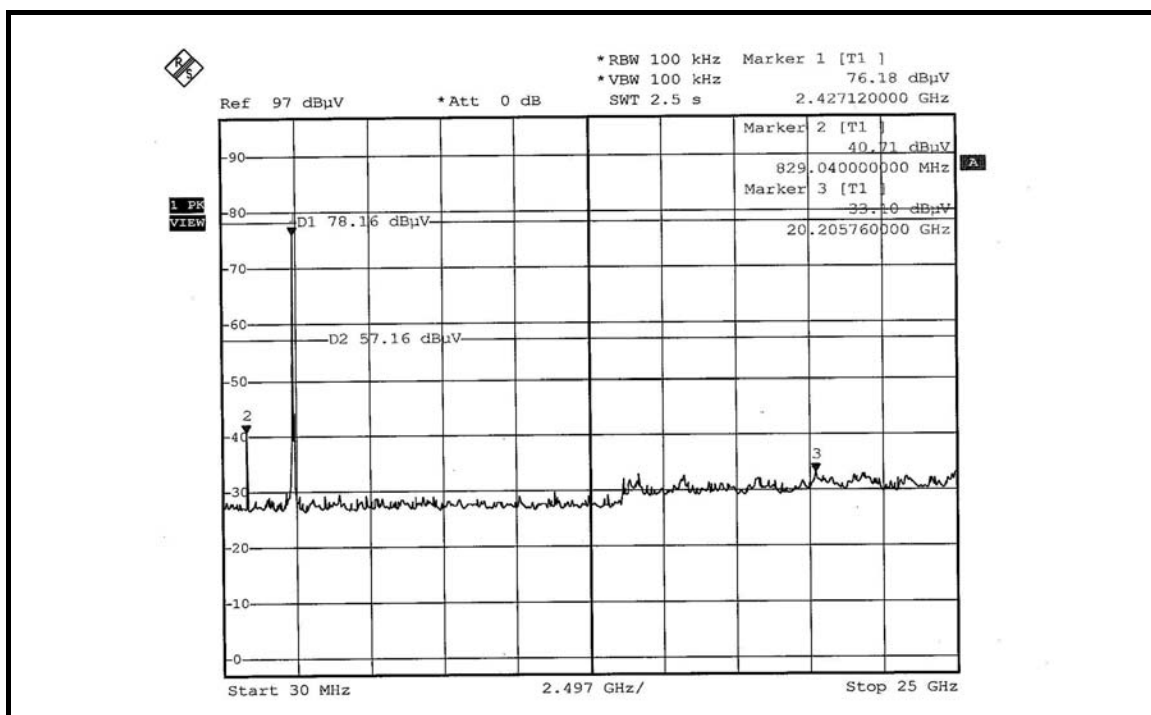
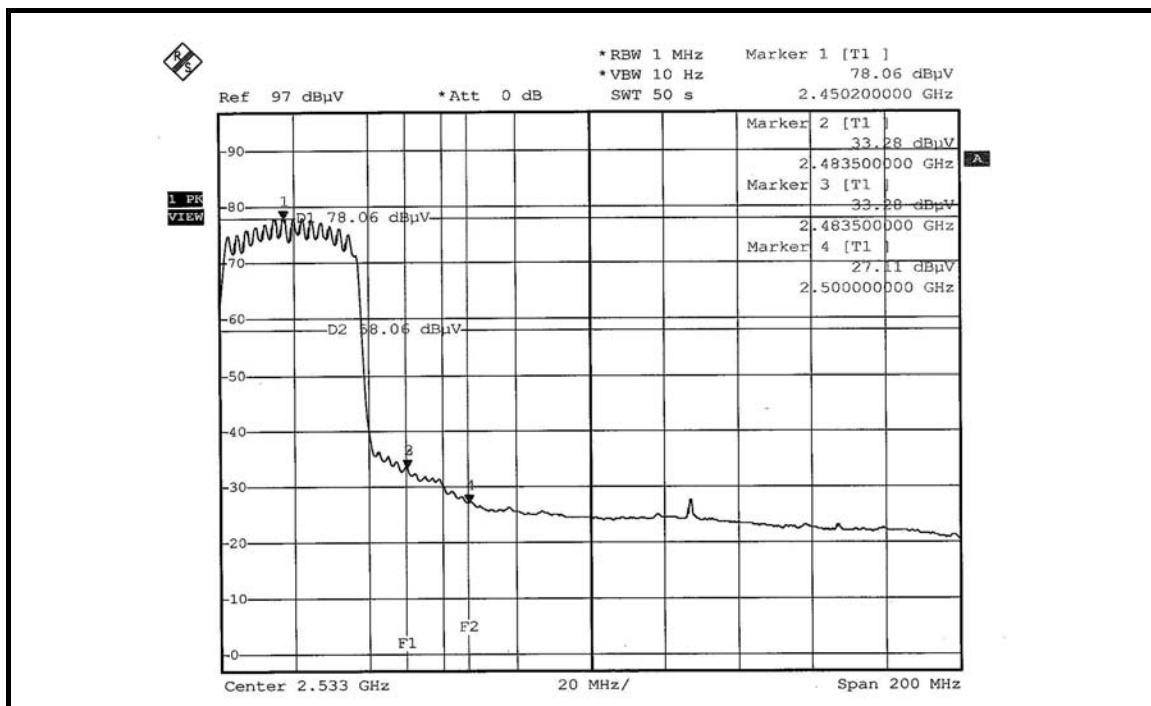
The band edge emission plot on the next page shows 42.74dBc between carrier maximum power and local maximum emission in restrict band (2.38840GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 91.68dBuV/m (Average), so the maximum field strength in restrict band is $91.68 - 42.74 = 48.94$ dBuV/m which is under 54dBuV/m limit.

NOTE 2: The band edge emission plot on the next second page shows 42.53dBc between carrier maximum power and local maximum emission in restrict band (2.49030GHz). The emission of carrier strength list in the test result of channel 7 at the item 4.2.7 is 102.48dBuV/m (Peak), so the maximum field strength in restrict band is $102.48 - 42.53 = 59.95$ dBuV/m which is under 74dBuV/m limit.

The band edge emission plot on the next third page shows 44.78dBc between carrier maximum power and local maximum emission in restrict band (2.48350GHz). The emission of carrier strength list in the test result of channel 7 at the item 4.2.7 is 91.48dBuV/m (Average), so the maximum field strength in restrict band is $91.48 - 44.78 = 46.70$ dBuV/m which is under 54dBuV/m limit.







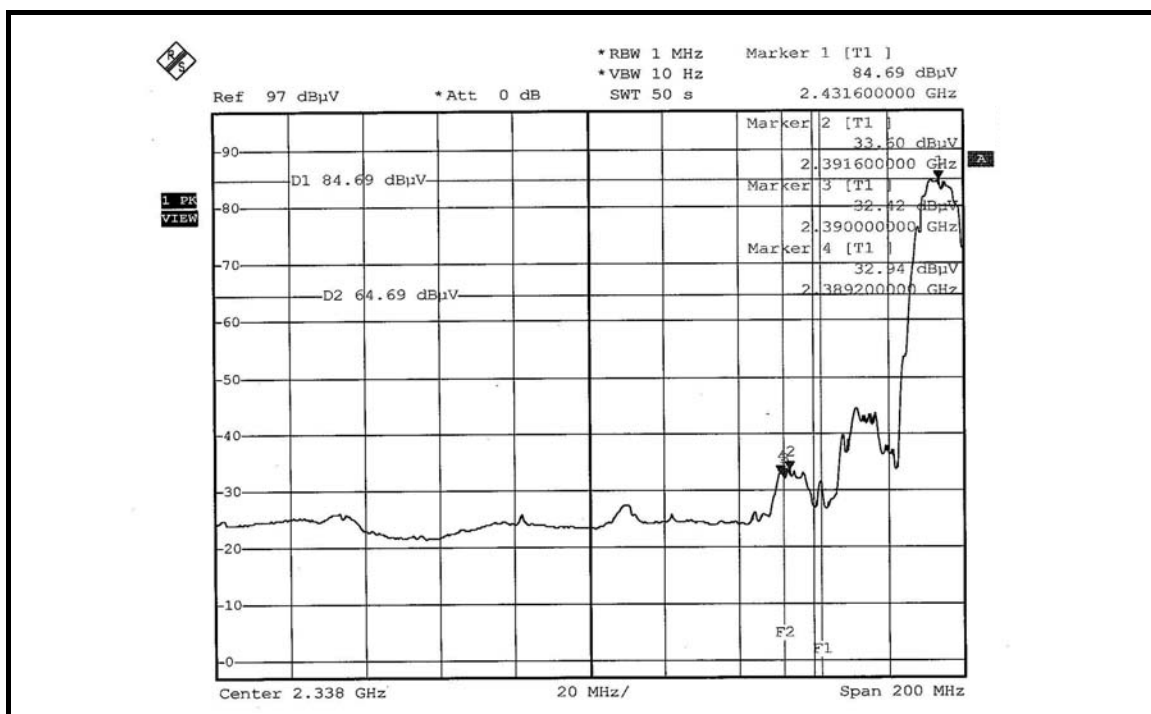
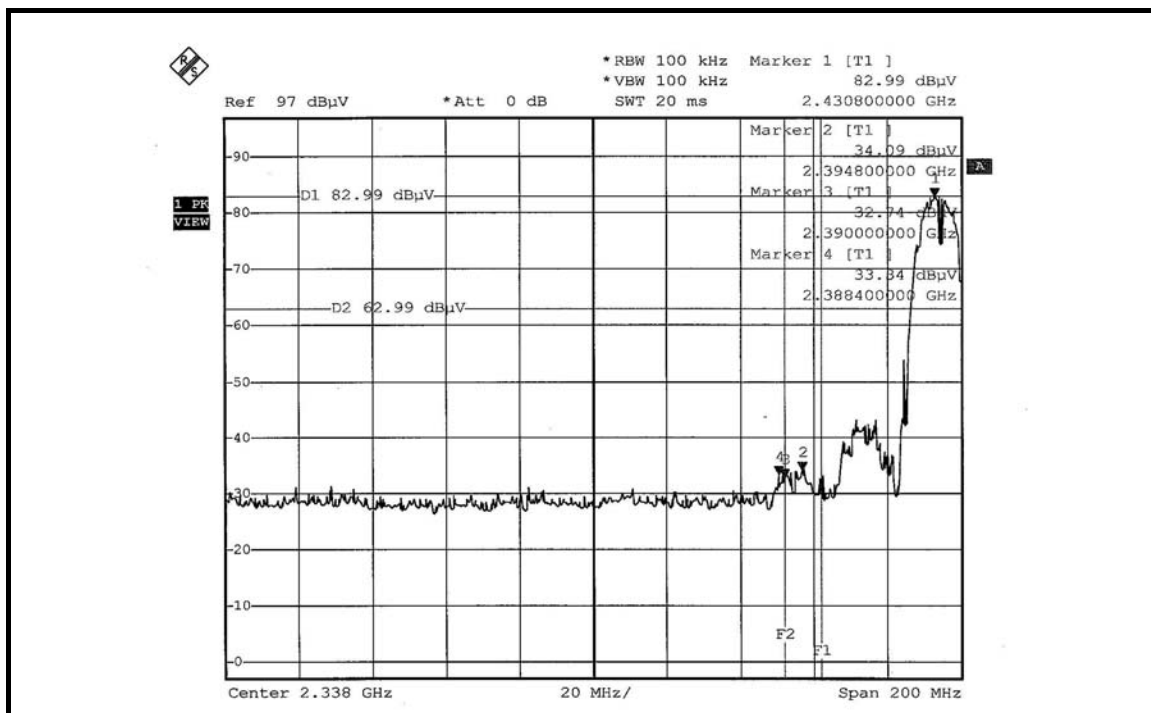

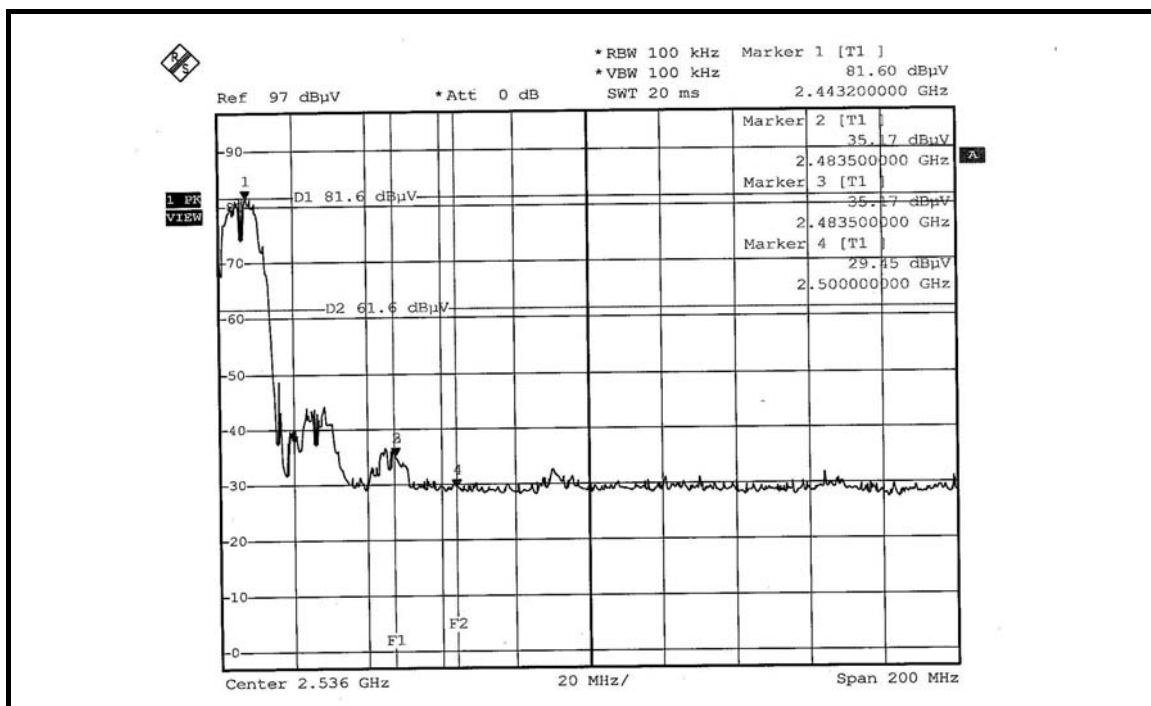
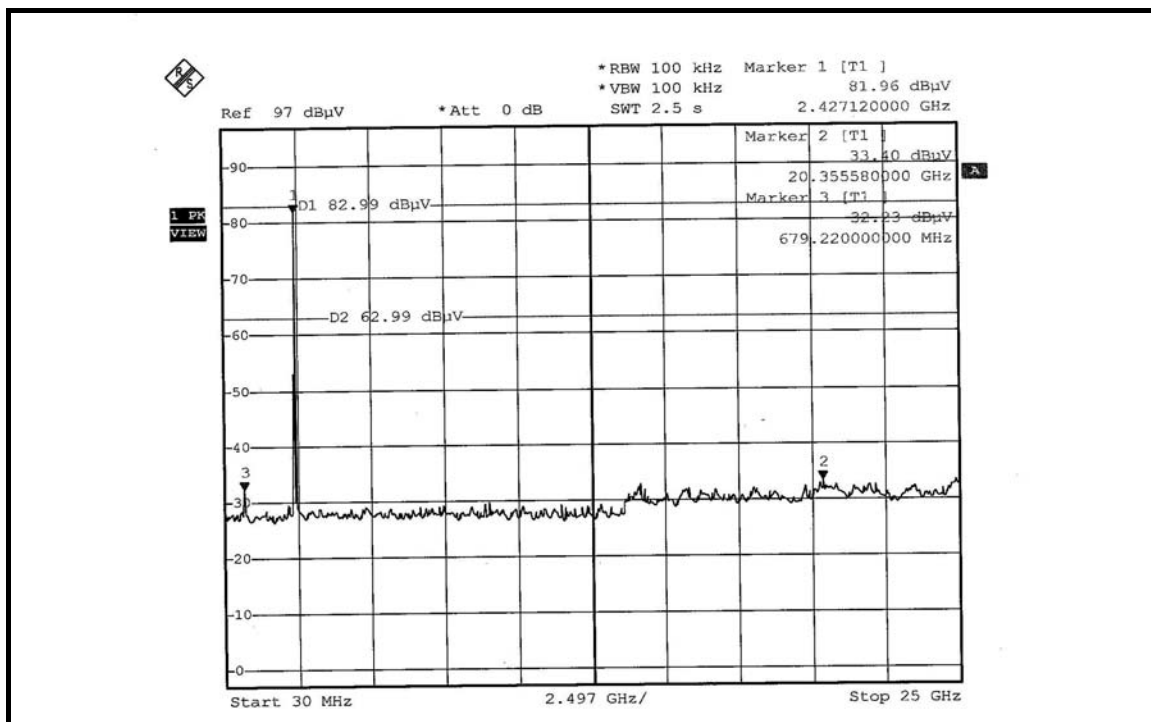
NOTE 1: The band edge emission plot on the next page shows 49.65dBc between carrier maximum power and local maximum emission in restrict band (2.38840GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 108.13dBuV/m (Peak), so the maximum field strength in restrict band is $108.13 - 49.65 = 58.48$ dBuV/m which is under 74dBuV/m limit.

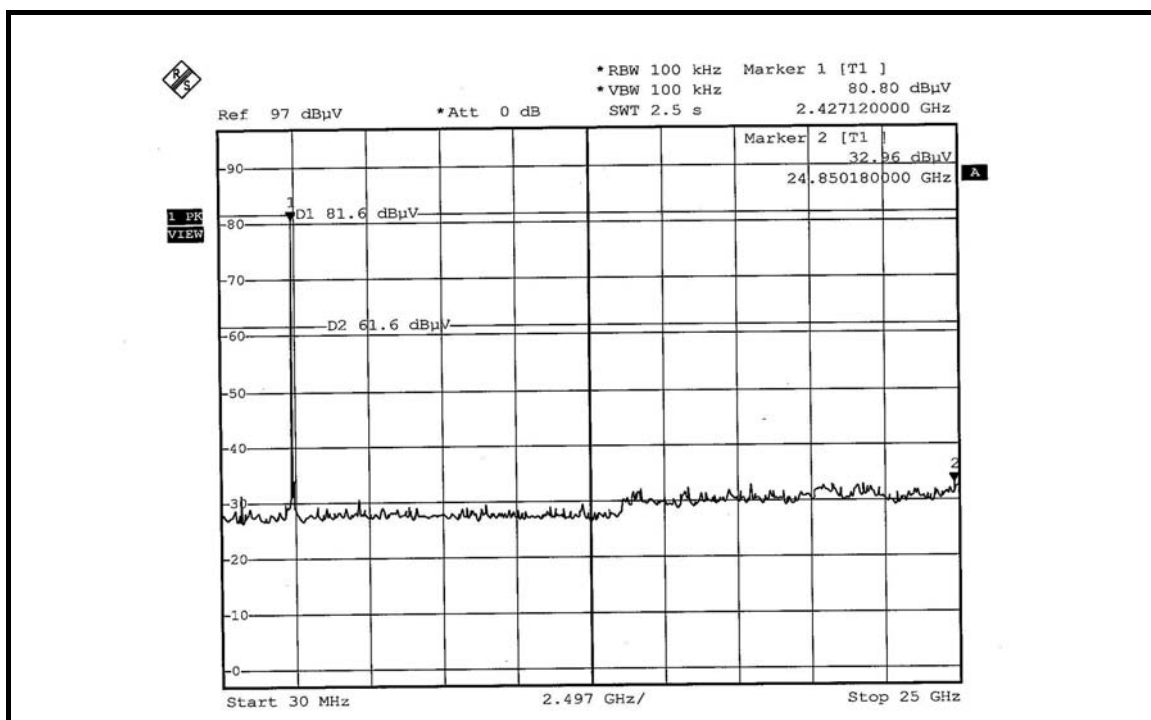
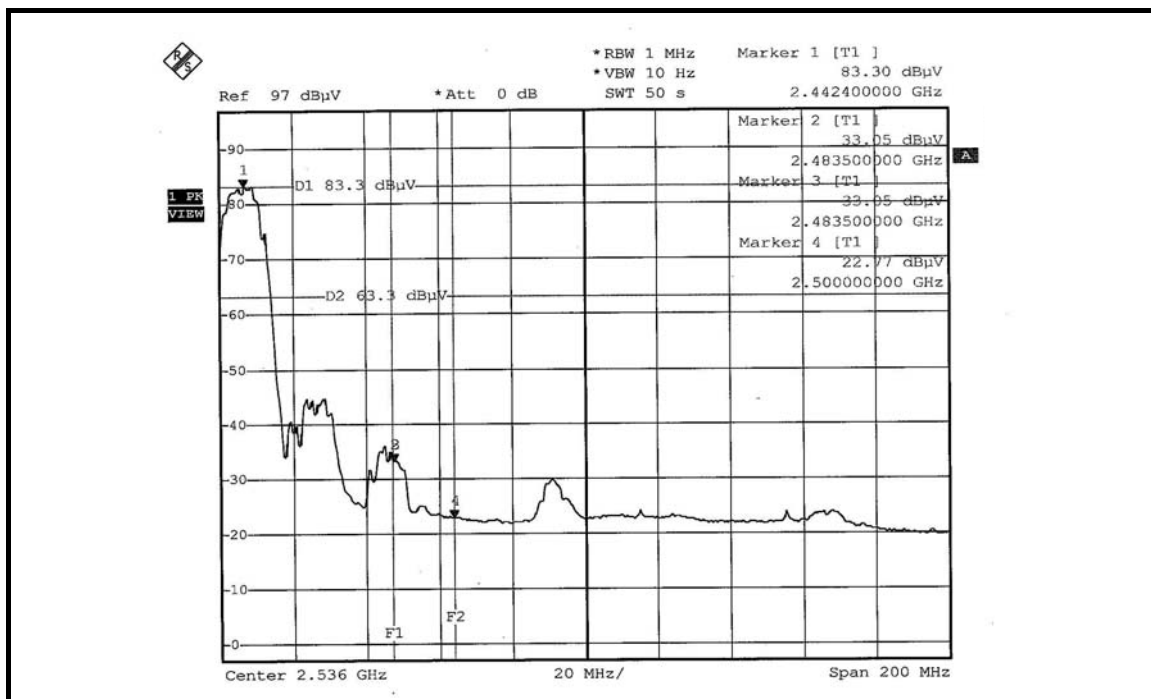
The band edge emission plot on the next page shows 51.75dBc between carrier maximum power and local maximum emission in restrict band (2.38920GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 104.65dBuV/m (Average), so the maximum field strength in restrict band is $104.65 - 51.75 = 52.90$ dBuV/m which is under 54dBuV/m limit.

NOTE 2: The band edge emission plot on the next second page shows 46.43dBc between carrier maximum power and local maximum emission in restrict band (2.48350GHz). The emission of carrier strength list in the test result of channel 7 at the item 4.2.7 is 107.38dBuV/m (Peak), so the maximum field strength in restrict band is $107.38 - 46.43 = 60.95$ dBuV/m which is under 74dBuV/m limit.

The band edge emission plot on the next third page shows 50.25dBc between carrier maximum power and local maximum emission in restrict band (2.48350GHz). The emission of carrier strength list in the test result of channel 7 at the item 4.2.7 is 103.24dBuV/m (Average), so the maximum field strength in restrict band is $103.24 - 50.25 = 52.99$ dBuV/m which is under 54dBuV/m limit.







4.7 ANTENNA REQUIREMENT

4.7.1 STANDARD APPLICABLE

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

4.7.2 ANTENNA CONNECTED CONSTRUCTION

The antenna used in this product is Dipole antenna with R-SMA connector. The maximum Gain of the antenna is -1.1dBi.
