Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Conclusion:

WLAN 2.4GHz + WLAN 5GHz = 0.32026 / 1 + 0.58951 / 1 = 0.90977Therefore the maximum calculations of above situations are less than the "1" limit.
