The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. 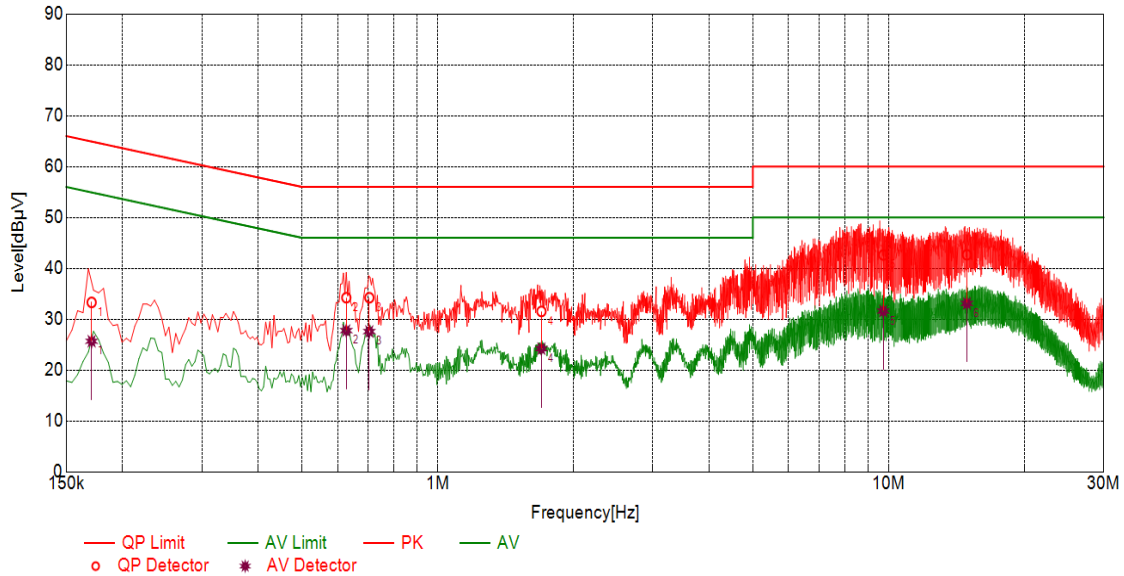


**Measurement Data**

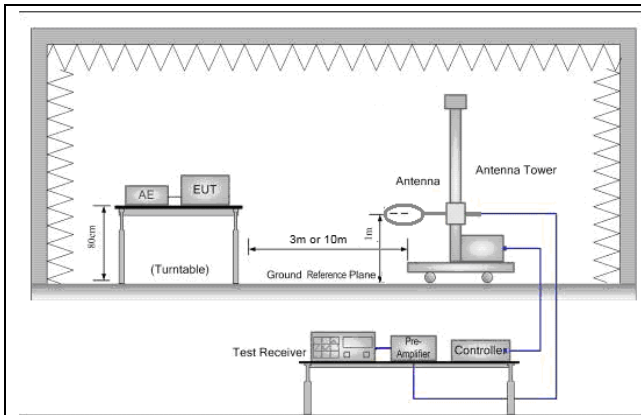


Figure 1. Below 30MHz

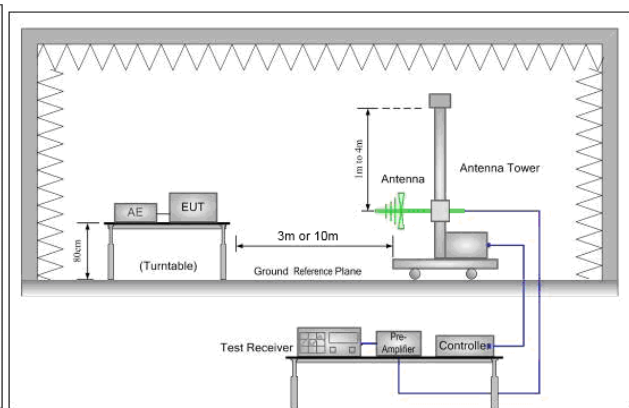


Figure 2. 30MHz to 1GHz

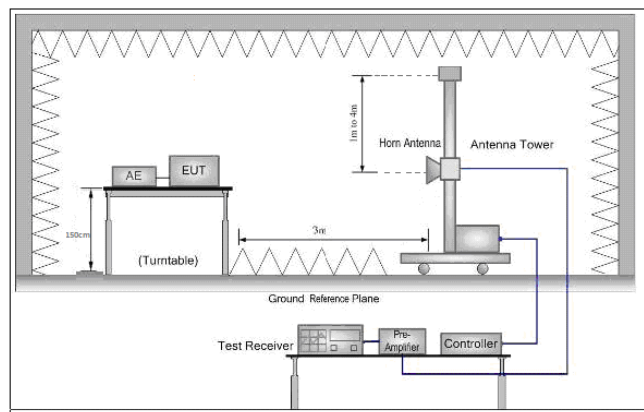


Figure 3. Above 1 GHz

- 2) Scan from 9kHz to 25GHz, the disturbance between 9KHz to 30MHz and 18GHz to 25GHz was very low, and the above harmonics were the highest point could be found when testing, The amplitude of spurious emissions from the radiator which are attenuated more than 20dB below the limit need not be reported.
- 3) As shown in this section, for frequencies above 1GHz, the field strength limits are based on average limits. However, the peak field strength of any emission shall not exceed the maximum permitted average limits specified above by more than 20 dB under any condition of modulation. So, only the peak measurements were shown in the report.

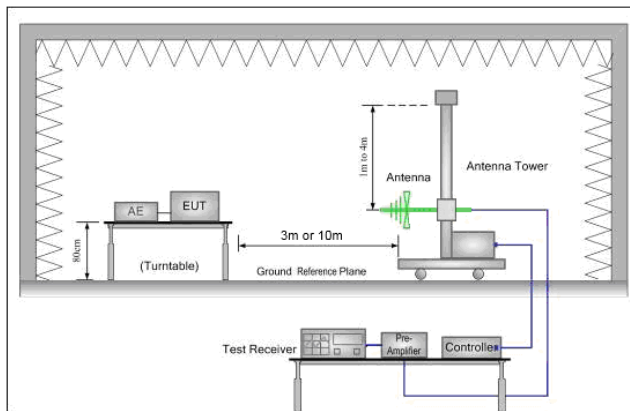


Figure 1. 30MHz to 1GHz

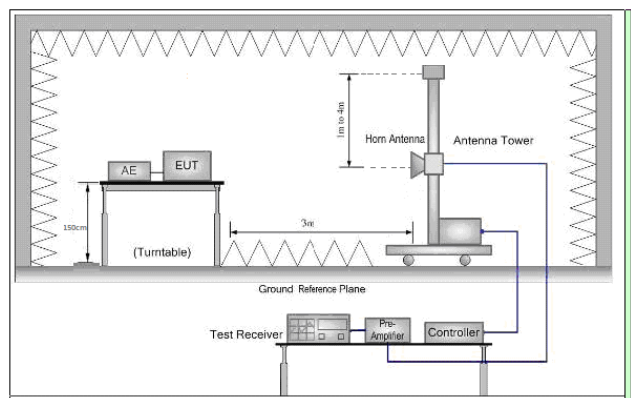


Figure 2. Above 1 GHz
