





#### 6 dB Bandwidth Plot on Channel 00







#### 99% Bandwidth Plot on Channel 00





## 3.2 Output Power Measurement

For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. 





#### PSD 100kHz Plot on Channel 00









#### **PSD 3kHz Plot on Channel 00**







## 3.5 Radiated Band Edges and Spurious Emission Measurement

## 3.5.1 Limit of Radiated Band Edges and Spurious Emission

In any 100 kHz bandwidth outside the intentional radiator frequency band, all harmonics/spurious must be at least 20 dB below the highest emission level within the authorized band. If the output power of this device was measured by spectrum analyzer, the attenuation under this paragraph shall be 30 dB instead of 20 dB. #### 3.5.3 Test Procedures

- 1. The testing follows FCC KDB Publication No. 558074 D01 DTS Meas. Guidance v04.
- 2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.
- 3. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- 4. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
- 5. Corrected Reading: Antenna Factor + Cable Loss + Read Level Preamp Factor = Level

  - (3) Set RBW = 1 MHz, VBW= 3MHz for  $f \ge 1$  GHz for peak measurement. For average measurement:
    - VBW = 10 Hz, when duty cycle is no less than 98 percent.
    - VBW ≥ 1/T, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.





#### For radiated emissions below 30MHz




#### For radiated emissions from 30MHz to 1GHz

# Emission below 1GHz 2.4GHz BLE (LF)




