2 Test Configuration of Equipment Under Test

2.1 Test Mode

Antenna port conducted and radiated test items were performed according to KDB 971168 D01 Power Meas. License Digital Systems v03r01 with maximum output power.

For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Z Plane) were recorded in this report.

Radiated emissions were investigated as following frequency range:

1. 30 MHz to 9000 MHz for GSM850

All modes, data rates and positions were investigated.



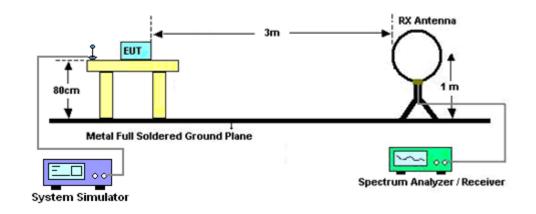




For radiated test below 30MHz

3.3 Test Result of Radiated Test

Please refer to Appendix A.

Note:

The low frequency, which started from 9 kHz to 30 MHz, was pre-scanned and the result which was 20 dB lower than the limit line was not reported.

There is a comparison data of both open-field test site and alternative test site - semi-Anechoic chamber according to 414788 D01 Radiated Test Site **v01r01**, and the result came out very similar.

3.4 Field Strength of Spurious Radiation Measurement

3.4.1 Description of Field Strength of Spurious Radiated Measurement

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitter power (P) by a factor of at least 43 + 10 log (P) dB. The spectrum is scanned from 30 MHz up to a frequency including its 10th harmonic.

3.4.2 Test Procedures

The testing follows FCC KDB 971168 D01 v03r01 Section 7 and ANSI / TIA-603-E Section 2.2.12.

- 1. The EUT was placed on a rotatable wooden table 0.8 meters for frequency below 1 GHz and 1.5 meter for frequency above 1 GHz above the ground.
- 2. The EUT was set 3 meters from the receiving antenna, which was mounted on the antenna tower.
- 3. The table was rotated 360 degrees to determine the position of the highest spurious emission.
- 4. The height of the receiving antenna is varied between one meter and four meters to search for the maximum spurious emission for both horizontal and vertical polarizations.
- Make the measurement with the spectrum analyzer's RBW = 1 MHz, VBW = 3 MHz, taking record of maximum spurious emission.
- 6. A horn antenna was substituted in place of the EUT and was driven by a signal generator.
- 7. Tune the output power of signal generator to the same emission level with EUT maximum spurious emission.
- 8. Take the record of output power at antenna port.
- 9. Repeat step 7 to step 8 for another polarization.
- 10. EIRP (dBm) = S.G. Power Tx Cable Loss + Tx Antenna Gain
- 11. ERP (dBm) = EIRP 2.15
- 12. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.
- 13. The limit line is derived from 43 + 10log(P) dB below the transmitter power P(Watts)
