2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4-2009, FCC CFR 47 Part 2, FCC CFR 47 Part 15, RSS-GEN Issue 3, and RSS-210 Issue 8.

3. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 47173 and 47266 Benicia Street, Fremont, California, USA. Line conducted emissions are measured only at the 47173 address. The following table identifies which facilities were utilized for radiated emission measurements documented in this report. 4. CALIBRATION AND UNCERTAINTY

4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

4.2. SAMPLE CALCULATION

Where relevant, the following sample calculation is provided:

Field Strength (dBuV/m) = Measured Voltage (dBuV) + Antenna Factor (dB/m) + Cable Loss (dB) – Preamp Gain (dB)

36.5 dBuV + 18.7 dB/m + 0.6 dB - 26.9 dB = 28.9 dBuV/m

4.3. MEASUREMENT UNCERTAINTY

Where relevant, the following measurement uncertainty levels have been estimated for tests performed on the apparatus:

5. EQUIPMENT UNDER TEST

5.1. DESCRIPTION OF EUT

This EUT is a GSM/WCDMA/LTE + BLUETOOTH, DTS/UNII a/b/g/n/ac , ANT+ and NFC.

The model FCC ID: PY7-PM0794 shares the same enclosure and circuit board as mode FCC ID: PY7-PM0793. The unlicensed radios (WLAN/BT/NFC/ANT+) including antenna and GPS receiver, are identical between the two units.

After confirming through preliminary radiated emissions that the performance of the FCC ID: PY7-PM0793 data remains representative of this model (FCC ID: PY7-PM0794), FCC ID: PY7-PM0794 leveraged test data from FCC ID: PY7-PM0793.

5.2. MAXIMUM OUTPUT POWER

The transmitter has a maximum peak conducted output power as follows:

Note: GFSK, Pi/4-DQPSK, 8PSK average Power are all investigated, The GFSK & 8PSK Power are the worst case. Testing is based on this mode to showing compliance. For average power data please refer to section 8.6.

5.3. DESCRIPTION OF AVAILABLE ANTENNAS

The radio utilizes an FPCB antenna, with a maximum gain of -1.4dBi.

5.4. WORST-CASE CONFIGURATION AND MODE

Radiated emission and power line conducted emission were performed with the EUT set to transmit at the channel with highest output power as worst-case scenario.

The fundamental of the EUT was investigated in three orthogonal orientations X,Y,Z, it was determined that X orientation was worst-case orientation; therefore, all final radiated testing was performed with the EUT in X orientation.

The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed.

TEST PROCEDURE

The transmitter output is connected to a spectrum analyzer. The span is set to 0 Hz, centered on a single, selected hopping channel. The width of a single pulse is measured in a fast scan. The number of pulses is measured in a 3.16 second scan, to enable resolution of each occurrence.

The average time of occupancy in the specified 31.6 second period (79 channels * 0.4 s) is equal to 10 * (# of pulses in 3.16 s) * pulse width.

TEST PROCEDURE

The EUT is placed on a non-conducting table 80 cm above the ground plane. The antenna to EUT distance is 3 meters. The EUT is configured in accordance with ANSI C63.4. The EUT is set to transmit in a continuous mode.

For measurements below 1 GHz the resolution bandwidth is set to 100 kHz for peak detection measurements or 120 kHz for quasi-peak detection measurements. Peak detection is used unless otherwise noted as quasi-peak.

For band edge measurements above 1 GHz the resolution bandwidth is set to 1 MHz, then the video bandwidth is set to 1 MHz for peak measurements and 1/T (on time) for average measurement. GFSK = 1/T = 1 / 0.002.867S = 350Hz.

The spectrum from 1GHzHz to 26 GHz is investigated with the transmitter set to the lowest, middle, and highest channels in the 2.4 GHz band.

The frequency range of interest is monitored at a fixed antenna height and EUT azimuth. The EUT is rotated through 360 degrees to maximize emissions received. The antenna is scanned from 1 to 4 meters above the ground plane to further maximize the emission. Measurements are made with the antenna polarized in both the vertical and the horizontal positions.
