





Fig.3 Right Head Section / Cheek-Touch Position







Fig.4 Right Head Section / Ear-Tilt Position(15°)






Fig.5 Left Head Section / Cheek-Touch Position




Fig.6 Left Head Section / Ear-Tilt Position(15°)




Fig.7 EUT front side to flat phantom






Fig.8 EUT back side to flat phantom

#### Hotspot mode - distance between flat phantom and mobile phone is 10 mm






Fig.9 EUT front to flat phantom







Fig.10 EUT back to flat phantom






Fig.11 EUT top to flat phantom




Fig.12 EUT bottom to flat phantom






Fig.13 EUT bottom with headset to flat phantom






Fig.14 EUT right to flat phantom






Fig.15 EUT left to flat phantom




Fig.18 Headset




Fig.19 Antenna position of EUT - End of Report -
