### 4. TPC and DFS MEASUREMENT

# 4.1. TPC: Standard Applicable

According to §15.407(h)(1), Transmit power control (TPC). U-NII devices operating in the 5.25-5.35 GHz band and the 5.47-5.725 GHz band shall employ a TPC mechanism. (i) In-service monitoring: an LE-LAN device should be able to monitor the operating channel to check that a co-channel radar has not moved or started operation within range of the LE-LAN device. 




#### Setup for Master with injection at the Master

## **4.2.4. Description of EUT:**

EUT operates over the 5250-5350MHz and 5470-5725MHz ranges and EUT is a slave device (client equipment) w/o radar detection and DFS capability. EUT has a gain of -0.34dBi in the 5GHz Band.

EUT has no TPC mechanism implemented with no adjustment of lowest, and highest power, but the level of power emission stays at fixed level.

The EUT utilizes the 802.11a architecture, with a nominal channel bandwidth of 40MHz WLAN traffic is generated by streaming the mpeg file from the master to slave in full monitor video mode using the media player.
