2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with FCC CFR 47 Part 2, FCC CFR 47 Part 15, and ANSI C63.10-2013.

3. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 47173 and 47266 Benicia Street, Fremont, California, USA. Line conducted emissions are measured only at the 47173 address. The following table identifies which facilities were utilized for radiated emission measurements documented in this report. 4. CALIBRATION AND UNCERTAINTY

4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

4.2. SAMPLE CALCULATION

Where relevant, the following sample calculation is provided:

$$\begin{aligned} \text{Field Strength (dBuV/m)} &= \text{Measured Voltage (dBuV)} + \text{Antenna Factor (dB/m)} + \\ &\text{Cable Loss (dB)} - \text{Preamp Gain (dB)} \\ 36.5 \text{ dBuV} + 18.7 \text{ dB/m} + 0.6 \text{ dB} - 26.9 \text{ dB} &= 28.9 \text{ dBuV/m} \end{aligned}$$

4.3. MEASUREMENT UNCERTAINTY

Where relevant, the following measurement uncertainty levels have been estimated for tests performed on the apparatus:

Radiated Disturbance, 6000 to 18000 MHz	4.23 dB
Radiated Disturbance, 18000 to 26000 MHz	5.30 dB
Radiated Disturbance, 26000 to 40000 MHz	5.23 dB

Uncertainty figures are valid to a confidence level of 95%.

5. EQUIPMENT UNDER TEST

5.1. DESCRIPTION OF EUT

The EUT is a GSM/WCDMA/LTE Phone with BT, DTS/UNII a/b/g/n/ac & NFC.

According to manufacturer attestation letter, FCC ID: PY7-PM0941 and FCC ID: PY7-PM0943 unlicensed radios (WLAN/BT/BLE/NFC) are electrically identical. They share the same chipset, same power and same antenna performance including antenna gain. The FCC ID: PY7-PM0941 test data shall remain representative of FCC ID: PY7-PM0943 so FCC ID: PY7-PM0943 leverage test data from FCC ID: PY7-PM0941.
