5 Electrical parameters on the tissueSimulating liquid

Prior to conducting SAR measurements, the relative permittivity, $\boldsymbol{\epsilon}_r$, and the conductivity, $\boldsymbol{\sigma}_r$, of the tissue simulating liquids were measured with the dielectric probe kit. These values are shown in the table below. The mass density, $\boldsymbol{\rho}_r$, entered into the DASY3 software is also given. Recommended limits for permittivity $\boldsymbol{\epsilon}_r$, conductivity $\boldsymbol{\sigma}_r$ and mass density $\boldsymbol{\rho}_r$ are also shown.

6 System accuracy verification

Checked

A system accuracy verification of the DASY3 was performed using the dipole validation kit listed in section 3.1. The system verification test was conducted on the same day as the measurement of the DUT. Measurement made in ambient temperature 23.2 °C and humanity 40.8%. The obtained results are displayed in the table below. RF noise had been measured in liquid when all RF equipment in lab was set off. Measured value was 0.001 mW/g in 1g mass.

8 Test results

The measured 1-gram averaged SAR values of the device against the head and the body are provided in Tables 1 and 2 respectively. The humidity and ambient temperature of test facility were 44.4% - 40.8% and 22.5 °C – 24.2 °C respectively. The depth of the head tissue simulating liquid was 15.1cm and of the muscle tissue simulating liquid was 15.5cm. A base station simulator was used to control the device during the SAR measurement. The phone was supplied with full-charged battery for each measurement.

For head measurement, the device was tested on the right-hand phantom (corresponding to the right side of the head) and the left-hand phantom in two phone position, cheek (touch) and tilt (cheek + 15deg). For GSM 1900 and GSM 850 modes, the device was tested at the lowest, middle and highest frequencies in the transmit band.
































