5 Electrical parameters on the tissue simulating liquid

Prior to conducting SAR measurements, the relative permittivity, ϵ_r , and the conductivity, σ , of the tissue simulating liquids were measured with the dielectric probe kit. These values are shown in the table below. The mass density, ρ , entered into the DASY4 software is also given.

Recommended limits for permittivity ϵ_r , conductivity σ and mass density ρ are also shown.

6 System accuracy verification

8 Test results

The measured 1-gram averaged SAR values of the device against head and body are provided in tables 1 and 2. The ambient humidity and temperature of test facility were 25%-35% and 22°C–23°C respectively. The depth of tissue simulating liquid for head and body are 15.2cm and 15.6cm. A base station simulator was used to control the device during the SAR measurement. The phone was supplied with full-charged battery for each measurement.

For head measurement, the device was tested on the right-hand phantom (corresponding to the right side of the head) and the left-hand phantom in two phone position, cheek (touch) and tilt (cheek + 15deg).

For body measurement phone was tested on the antenna (back) and Front against flat section of phantom with 15mm distance in both speech and Data (GPRS Class10 with Capability Class: B) mode. For all modes, the device was tested at the lowest, middle and highest frequencies in the transmit band. For Hands free used Sony Ericsson head set (HPB-60) and for Blue Tooth phone was paired with Sony Ericsson HBH-60 Blue Tooth accessory and measured on worst case speech mode and for body.

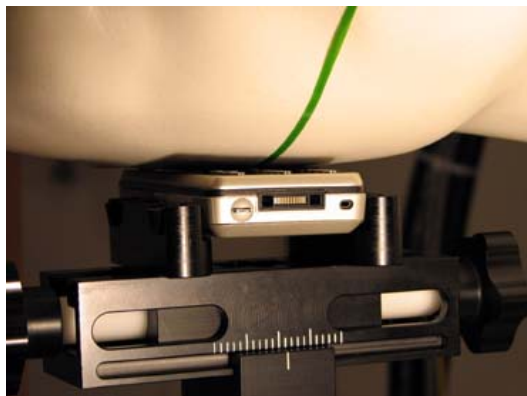

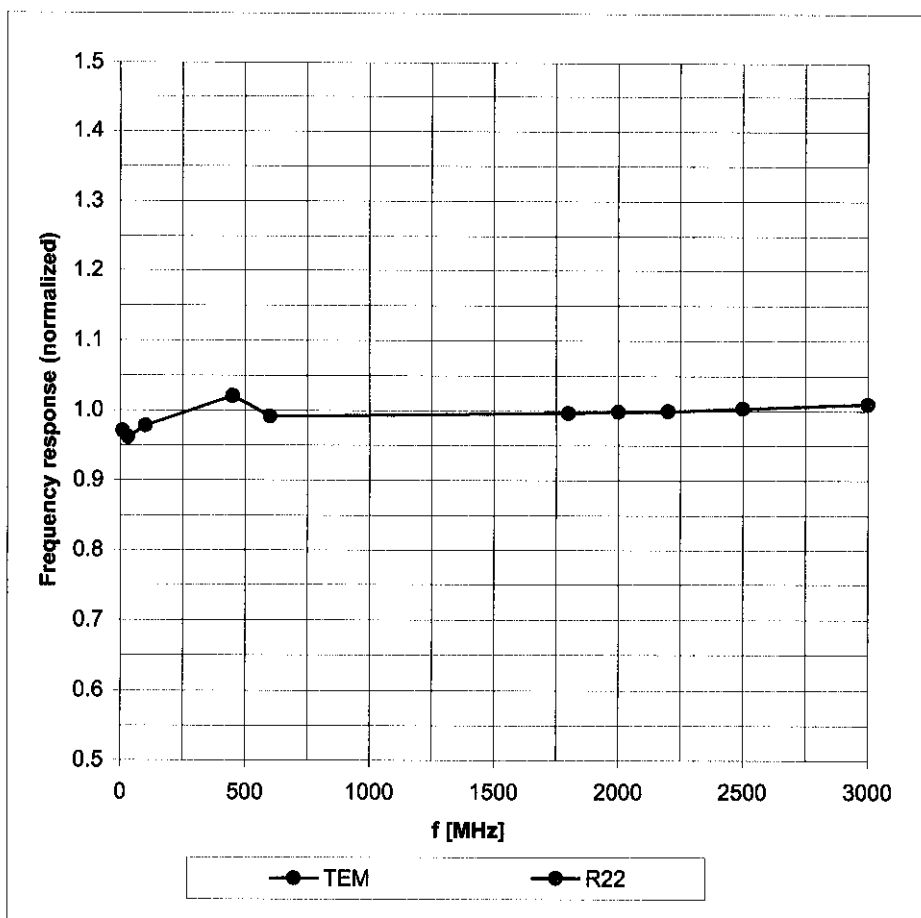

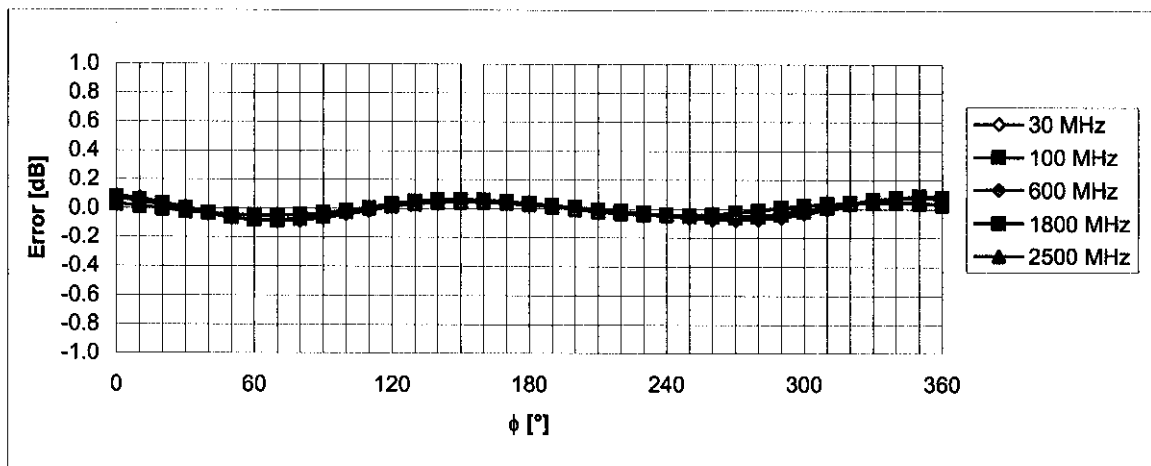
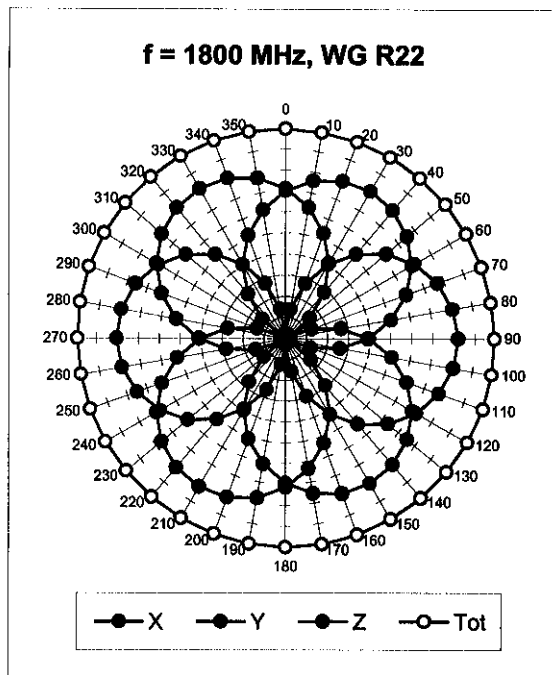
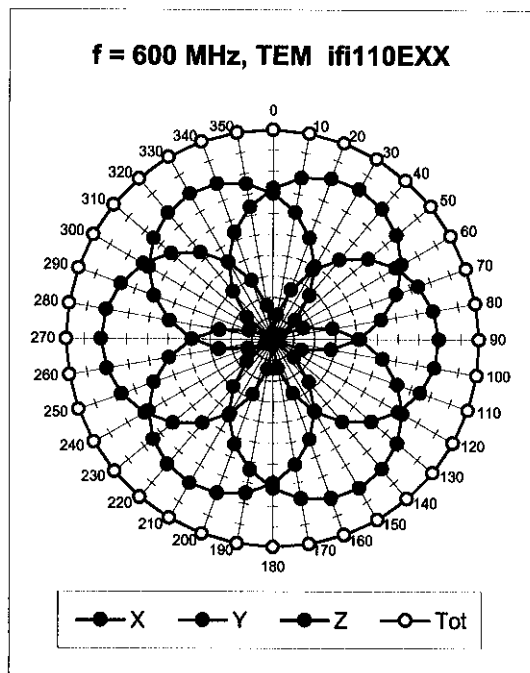
Frequency Response of E-Field

(TEM-Cell:ifi110 EXX, Waveguide: R22)



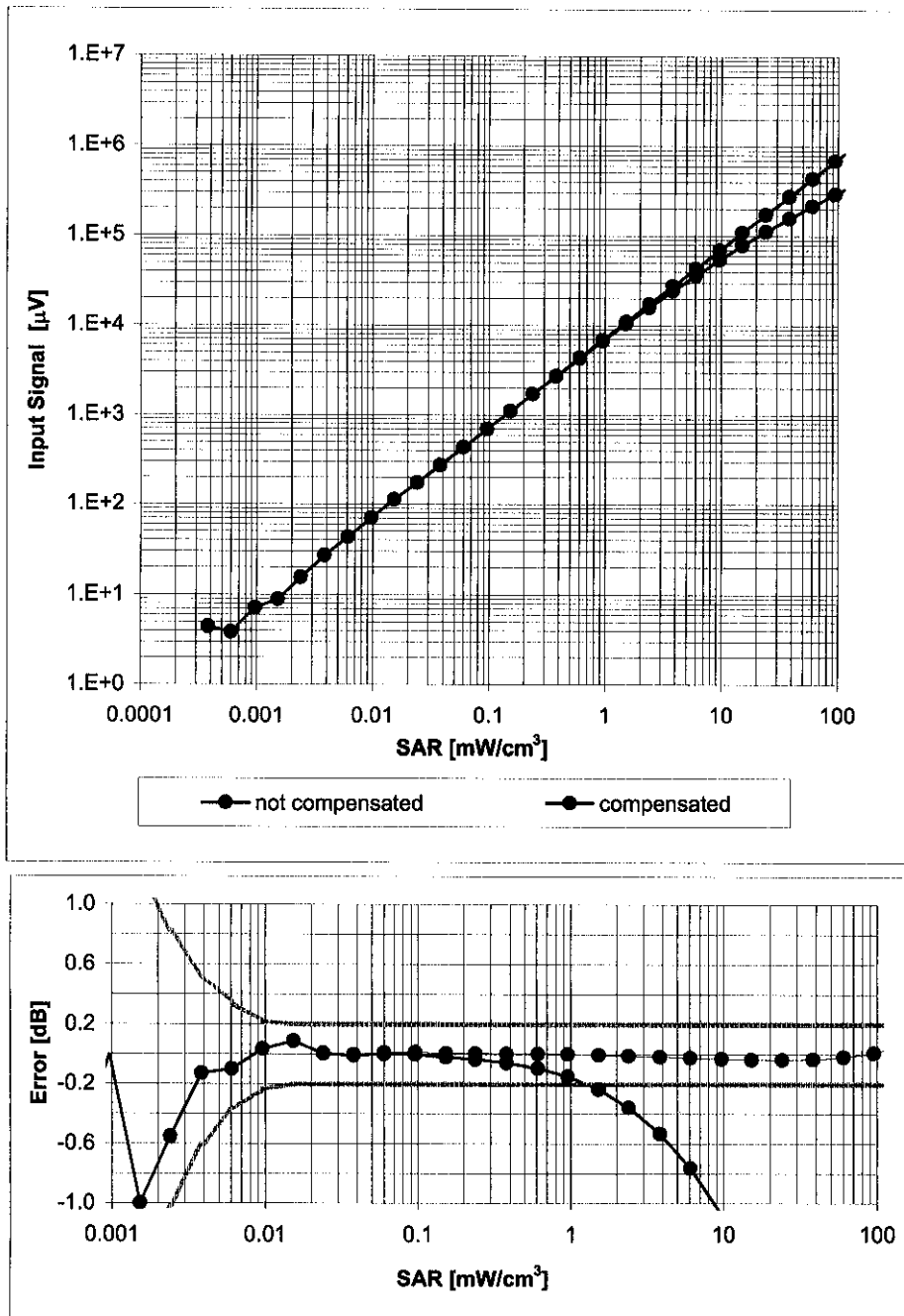
Uncertainty of Frequency Response of E-field: $\pm 6.3\%$ ($k=2$)

Receiving Pattern (ϕ), $\theta = 0^\circ$



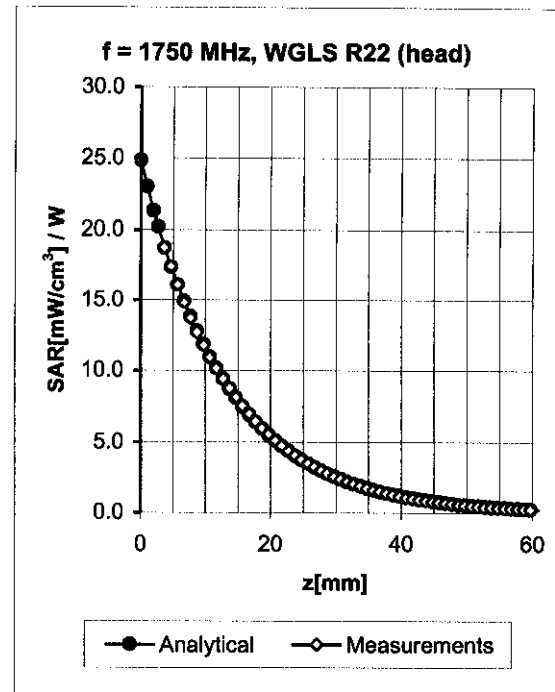
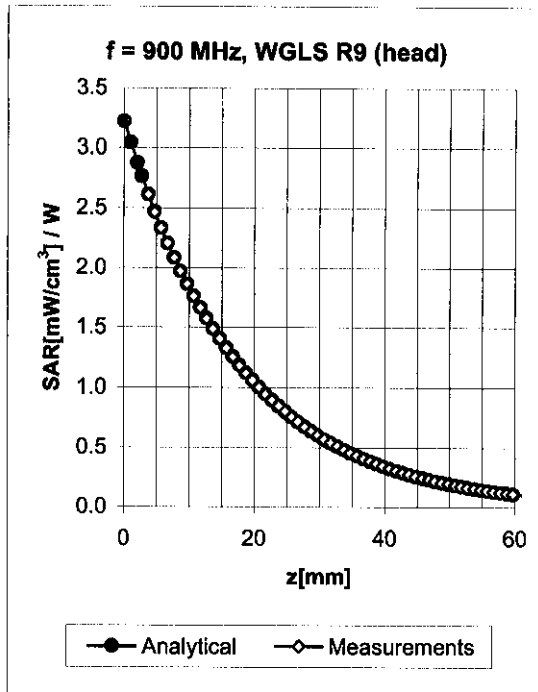
Uncertainty of Axial Isotropy Assessment: $\pm 0.5\%$ ($k=2$)

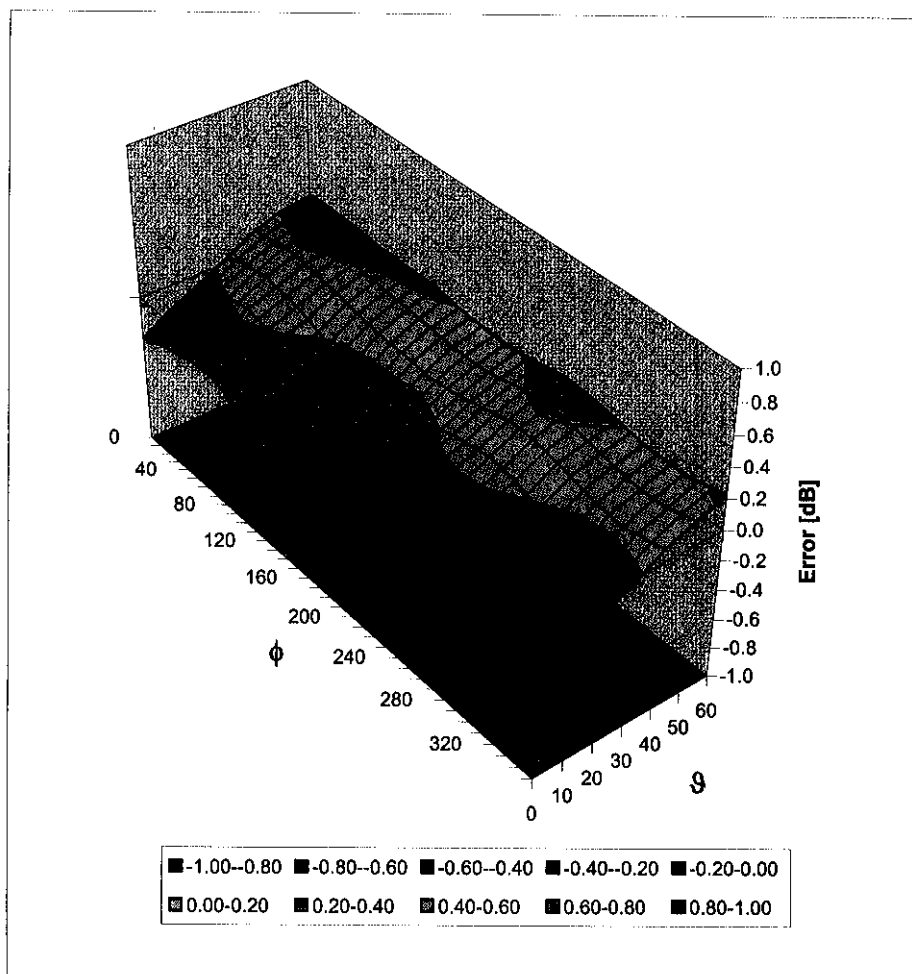

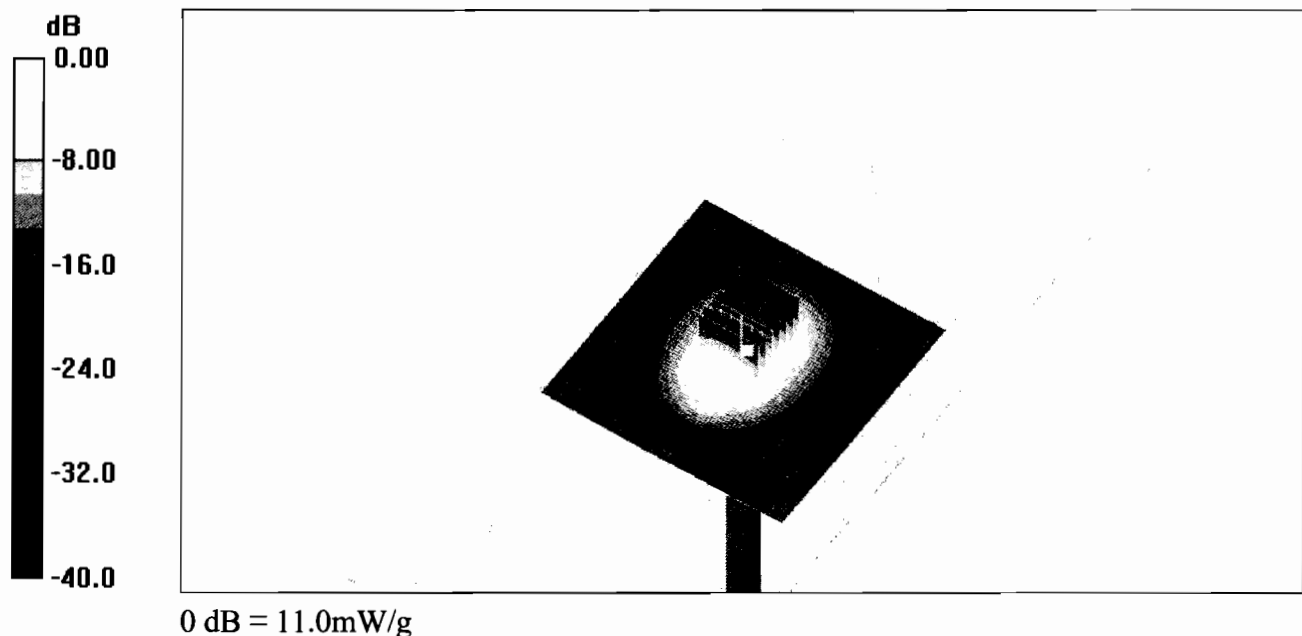

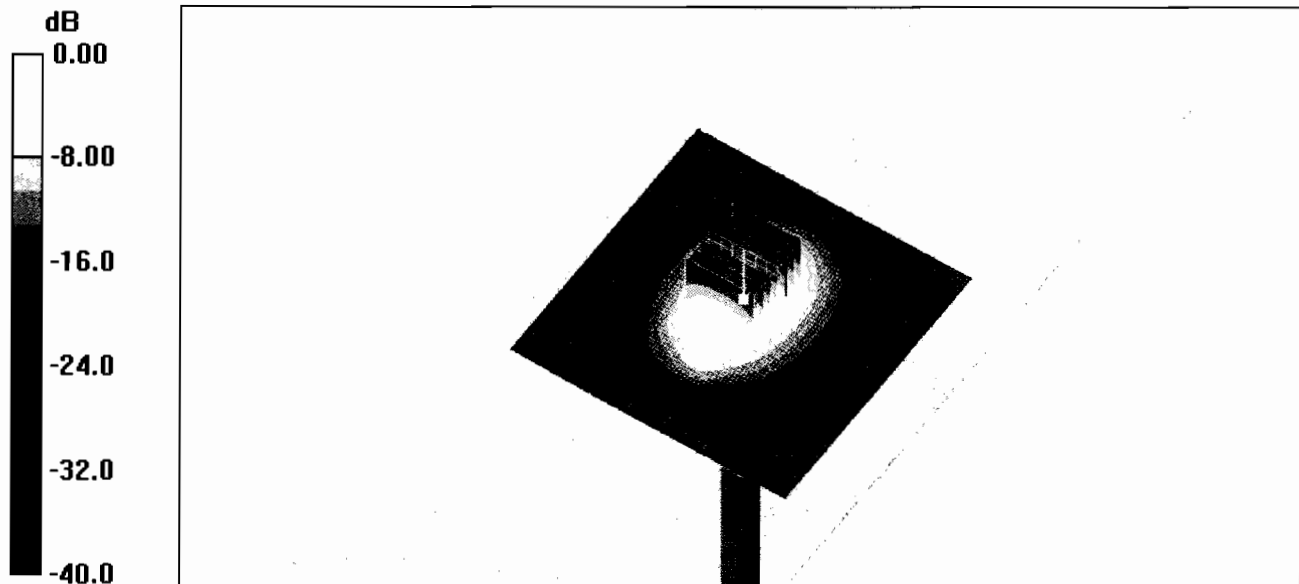
