<b>Line 7a</b> (30,0/6,0)	Supplier's identification for trace-ability of the telephone, as desired by supplier (e.g. "S/N: nnn...." for serial number).	Text, height 1,5 mm. Defined by supplier.
<b>Line 7b</b> (30,0/20,0)	Actual electronic serial number (IMEI) of the mobile phone, "00000000-000000-0"	Text, height 1,5mm. In the format TAC-SNR-CD. TAC and SNR derived from pos 500 in BOM. CD = check digit according to the Luhn formula (ISO/IEC 7812), GSM 02.16.
<b>Line 8</b> (33,06,0)	Line 8 in bar code, according to line 7b. As desired by supplier (e.g. only actual number).	Bar code, height 2,0 mm. As desired by supplier (e.g. Code 128 symbology).
<b>Line 9a</b> (47,0/4,0)	CE approval symbol, the NB-"0682" and "Alert Symbol" in one artwork	Graphics, height 5 mm. According to 1242-7470
<b>Line 9b</b> (47,0/33,5)	WEEE trashcan without bar symbol	Graphics, min. height 5mm, according to 1202-5537.
