

## 2. SYSTEM TEST CONFIGURATION

### 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

### 2.2. EUT Exercise

The EUT (Transmitter) was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements.

### 2.3. Test Procedure

#### 2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. According to the requirements in Section 7 and 13 of ANSI C63.4: 2003 & ANSI 63.10:2009. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-Peak and Average detector mode.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna. according to the requirements in Section 8 and 13 and Subclause 8.3.1.2 of ANSI C63.4: 2003, ANSI 63.10:2009. and DA 00-705.

Fig. 2-1 AC Power line, Conducted emission and Radiated Emission Configuration

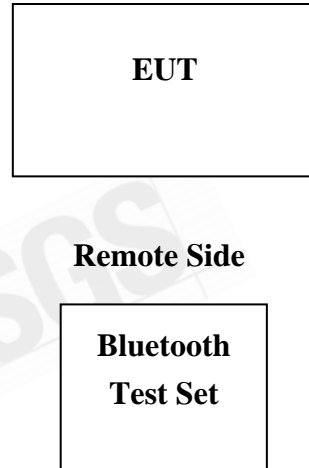

### 4. DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition. Test program used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

Channel Low, Mid and High with highest rated data rate were chosen as worst case for full testing. The field strength of spurious radiation emission was measured as EUT stand-up position (H mode) and lie down position (E1, E2 mode) for Bluetooth Transmitter for channel Low, Mid and High the worst case H position was reported.

## Peak Power Output Data Plot (CH Mid) (BDR mode)

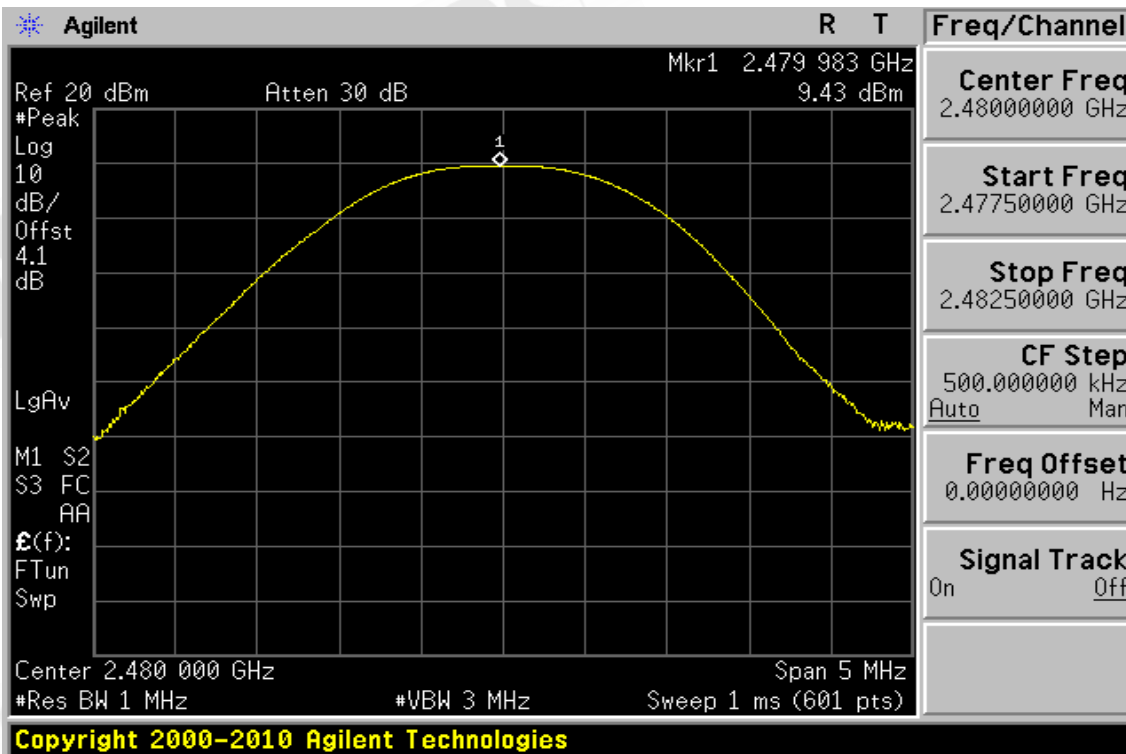

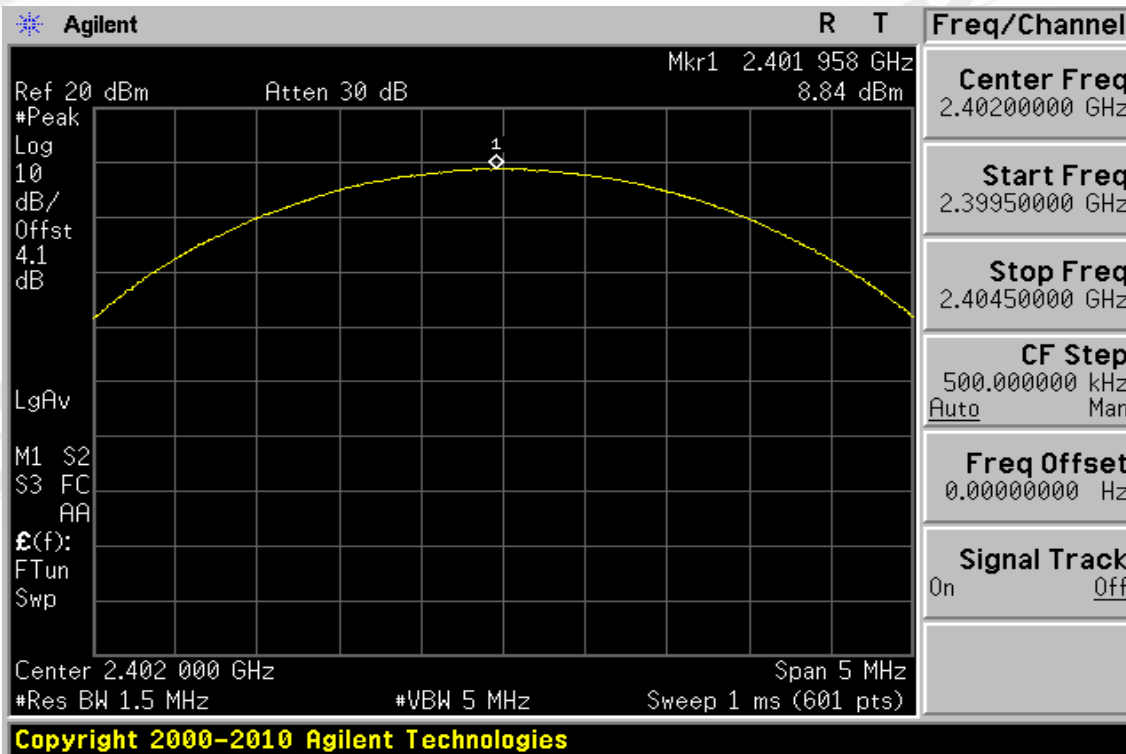

## Peak Power Output Data Plot (CH Low) (EDR mode)

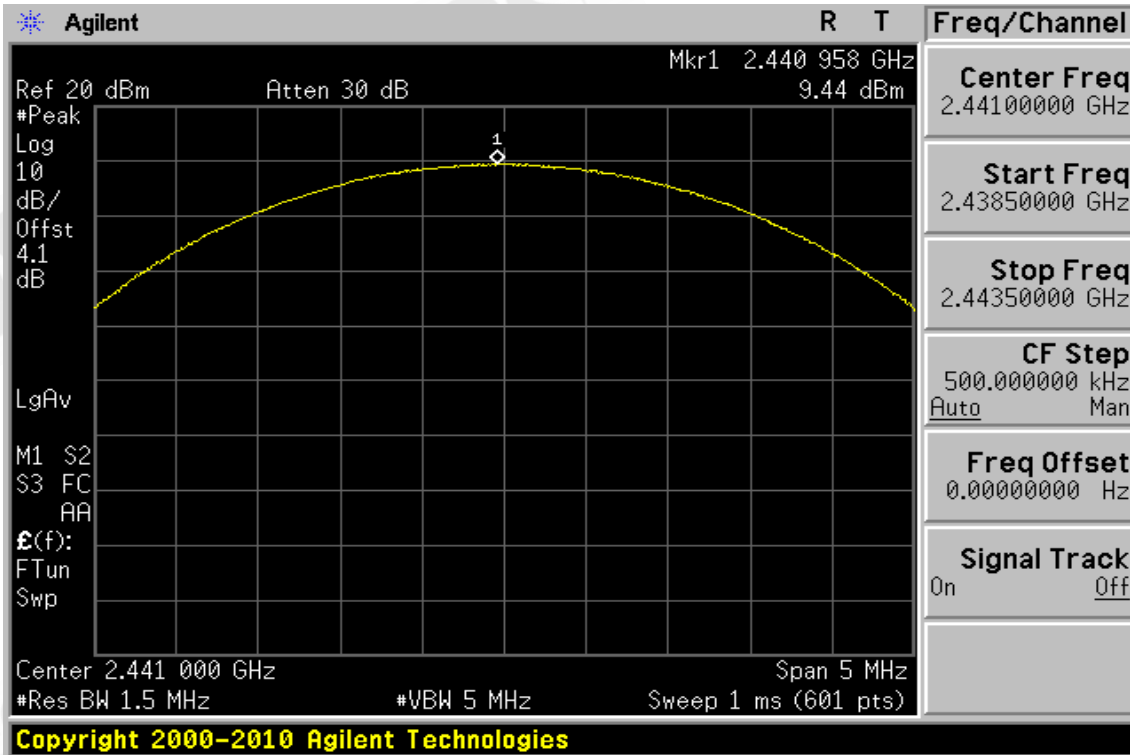

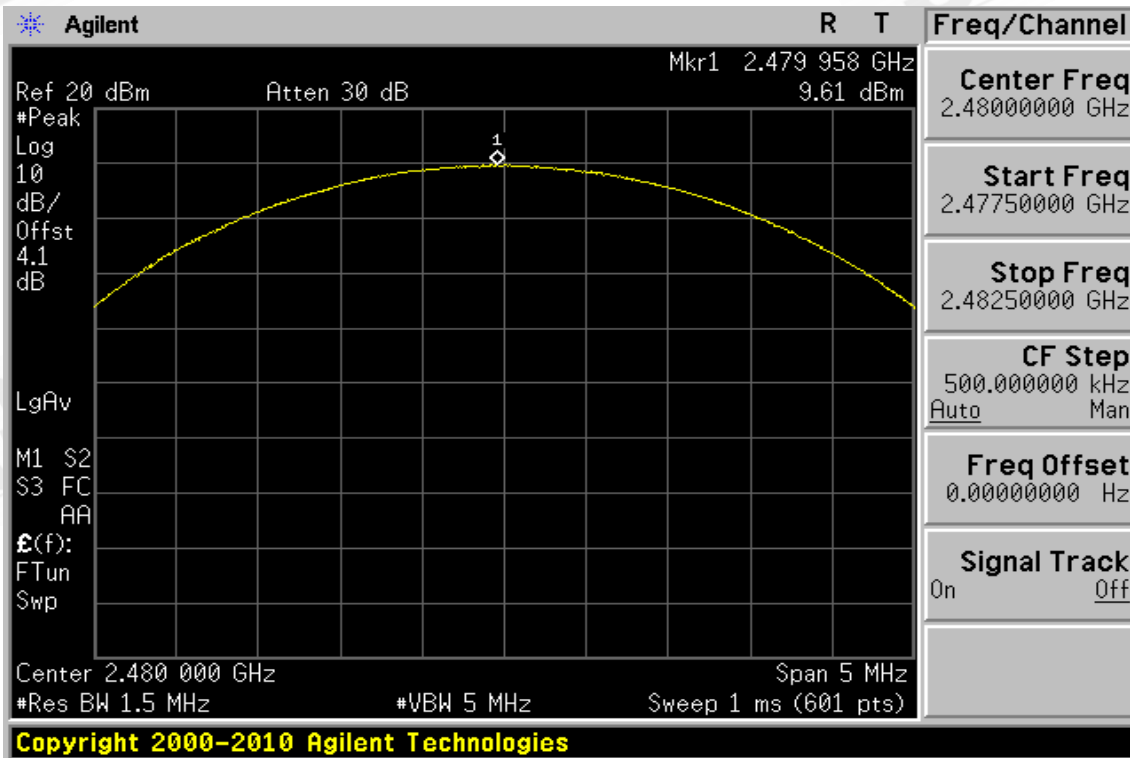

### 8.1. Standard Applicable

For 20dB Bandwidth

According to §15.247(a)(1) and RSS210 A8.1(b), for frequency hopping systems operating in the 2400MHz-2483.5 MHz no limit for 20dB bandwidth.

For 99% Bandwidth

RSS-Gen §4.6.1, the transmitter shall be operated at its maximum carrier power measured under normal test conditions. The span of the analyzer shall be set to capture all products of the modulation process, including the emission skirts. The resolution bandwidth shall be set to as close to 1% of the selected span as is possible without being below 1%. The video bandwidth shall be set to 3 times the resolution bandwidth. Video averaging is not permitted. Where practical, a sampling detector shall be used since a peak or, peak hold, may produce a wider bandwidth than actual.

The trace data points are recovered and are directly summed in linear terms. The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5% of the total is reached and that frequency recorded. The process is repeated for the highest frequency data points. This frequency is recorded.

The span between the two recorded frequencies is the occupied bandwidth.

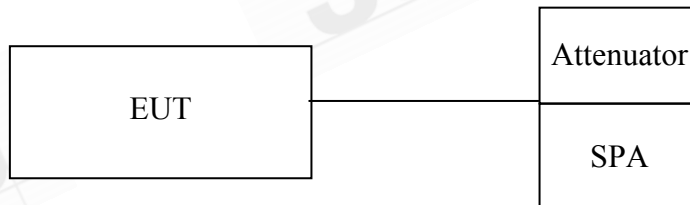

## 9. 100KHz BANDWIDTH OF BAND EDGES and Out-Of-Band EMISSION MEASUREMENT

### 9.1. Standard Applicable

In addition, radiated emissions which fall in the restricted bands of Table 3 must also comply with the radiated emission limits specified in Tables 5 and 6 of RSS-GEN.

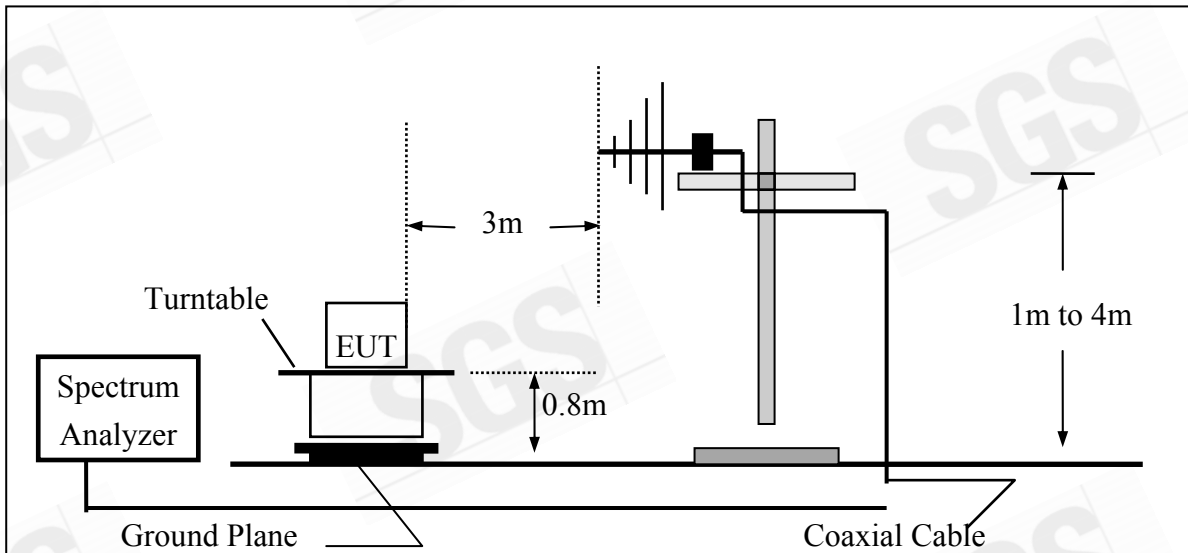

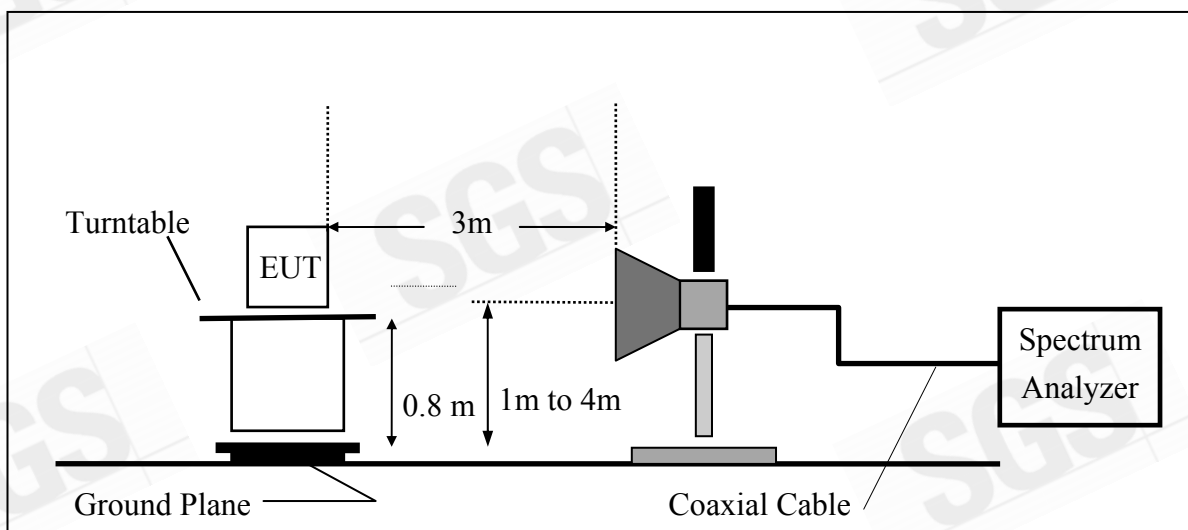

#### 10.4. Measurement Procedure:

##### Radiated Emission:

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
4. When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made “while keeping the antenna in the ‘cone of radiation’ from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response.” is still within the 3dB illumination BW of the measurement antenna.
5. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
6. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
7. Repeat above procedures until all frequency measured were complete.

#### 10.5. Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain and Duty Cycle Correction Factor(if any) from the measured reading. The basic equation with a sample calculation is as follows:

## 14. ANTENNA REQUIREMENT

### 14.1. Standard Applicable

For intentional device, according to §15.203, an intentional radiator shall be designed to ensure that no antenna other than furnished by the responsible party shall be used with the device.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by

1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

According to RSS-GEN 7.1.2, a transmitter can only be sold or operated with antennas with which it was certified. A transmitter may be certified with multiple antenna types. An antenna type comprises antennas having similar in-band and out-of-band radiation patterns. Testing shall be performed using the highest-gain antenna of each combination of transmitter and antenna type for which certification is being sought, with the transmitter output power set at the maximum level. Any antenna of the same type and having equal or lesser gain as an antenna that had been successfully tested for certification with the transmitter, will also be considered certified with the transmitter, and may be used and marketed with the transmitter. The manufacturer shall include with the application for certification a list of acceptable antenna types to be used with the transmitter.

When a measurement at the antenna connector is used to determine RF output power, the effective gain of the device's antenna shall be stated, based on measurement or on data from the antenna manufacturer. Any antenna gain in excess of 6 dBi (6 dB above isotropic gain) shall be added to the measured RF output power before using the power limits specified in RSS-210 or RSS-310 for devices of RF output powers of 10 milliwatts or less. For devices of output powers greater than 10 milliwatts, except devices subject to RSS-210 Annex 8 (Frequency Hopping and Digital Modulation Systems Operating in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz Bands) or RSS-210 Annex 9 (Local Area Network Devices), the total antenna gain shall be added to the measured RF output power before using the specified power limits. For devices subject to RSS-210 Annex 8 or Annex 9, the antenna gain shall not be added.

### 14.2. Antenna Connected Construction

The directional gains of antenna used for transmitting is 0.68 dBi, and the antenna connector is designed with permanent attachment and no consideration of replacement. Please see EUT photo for details.
