













Fig.3 Right Head Section / Cheek-Touch Position







Fig.4 Right Head Section / Ear-Tilt Position(15°)






Fig.5 Left Head Section / Cheek-Touch Position






Fig.6 Left Head Section / Ear-Tilt Position(15°)



Body worn speech mode- distance between flat phantom and mobile phone is 15 mm







Fig.7 EUT front side with headset (MH410C) to flat phantom






Fig.8 EUT back side with headset (MH410C) to flat phantom

Hotspot mode - distance between flat phantom and mobile phone is 10 mm






Fig.9 EUT front to flat phantom






Fig.10 EUT back to flat phantom






Fig.11 EUT back side with headset (MH410C) to flat phantom






Fig.12 EUT top to flat phantom






Fig.13 EUT bottom to flat phantom






Fig.14 EUT right to flat phantom






Fig.15 EUT left to flat phantom








Fig.20 Headset (Model No.: MH410C, Supplier: Foster Electric, Type No.: AG-1100)




Fig.21 Antenna position of EUT
