1.2. Related Submittal(s) / Grant (s)

1.3. Test Methodology

Both conducted and radiated testing were performed according to the procedures in ANSI C63.4:2009 & ANSI C63.10:2009. Radiated testing was performed at an antenna to EUT distance 3 meters.

1.4. Test Facility

The measurement facilities used to collect the 3m Radiated Emission and AC power line conducted data are located on the address of SGS Taiwan Ltd. Electronics & Communication Laboratory No. 134, Wu Kung Rd., Wuku Industrial Zone, Taipei Country, Taiwan which are constructed and calibrated to meet the FCC requirements in documents ANSI C63.4: 2009 & ANSI C63.10:2009. FCC Registration Number are: 990257, Canada Registration Number: 4620A-4.

Fig. 2-1 Radiated Emission




Fig. 2-2 Conducted (Antenna Port) Configuration




Fig. 2-3 AC Power Line Conducted Emission





7. RADIATED EMISSION TEST

7.1 Measurement Procedure

- The EUT was placed on a turn table which is 0.8m above ground plane.
- 2 The turn table shall rotate 360 degrees to determine the position of maximum emission level.
- EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.








