Fig. 2-1 Radiated Emission

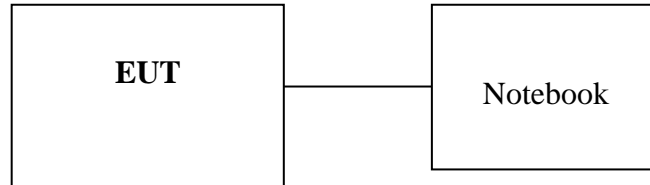


Fig. 2-2 Conducted (Antenna Port) Configuration

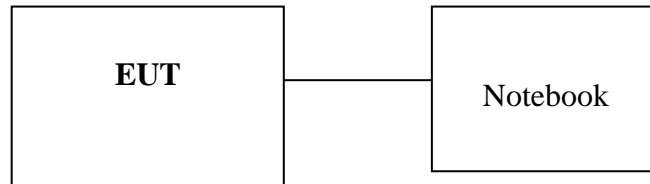


Fig. 2-3 AC Power Line Conducted Emission

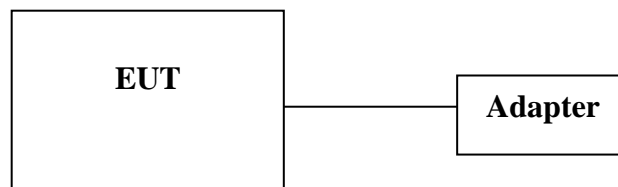

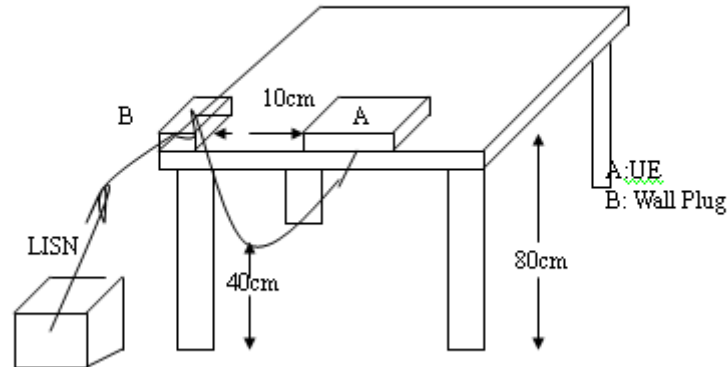

7. RADIATED EMISSION TEST

7.1 Measurement Procedure

- 1 The EUT was placed on a turn table which is 0.8m above ground plane.
- 2 The turn table shall rotate 360 degrees to determine the position of maximum emission level.
- 3 EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
- 4 When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made “while keeping the antenna in the ‘cone of radiation’ from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response.” is still within the 3dB illumination BW of the measurement antenna.
- 5 Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 6 And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 7 Repeat above procedures until all frequency of the interest measured were complete.

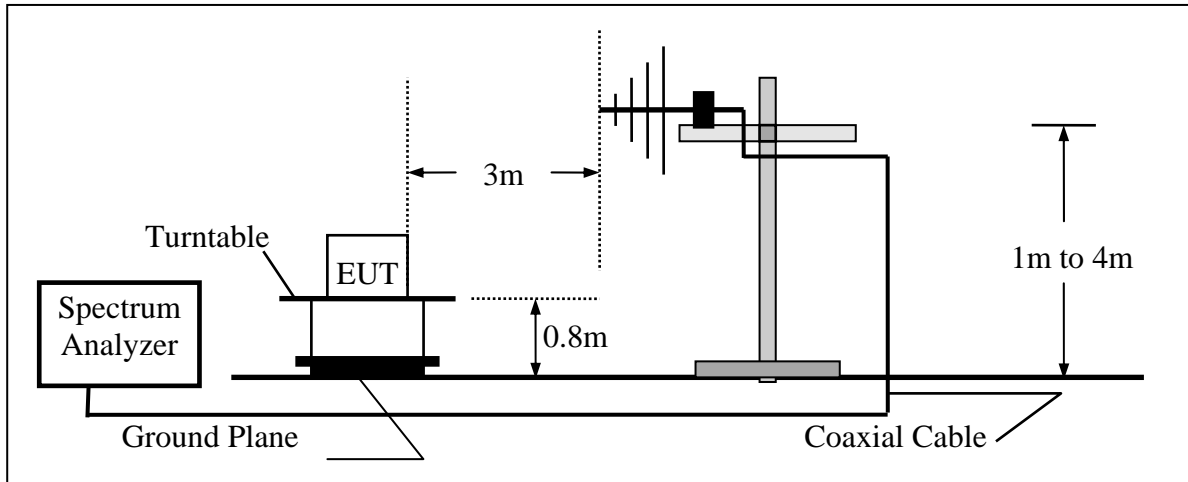

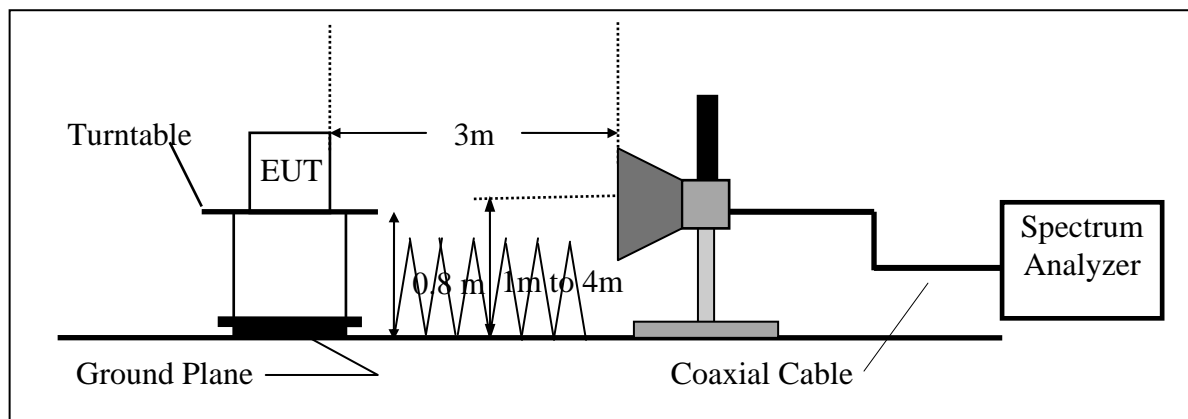

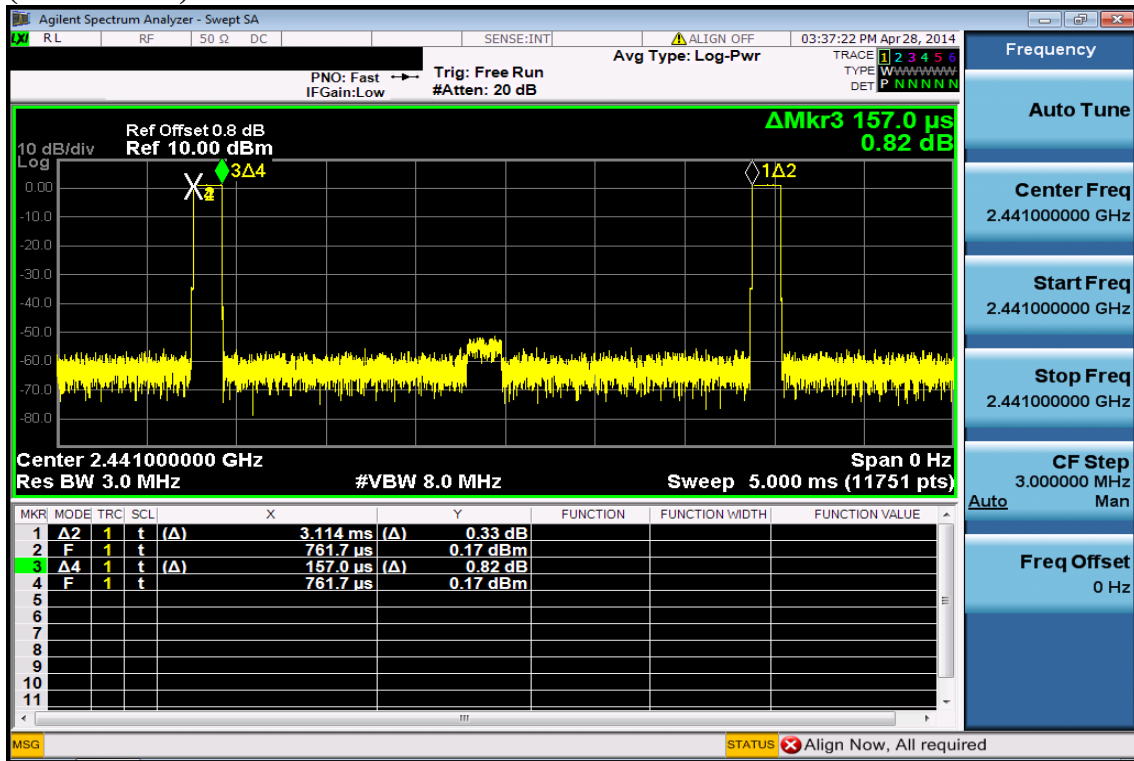

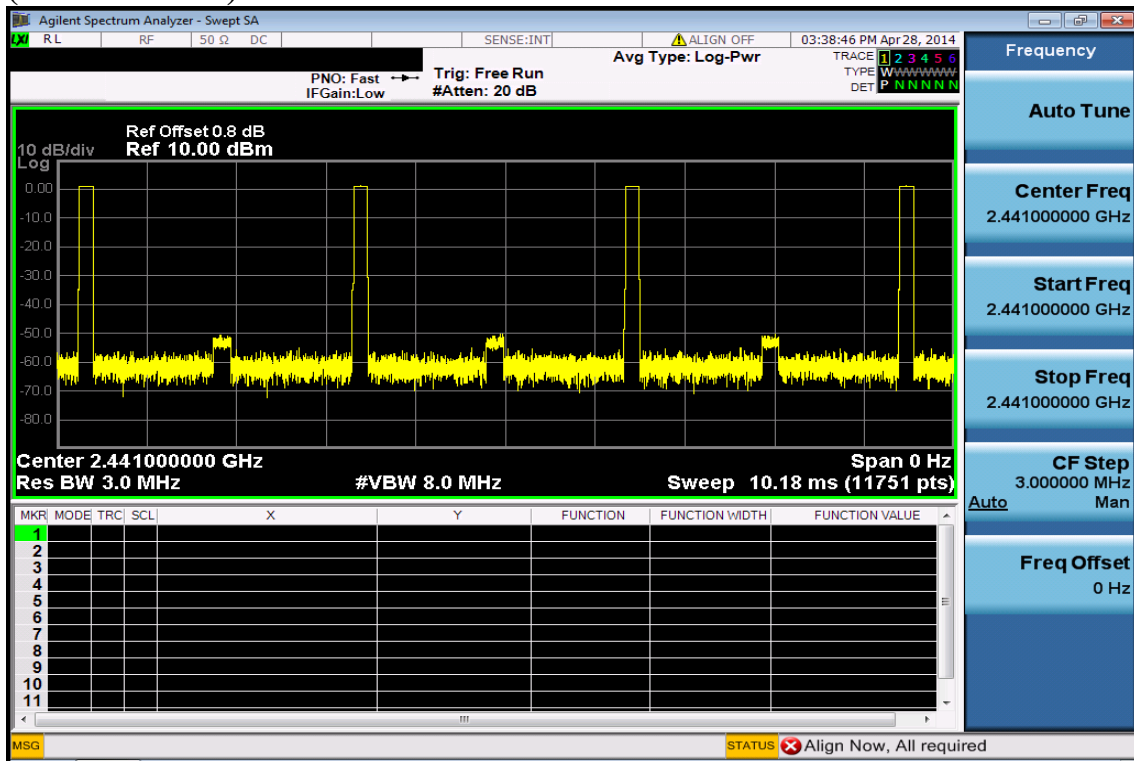
