





AC 120V/60 Hz, Line







Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All final data was recorded in Quasi-peak detection mode for frequency range of 30 MHz -1 GHz and peak and Average detection modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:






Middle Channel



Low Channel




Middle Channel






Pulse time, Low Channel

Number of hops on spectrum analyzer






Pulse time, Middle Channel





Sweep time 6.4s




Pulse time, High Channel

Number of hops on spectrum analyzer




Band Edge-Left Side
