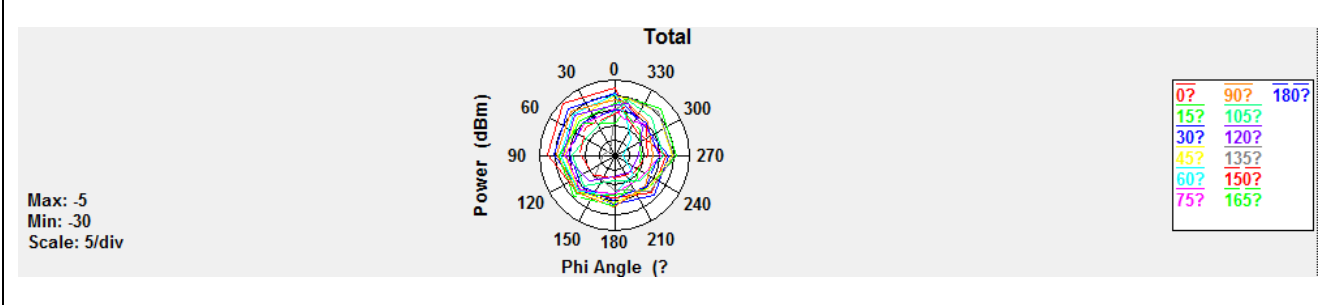

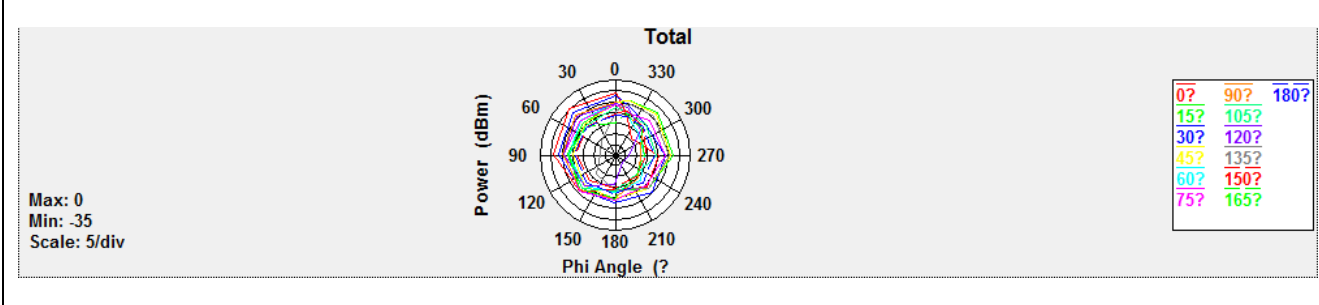

**2D POLAR RADIATION PATTERN**

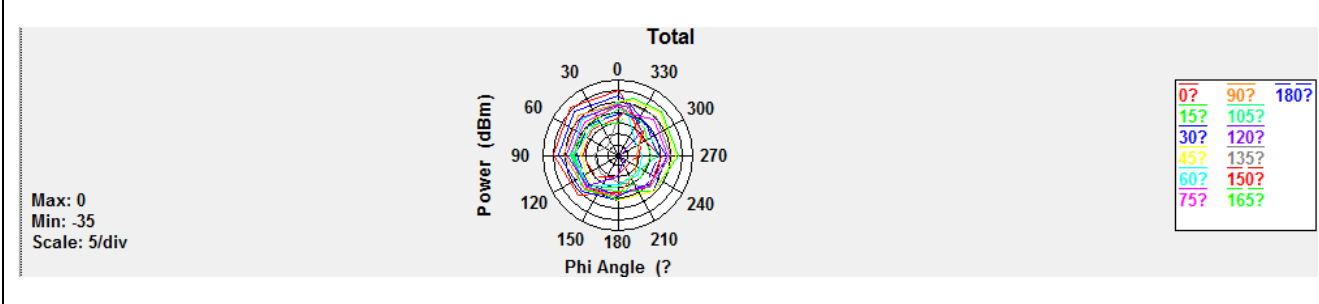

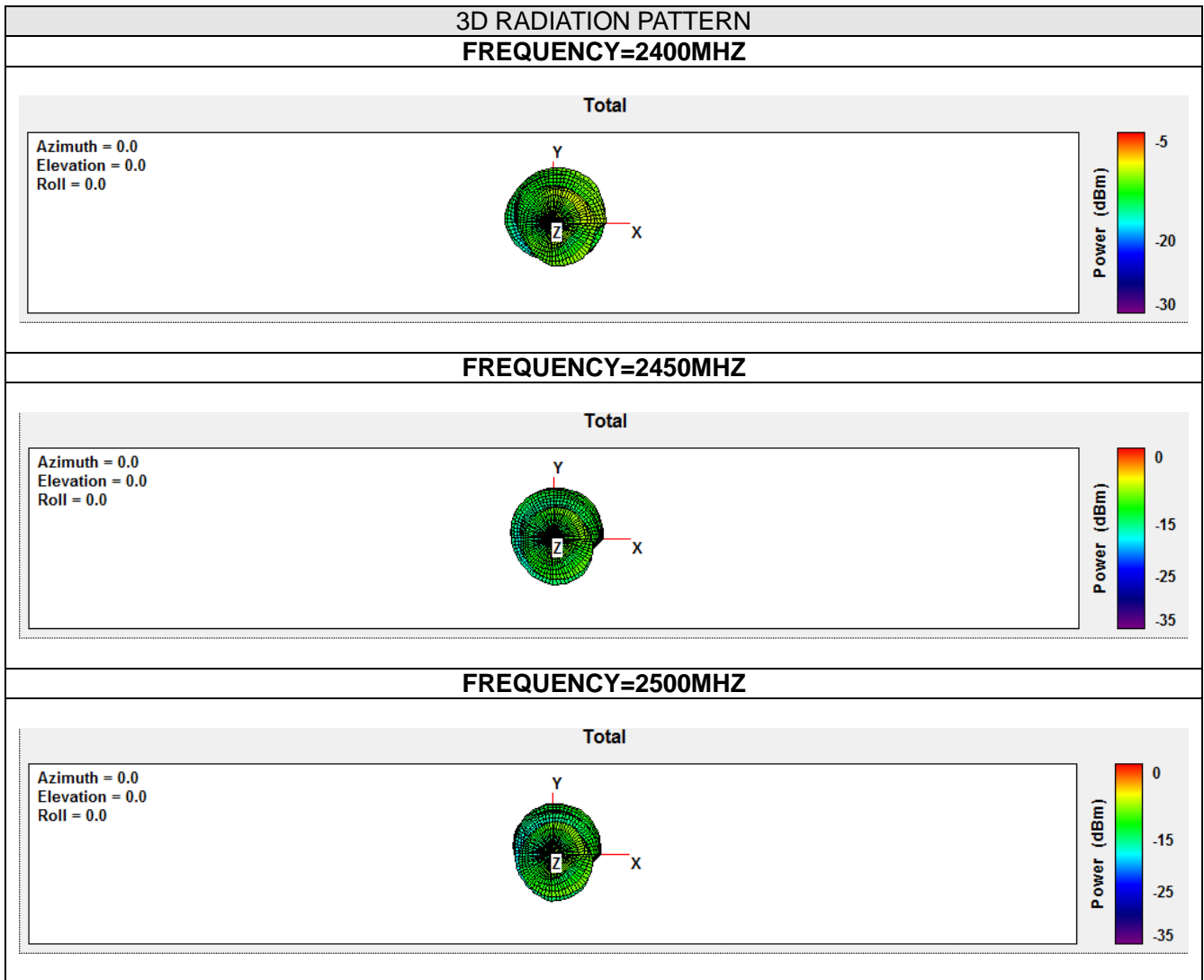
**FREQUENCY=2450MHZ**



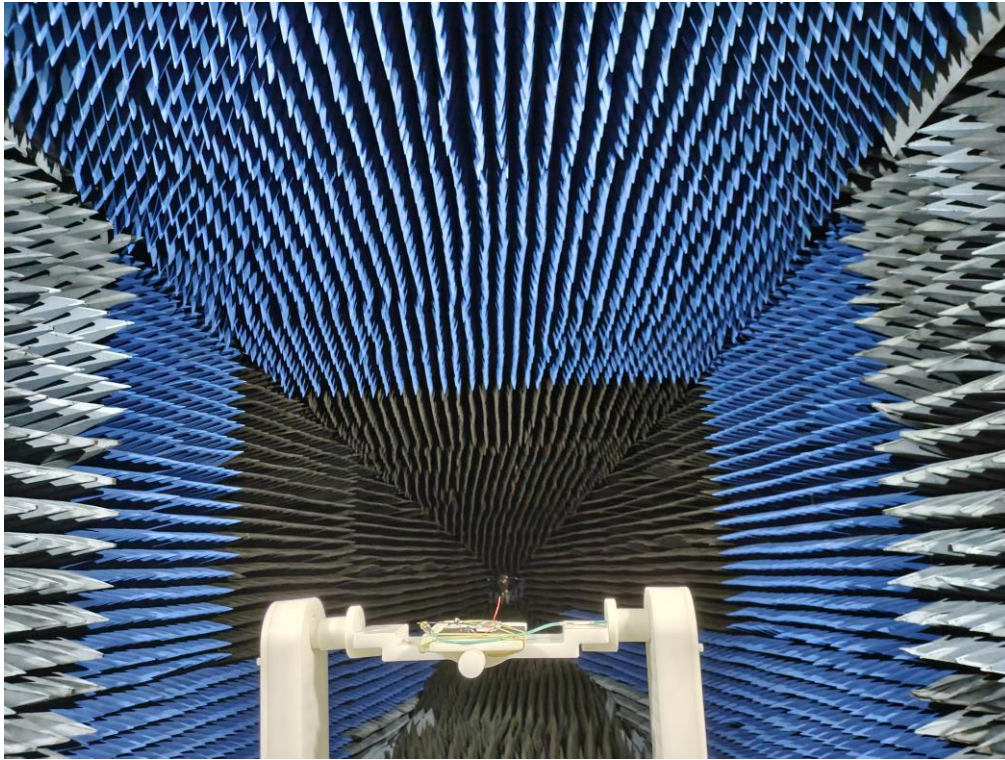

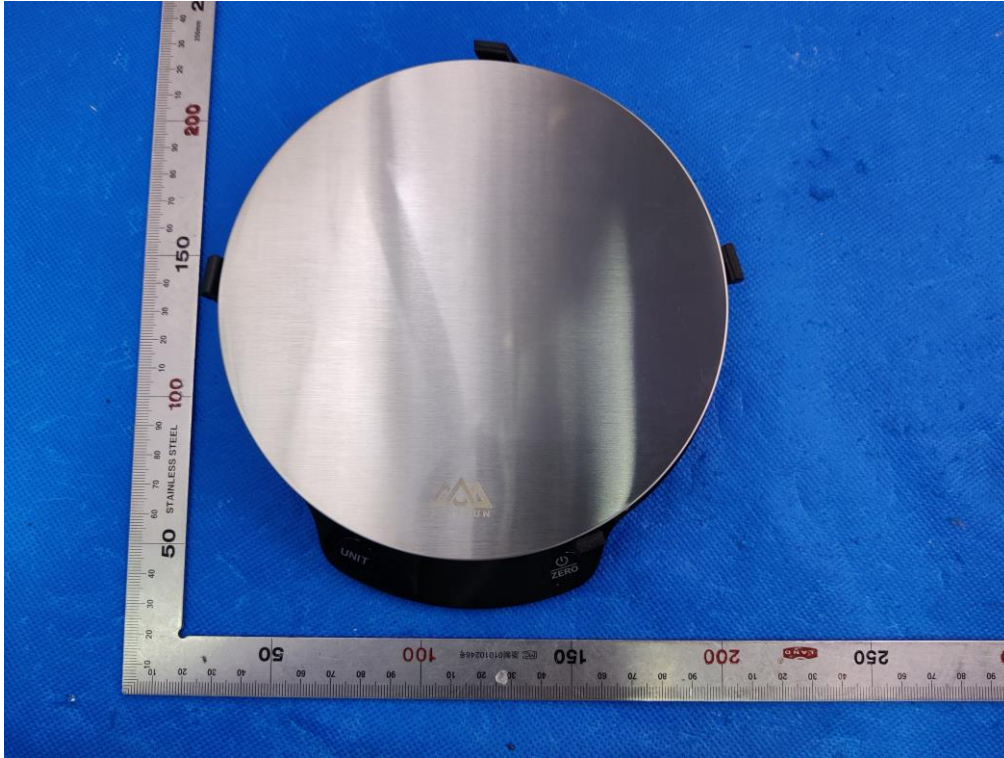

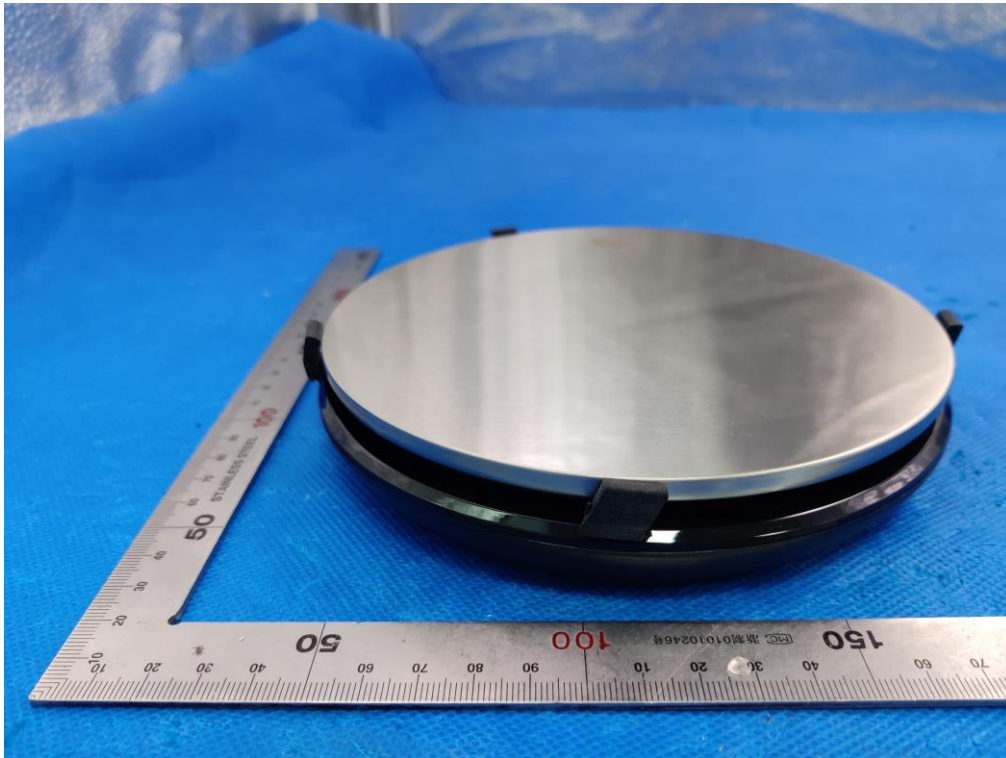
### BOTTOM VIEW OF EUT



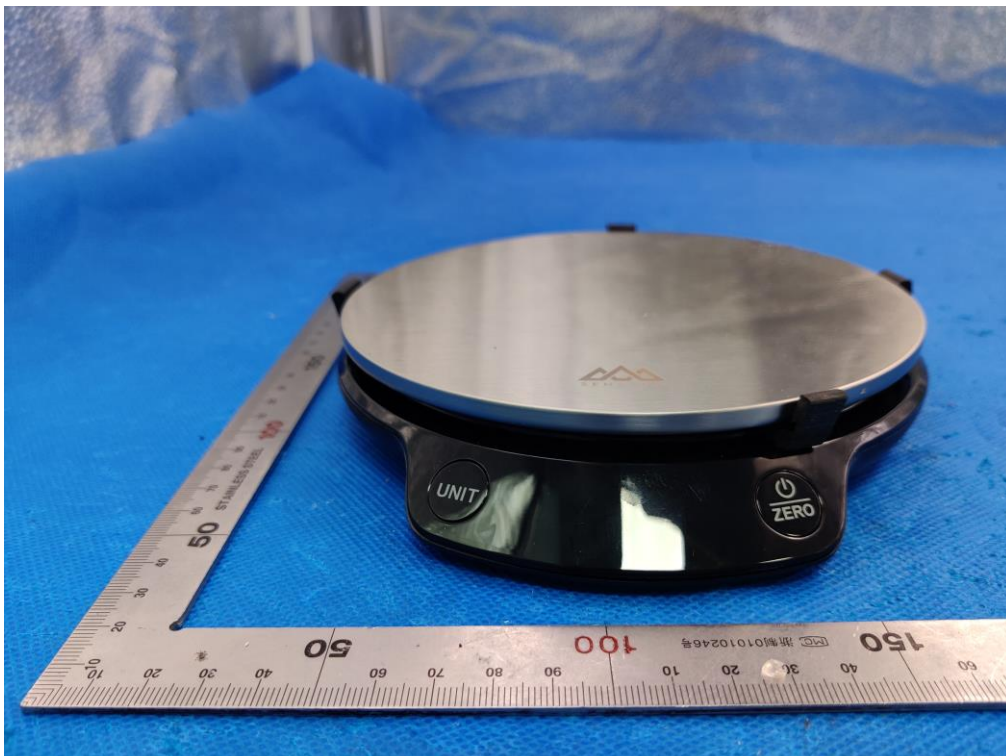

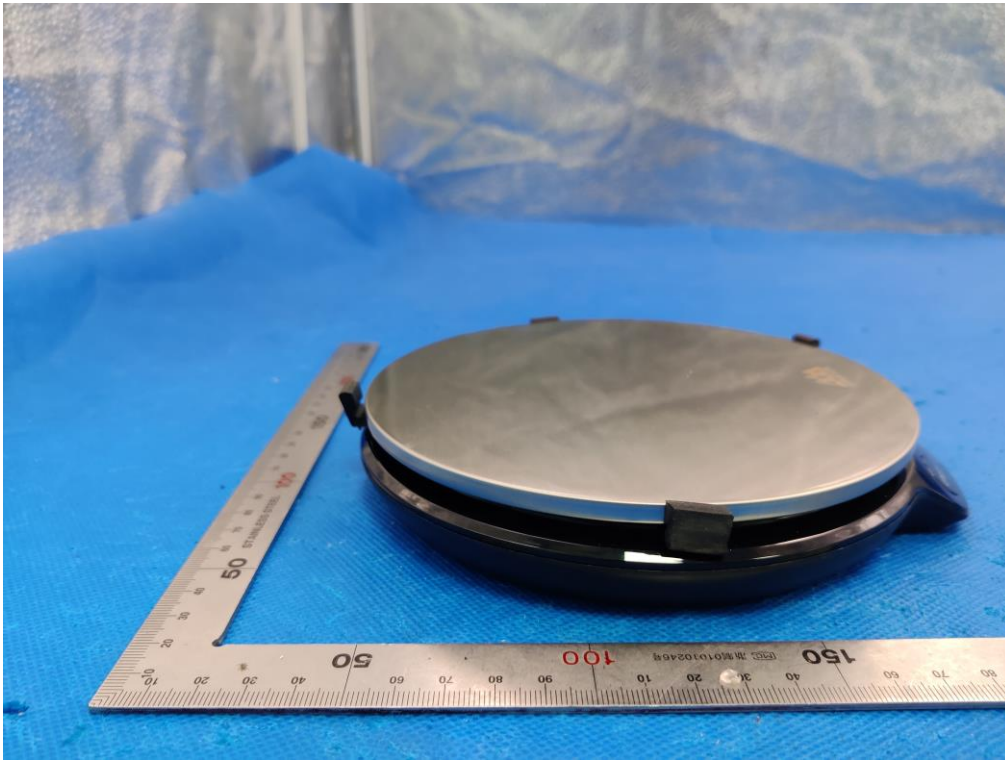

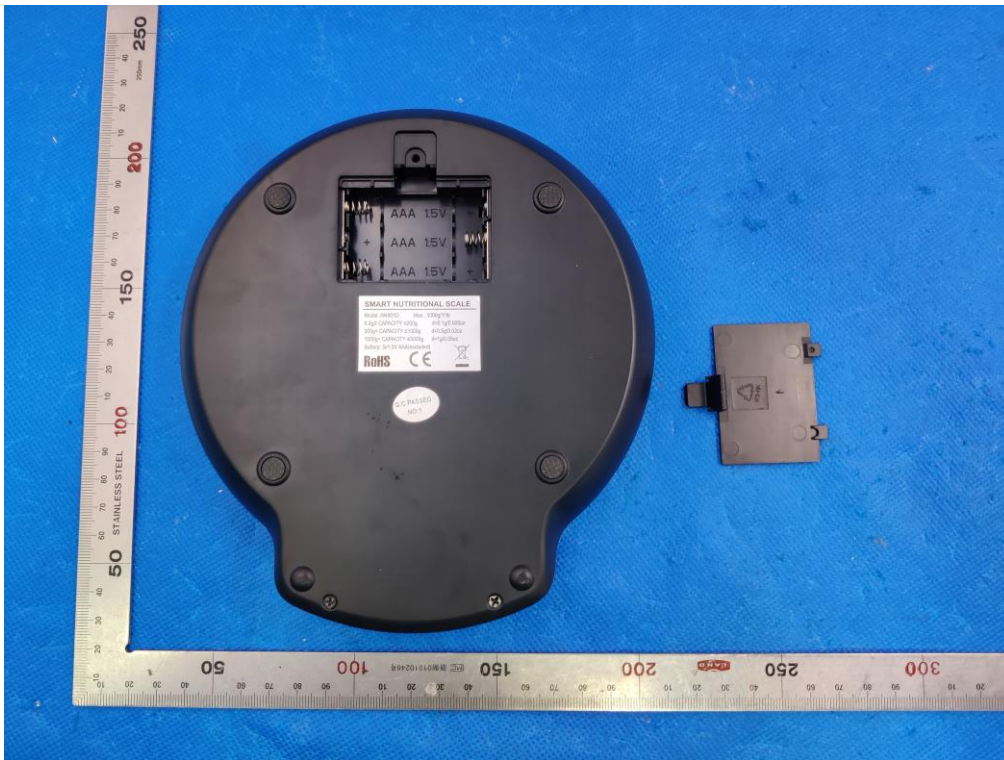


## RIGHT VIEW OF EUT

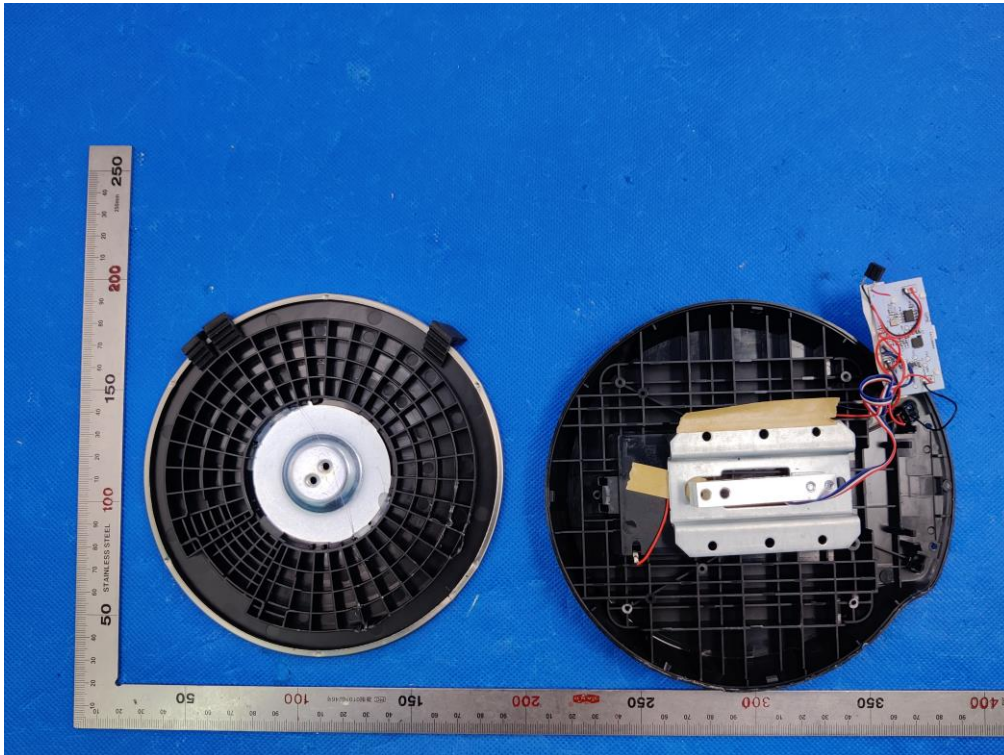

OPEN VIEW OF EUT (FIGURE 1)

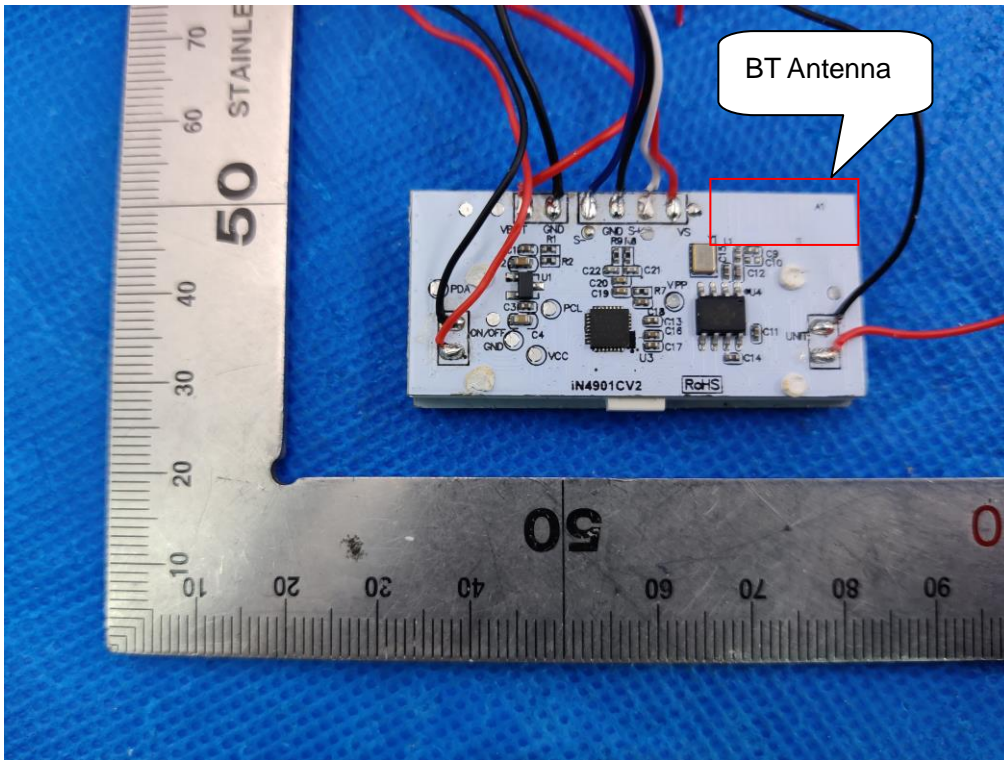


OPEN VIEW OF EUT (FIGURE 2)

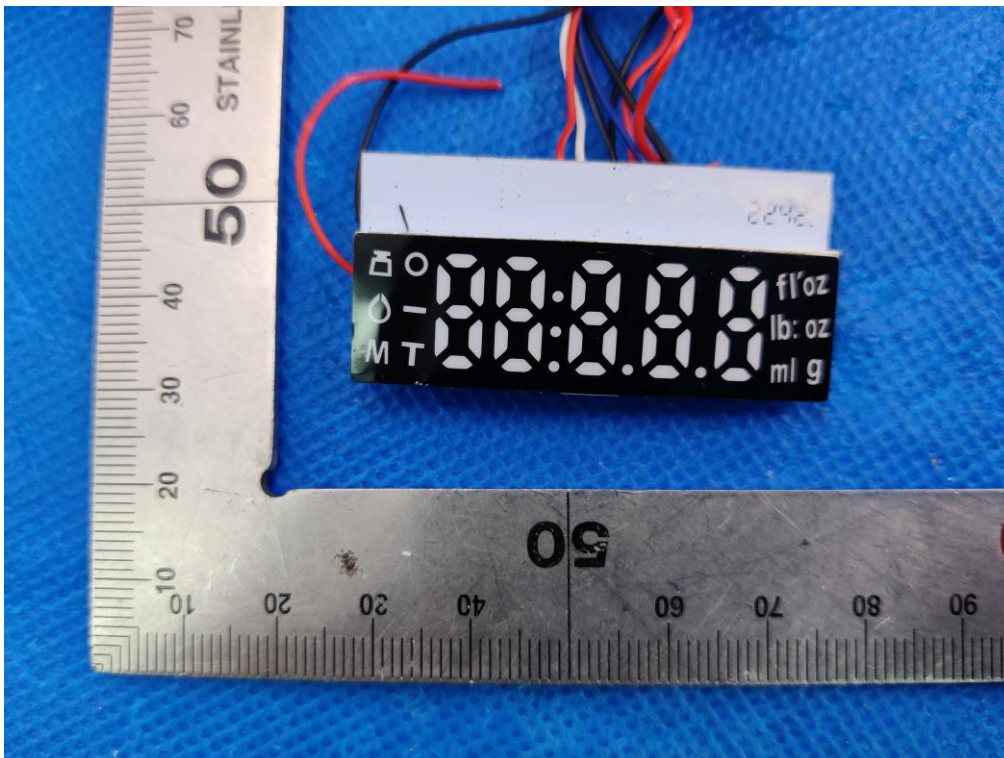

INTERNAL VIEW OF EUT (FIGURE 1)



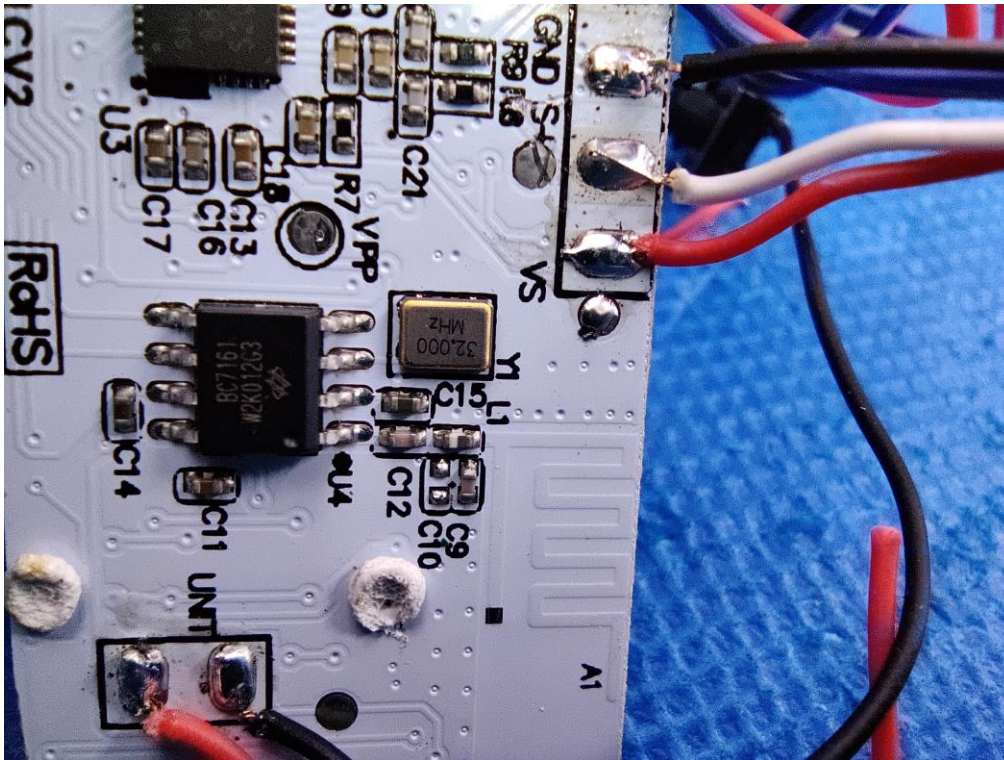
