Middle Channel:



Middle Channel:







Lowest Channel





1GHz to 5GHz



Compute the power by integrating the spectrum over 1MHz using the analyzer's band power measurement function with band limits set equal to the emission frequency($f_{emission}$)±0.5MHz.If the instrument does not have a band power function,the sum the amplitude levels(in power units) at 100kHz intervals extending across the 1MHz spectrum defined by femission±0.5MHz.





Lowest Channel


