



1.7 Test Procedure

All measurements contained in this report were performed mainly according to the techniques described in ANSI C63.4 (1992) and the pre-setup was written on <1.3>, the detail setup was written

on each test item.

1.8 Location of the Test Site

The radiated emissions measurements required by the rules were performed on the

three-meter, Anechoic Chamber (Registration Number: 93906) maintained by Training

Research Co., Ltd. 1F, No. 255 Nanyang Street, Shijr, Taipei Hsien 221, Taiwan, R.O.C. Complete

1.9 General Test Condition

The conditions under which the EUT operates were varied to determine their effect on the

equipment's emission characteristics. The final configuration of the test system and the mode of

operation used during these tests were chosen as that which produced the highest emission levels.

However, only those conditions, which the EUT was considered likely to encounter in normal use

were investigated.

In test, they were set in high power and continuously transmitting mode that controlled by

computer. The ch01, ch06 and ch11 of EUT were all tested. The setting up procedure is recorded on

<1.3> test method.

II. Section 15.101(a): Equipment authorization of unintentional radiators

The EUT equipped with a Universal Serial Bus and should be operated with the computer. It was categorized to *Class B personal computers and peripherals* as cannot be operated stand-alone. The authorization requires **Declaration of Conformity (DoC)** and the items required such as Sect.15.107 (Conducted limits) and Sect.15.109 (Radiated emission limits) is same as Sect.15.207 and 15.247(C).

III. Section 15.203: Antenna requirement

The EUT has an integral antenna inside the housing. In addition, there is no external antenna or external connector employed. The antenna requirement stated in Sect.15.203 is inapplicable to this EUT.

IV. Section 15.207: Power Line Conducted Emissions for AC Powered Units

4.1 Test Condition & Setup

The power line conducted emission measurements were performed in an anechoic chamber. The EUT was assembled on a wooden table, which is 80 centimeters high, was placed 40 centimeters from the backwall and at least 1 meter from the sidewall.

Power was fed to the EUT from the public utility power grid through a line filter and Line Impedance Stabilization Networks (LISNs). The LISN housing, measuring instrumentation case, ground plane, etc., were electrically bonded together at the same RF potential. The Spectrum analyzer (or EMI receiver) was connected to the AC line through an isolation transformer. The 50-ohm output of the LISN was connected to the spectrum analyzer directly. Conducted emission levels were in the CISPER quasi-peak detection mode. The analyzer's 6 dB bandwidth was set to 9 KHz. No post-detector video filter was used.

The spectrum was scanned from 150 KHz to 30 MHz. The physical arrangement of the test system and associated cabling was varied (within the scope of arrangements likely to be encountered in actual use) to determine the effect on the unit's emanations in amplitude and frequency. All spurious emission frequencies were observed. The highest emission amplitudes relative to the appropriate limit were measured and have been recorded in paragraph 2.4.

There is a test condition applies in this test item, the test procedure description as the following: EUT transmit only:

Using the LAN port of notebook computer and software to control the EUT. The setting up procedure is recorded on <1.3>. Three channels were tested, one in the top (CH01), one in the middle (CH06) and the other in bottom (CH11).

V. Section 15.247 (a): Technical description of the EUT

Based on the Section 2.1, *Direct Sequence System* is a spread spectrum system in which the carrier has been modulated by a high speed spreading code and an information data stream. The high speed code sequence dominates the "modulating function" and is the direct cause of the wide spreading of the transmitted signal. In the Exhibit, operational description demonstrates the operation principles of the Baseband processor employed by the EUT, shows that which is a complete DSSS baseband processor and meets the definition of the direct sequence spread spectrum system.



VI. Section 15.247(a)(2): Bandwidth for Direct Sequence System.

6.1 Test Condition & Setup

The transmitter bandwidth measurements were performed by the contact manner. The EUT was set to transmit continuously, also various channels were investigated to find the maximum occupied bandwidth.. The output of the EUT was connected to the spectrum analyzer. The bandwidth of the fundamental frequency is observed by the spectrum analyzer with 100kHz RBW and 100kHz VBW.




Bandwidth of Channel 11: 11.16 MHz

VIII. Section 15.247 (C): Spurious Emissions (Radiated)

8.1 Test Condition & Setup

We'd performed the test by the *radiated emission* skill: The EUT was placed in an anechoic chamber, and set the EUT transmitting continuously and scanned at 3-meter distance to determine its emission characteristics. The physical arrangement of the EUT was varied (within the scope of arrangements likely to be encountered in actual use) to determine the effect on the unit's emanations in amplitude, directivity, and frequency. The exact system configuration, which produced the highest emissions was noted so it could be reproduced later during the final tests. For the measurement above 1GHz, according to the guidance we'd set the spectrum analyzer's 6dB bandwidth RBW to 1MHz.

This was done to ensure that the final measurements would demonstrate the worst-case interference potential of the EUT. Final radiation measurements were made on a three-meter, anechoic chamber. The EUT system was placed on a nonconductive turntable, which is 0.8 meters height, top surface 1.0×1.5 meter.

The spectrum was examined from 30 MHz to 1000 MHz using an Hewlett Packard 85460A EMI Receiver, Schwarzeck whole range Small Biconical antenna (Model No.: BBVU9135) is used to measure frequency from 30 MHz to 1GHz. The final test is used the HP 85460A spectrum and 8564E spectrum was examined from 1GHz to 25GHz using an Hewlett Packard Spectrum Analyzer, EMCO/CMT Horn Antenna (Model 3115 / RA42-K-F-4B-C) for 1G - 25GHz. At each frequency, the EUT was rotated 360 degrees, and the antenna was raised and lowered from one to four meters to find the maximum emission levels. Measurements were taken using both horizontal and vertical antenna polarization.

Appropriate preamplifiers were used for improving sensitivity and precautions were taken to avoid overloading or desensitizing the spectrum analyzer. There are two spectrum analyzers use on this testing, HP 85460A for frequency 30MHz to 1000MHz, and 8564E for frequency 1GHz to 18GHz. No post-detector video filters were used in the test. 
