### 2. SYSTEM TEST CONFIGURATION

### 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.



### 4. DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition.

Test program used to control the EUT for staying in continuous transmitting mode is programmed. Channel Low, Mid and High with highest rated data rate were chosen for full testing.

The field strength of spurious radiation emission was measured as EUT stand-up position (H mode) and lie down position (E1, E2 mode) for Bluetooth Transmitter for channel Low, Mid and High the worst case E2position was reported and EDR mode and DH5 data rate will be worst case. *Note:* 

The RF module, antenna types and antenna locations are all the same in every series model.

The difference for 1D or 2D scanner did not affect the RF performance, because it is far from the WLAN and WWAN antenna.





# 13. Peak Power Spectral Density

# 13.1. Standard Applicable







# 14. ANTENNA REQUIREMENT

# 14.1. Standard Applicable

For intentional device, according to §15.203, an intentional radiator shall be designed to ensure that no antenna other than furnished by the responsible party shall be used with the device.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

#### 14.2. Antenna Connected Construction

The directional gains of antenna used for transmitting is -4.0dBi, and the antenna connector is designed with permanent attachment and no consideration of replacement. Please see EUT photo for details.
