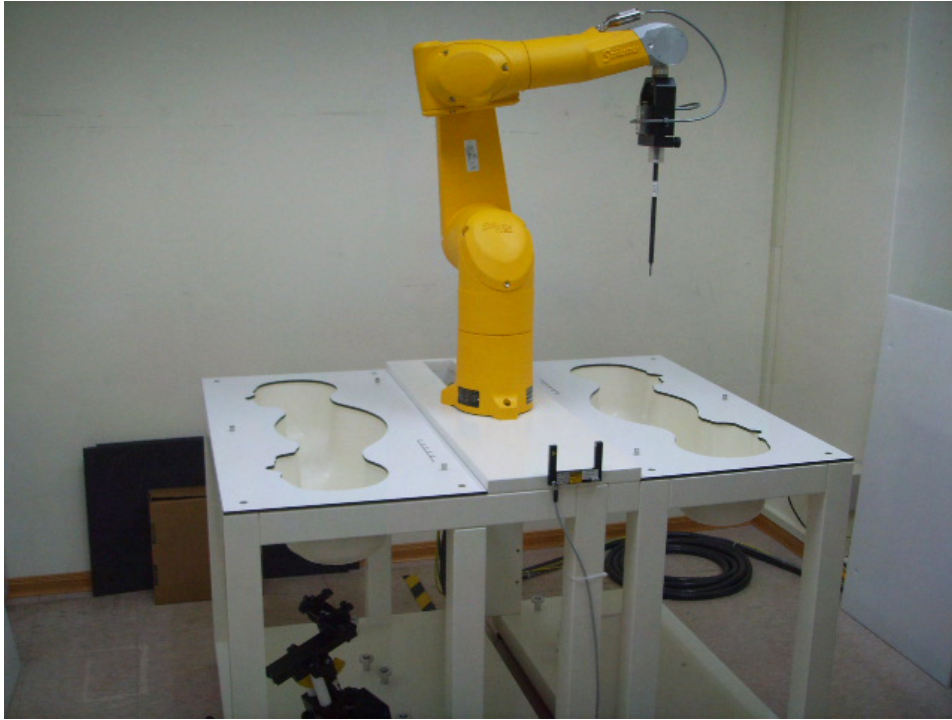
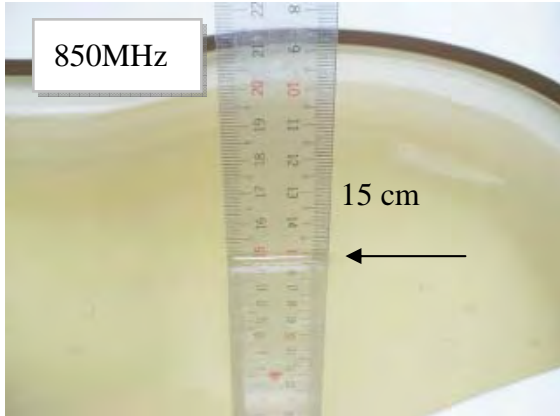


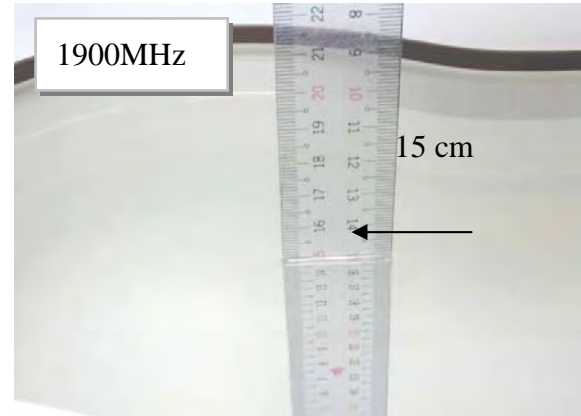
Fig.1 Photograph of the SAR measurement System

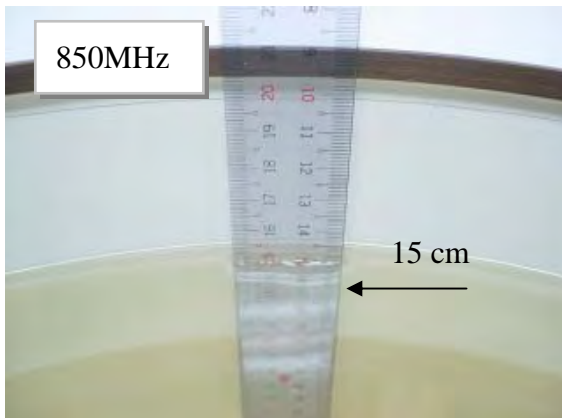

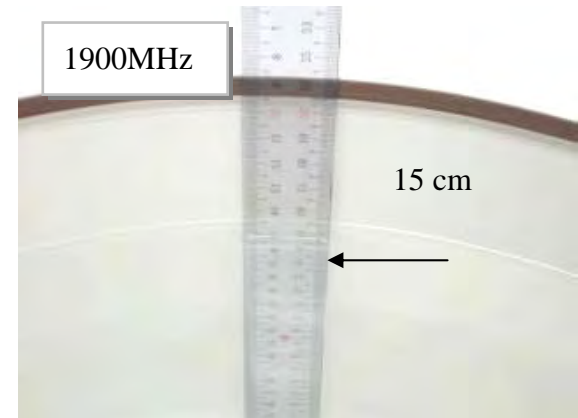
**Fig.2.1 Left-head Side**



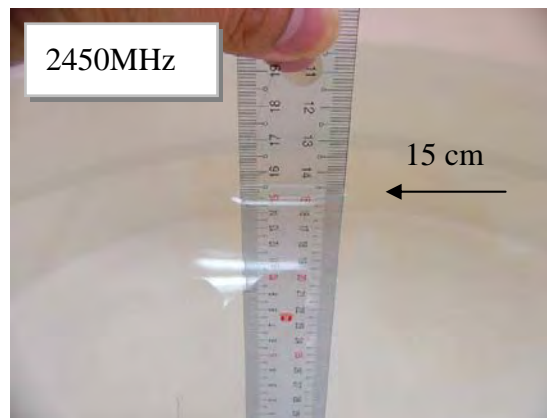
**Fig.2.2 Right-head Side**

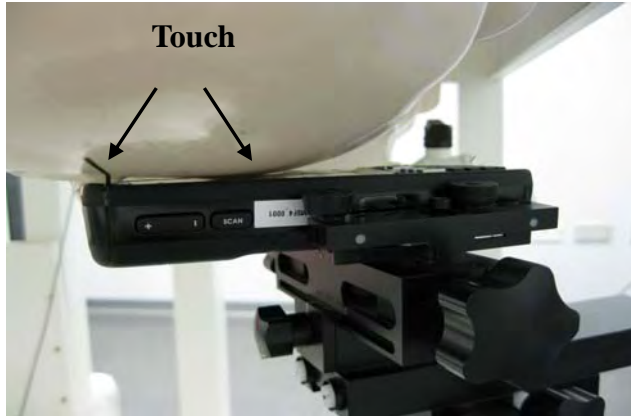


Fig.3 Right Head Section / Cheek-Touch Position

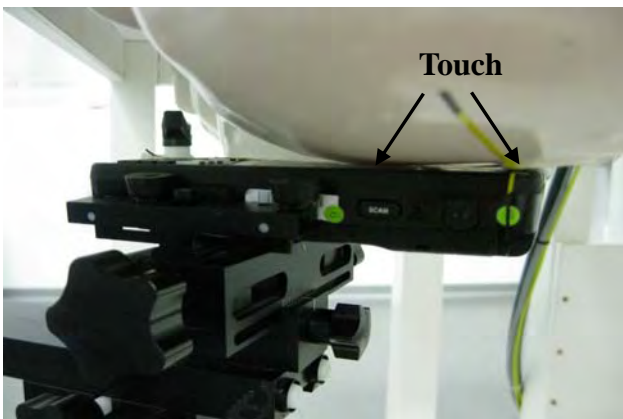


Fig.5 Left Head Section / Cheek-Touch Position

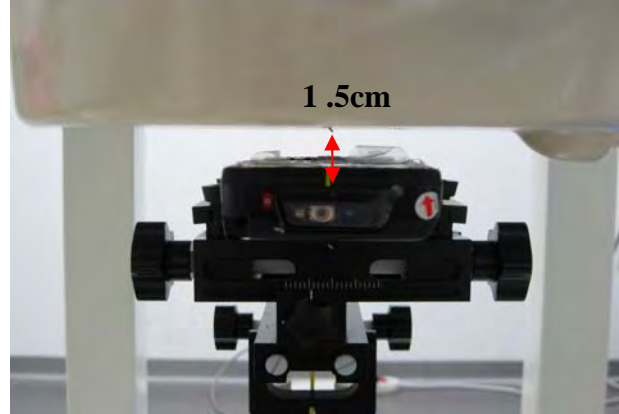

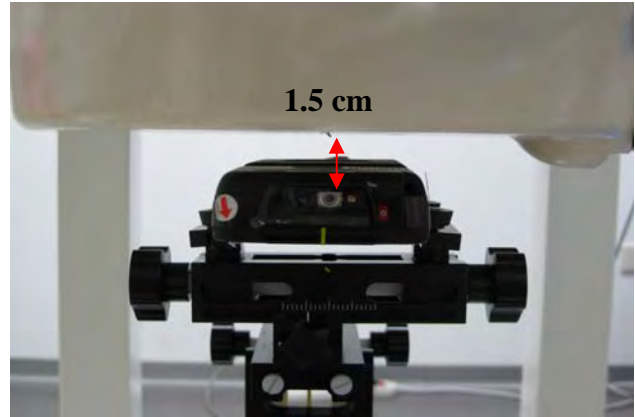
Fig.6 Left Head Section / Ear-Tilt Position(15°)
